## CONSTITUTION OF THE FOOTHILLS ASSOCIATION

## ARTICLE I. NAME PURPOSE AFFILIATION

This Association shall be called, The Foothills Association of (Original) Free Will Baptists of North Carolina. The purpose of this body is to proclaim and preach the gospel of our Lord and Savior Jesus Christ, that by his grace, we may advance his kingdom among men. We are affiliated with the North Carolina State Association of Free Will Baptists, and the National Association. The treatise of the National Association is adopted as an expression of our faith and practices.

ARTICLE 2. MEMBERSHIP

The members of this body shall consist of churches and ministers of like faith and practices. Members may be received by letter from other Free Will Baptist Associations or by letter of petition. Members coming to us from other denominations must be examined by our Executive Board and recommended by them for memship in this body. All members must report by letter to the annual meeting, and must be represented by delegates at our Quarterly and annual meetings. All members must be received by a majority vote of the body in session. The association may by a majority vote withdraw from any member found to be walking disorderly contrary to sound doctrine as believed by us.

ARTICLE 3. OFFICERS

The officers of this association are as follows, Moderator, Assistant Moderator, Clerk, Treasurer, Executive Board and any other officers that we may elect to transact the business of this body. The association may elect or appoint as many boards or committees as may be necessary. The duties of the officers shall be explained in an appendage to this constitution.

ARTICLE 4. INDEPENDANCE OF THE LOCAL CHURCH

This association recognize the independance of the local church and their right to administer their internal affairs. They have the right to discipline their members according to the Word of God, and such discipline ought to be binding on all of our churches. No member should be received into any of our churches who is out of fellowship with another. This body assumes no higher authority over the local church than that of an advisory capacity, and has no claims over local church proerty except that which may be acquired by legal title.

#### ARTICLE 5. LICENSING AND ORDAINING MINISTERS

This work shall be primarily the responsibility of the local church. After a church has licensed a man to preach and he is called to pastor a church or if his home church considers him eligible, the church may call a presbytery of at least(3) three pastors of the Association to lay hands on him and ordain him according to the Word of God. He must be of sound moral character and doctrine and meet all scriptural qualifications in order to be ordained. If he shall fail to live up to these qualifications, his home church or the church that had him ordained may vote to withdraw ordination from him and he is under solomn obligation to deliver his ordination certificate to the church. No man shall be considered for license or ordination who has been married twice if his first wife is living. No woman shall be considered for license or ordination. No ordination shall be recognized as valid that is not done according to the Word of God. (The Holy Bible) ARTICLE 6.

DISCIPLINE OF MINISTERS

In order to maintain and encourage sound doctrine and moral character, this body recognizes it's responsibility to discipline it's members according to the Word of God. Any charges made against a church or a minister must be presented in writing to the accused at least two weeks before a hearing is held on the matter. The charges must be signed by at least two reliable witnesses. A copy of these charges must be presented to the Executive Board of the Association who shall investigate them and bring the proper recommendations to the body in session. The association may vote to suspend or to withdraw fellowship from any member found to be disorderly by a majority vote.

ARTICLE 7. MEETINGS OF THE ASSOCIATION

The Association shall meet quarterly and annually for worship and business. The quarterly meetings shall be held on the second Saturdays in February, August, and November. The annual meetings shall be held on the second Saturday in May, or if a two day meeting be desired the meeting shall begin on the first Friday, before the second Saturday in May. All Deacons and Ministers shall be counted as standing delegates and visitors may be granted all the privileges of the body except that of voting. FINANCIAL SUPPORT ARTICLE 8.

Each church is requested to send at least I% of their income for the support of the association, and each minister is requésted to bring a one dollar offering to each meeting. Offerings may be received at the discretion of the moderator.

## ARTICLE 9. AMENDMENTS

This constitution may be amended or suspended by a two thirds majority vote at any annual session, providing a quorum of at least nine members is present. The motion to amend must be made at the first session of the annual and must lay on the table until the final session.

### APPENDAGE. DUTIES OF OFFICERS

- I. MODERATOR. The moderator shall have the general oversight of the association and shall preside at all business sessions. He shall see that the chair is filled at all times and that proper order is maintained. He shall have the same speaking rights as other members providing the chair is filled. In case of a tie vote, he shall be empowered to break the tie. He shall serve as chairman of the executive board. In his absence or at his request the assistant may assume his duties.
- 2. CLERK. The clerk shall take the minutes of all business meetings of the body and shall keep a permanent record of them. The clerk shall be responsible for having the minutes printed and shall serve as corresponding secretary of the association. In the absence of the clerk or at the clerk's request the assistant clerk may assume these duties.
- 3. TREASURER. The treasurer shall receive and disburse all money of the association at the direction of the body. He shall keep an accurate and permanent financial record, and shall give a financial report to the association at least once a year or upon request. In the absence of the treasurer, the assistant may assume these duties.
- 4. THE EXECUTIVE BOARD. This board shall consist of seven members, The moderator, assistant moderator, clerk, and treasurer, shall be members of the board by virtue of their office, with three additional members being elected by the body. The board shall have interim authority to act for the association between sessions. They shall report their work annually to the association and their work shall be final upon the approval of the body in session. A quorum of at least four members must be present in order for the board to conduct business.
- 5. BOARD OF TRUSTEES. This board shall consist of three members who shall hold title to all property acquired by the association, and shall represent the body in all matters needing trustees. They shall perform their duties at the direction of the body.

- 6. <u>HISTORIAN</u>. The historian shall keep records of all historical events of the association. The assistant shall assist the historian in these duties.
- 7. ELECTION OF OFFICERS. All officers of the association shall be elected for one year except the historian and board of trustees. These shall be elected for an indefinite period. A nominating committee shall be elected at the last session of the annual meeting. They shall present nominations to the body the following year for all associational offices. When they give their report, the moderator shall call for nominations from the floor.
- 8. ASSOCIATIONAL RECORDS AND PROPERTY. All finances, records, or property held by any officer of the association shall be turned over promptly to his successor in officer upon completion of his term in office.

BY-LAWS AND RULES OF DECORUM

- I. All meetings shall be opened with scripture reading, prayer, and worship.
- 2. The clerk, assistant clerk, or the senior minister in years shall call the meeting to order and shall preside until the moderator assumes his place.
- 3. Any member wishing to speak must first stand and be recognized by the moderator before speaking. He must confine himself to the subject before the body and shall not speak more than twice nor more than ten minutes without special permission from the body. No person shall interrupt another who is speaking except in cases of emergency or in accord with accepted parliamentary procedure. Frivolous motions or filibustering shall not be tolerated by this body.
- 4. Christian love must be the rule in every session. No title except Brother or Sister shall be used when addressing another There shall be no conversation between members that will interrupt business while the body is in session.
- 5. No member shall absent himself from the body without the permission of the moderator. Anyone violating this rule may be adomonished by the moderator. If the violation continues, it may result in loss of voting privileges for that session at the discretion of the moderator. The moderator's decision shall be final unless overruled by a majority vote of the body. Any member may appeal the moderator's decision to the body.
  - 6.Roberts Rules of order shall be used as a guide in our deliberations, and shall be the final authority as it applies to religious bodies such as ours.
  - 7. These rules may be amended or suspended at any regular business session by a simple majority vote, providing that a quorum of at least nine members is present.

PRE-ORGANIZATIONAL MEETING HELD AT ROCKY PASS FREE WILL BAPTIST CHURCH, FELLOWSHIP BUILDING, February, 25, 1977.

The meeting was opened with scripture reading and prayer. A discussion was held concerning a proposal that had been before the Blue Ridge Association concerning the churches east of Old Fort Mountain having their own quarterly meetings with the churches wast of the mountain doing the same. The churches would then meet together annually. After discussing the matter it was decided that it would be best for all concerned for us to form a new association east of the mountain. The pastors agreed to take this idea and present it to their churches and if approved, to set a time and place for an organizational meeting. All churches represented at this meeting were members of the Blue Ridge Association except the West Fifth Ave. Church of Gastonia. The pastor of this church, Rev. Billy Allen was a member of the Blue Ridge Association.

It was agreed that we have no bitterness toward the Blue Ridge Association, and that if we did leave the Association that we would do so by letter in good standing. It was further agreed that we would not entice any pastor or church to leave the Blue Ridge to unite with us. The stated purpose for the organization of the new association was to encourage greater participation of our churches in the association, that both associations might grow and prosper more in the Lord.

This was a blessed meeting and a sweet spirit prevailed. We joined hands in a closing prayer asking the Lord's blessings and guidance The Lord wonderfully blessed and we left the meeting rejoicing in the Lord.

ORGANIZATIONAL MEETING OF THE FOOTHILLS ASSOCIATION, HELD AT BETHEL CHURCH, MARION, N.C.

April, 2, 1977

The meeting opened with scripture reading, prayer, and congregational singing. The meeting was well attended with about two hundred people present. The pastor, Rev. R.J. Reynolds called the meeting to order and explained the purpose of this meeting. Bro. Reynolds was elected temporary moderator and Bro. Carl Roland was elected as temporary clerk, the proposal of organizing a new association was presented to the body by the moderator and the following motions were made and carried.

M.S.C. That we organize a new association.

M.S.C. That the name of this association shall be, The Foothills Association of (Original) Free Will Baptists of North Carolina.

M.S.C. That the ministers and churches wishing to unite with the new association unite by letter from their respective associations. The following churches being represented by delegates and pastors united by letter, Bethel, Mt. Calvary, Trinity Hill, Rocky Pass, Robertson Creek, Old Fort, Salem, and West Fifth Ave.

M.S.C. That we adopt the treatise of the National Association, and that we petition the North Carolina State Association for membership in that body.

The following were elected as a committee to prepare a constitution for our consideration at the next meeting, Billy Allen, A.C. Truluck, Carl Roland, Lattie Slagle, and Joe Helms. The following officers were elected for the year, Rev. R.J. Reynolds, Moderator, Rev. Billy Allen, Assistant Moderator, Bro. J.E. Suttles, Clerk, Bro. Dennis Ward, Treasurer, Rev. A.C. Truluck, Youth Camp Director, Rev. Wade Parker, Youth Director, Sis. Blanch Jones, Historian, and Sis. Francis Truluck, Women's Auxiliary Coordinator. M.S.C. That our next meeting be held at Trinity Hill church, Nebo, N.C. M.S.C. To adjourn. Adjourned with prayer. This was a great meeting and the Lord wonderfully blessed his people.

Clerk's note: The meeting held at Trinity Hill Church is known as our first annual meeting.

# FIRST ANNUAL MEETING TRINITY HILL CHURCH June, 25, 1977.

The meeting opened with devotions led by Rev. Haskel Davis, and congregational singing led by Rev. Carl Roland. The meeting was called to order by the clerk.

The moderator informed the body that each session would begin with devotions and a worship service before business. The host pastor welcomed us to the church. The following churches were represented, Bethel, Mt. Calvary, Trinty Hill, Salem, Rocky Pass, Friendly, Robertson Greek, and West Fifth Ave. Representatives from the following churches were recognized as visitors, Mt. Bethel, Spruce Pines, and Ray's Chapel. Rev. Billy Allen brought the morning message entitled, "The Little Book With Seven Seals," preaching from Revelation: 5. The Lord richly blessed in this service through His Word. The body recessed for lunch with prayer, and a great meal prepared by the host church was enjoyed by all.

Rev. Gorman Burgin petitioned for membership in this body.
M.S.C. That he be received pending a letter from the Blue Ridge Association. M.S.C. That our next meeting be held at the Robertson Creek Church, Bostic, N.C.
M.S.C. To adjourn. Adjourned with prayer.
