### DUTIES OF BOARDS AND COMMITTEES

# FOREIGN MISSIONS

This committee shall have the oversight of anything that pertains to foreign missons. They shal report annually to the Association and present recommendations of ways in which the body can better support foreign missons.

### HCME MISSIONS

This committee shall have the oversight of anything that pertains to home missions. They shall report annually to the Association and present recommendations of ways to better support and promote home missions

### FROMOTIONAL COMMITTEE

This committee shall be responsible for promoting the work of the association among local churches. They shall encourage the churches to support the association with it's presence and finances. They shall report their work to the association annually

### YCUTH COMMITTEE

This committee shall have the oversight of our youth. They shall explore plans to get our youth involved in the work of the association. They shall make plans for special activities and work for our youth They shall be responsible for planning youth services , and report annually to the association of the accomplishments of said committee.

### NOMINATING COMMITTEE

This committee shall be responsible for presenting all nominees for offices in the association. They shall be responsible in contacting nominees in advance of their presentation before the body at the annual session. The body shall retain the right to nominate from the floor when the committee gives it's reports duties of boards and committees cont.

### FINANCE COMMITTEE

This committee shall have the oversight of the finances of the association. They may prepare a buget for the Association to consider and make recommendations to the body concerning the distribution of finances belonging to the body: and their work shall be reported to the annual session of the Association.

### EXECUTIVE COMMITTEE

### CONSTITUTION OF THE FOOTHILLS ASSOCIATION

### ARTICLE I. NAME PURPOSE AFFILIATION

This Association shall be called. The Foothills Association of (Original) Free Will Baptists of North Carolina. The purpose of this body is to proclaim and preach the gospel of our Lord and Savior Jesus Christ, that by his grace, we may advance his kingdom among men. We are affiliated with the North Carolina State Association of Free Will Baptists, and the National Association. The treatise of the National Association is adopted as an expression of our faith and practices. ARTICLE 2. <u>MEMBERSHIP</u>

The members of this body shall consist of churches and ministers of like faith and practices. Members may be received by letter from other Free Will Baptist Associations or by letter of petition. Members coming to us from other denominations must be examined by our Executive Board and recommended by them for memship in this body. All members must report by letter to the annual meeting, and must be represented by delegates at our Quarterly and annual meetings. All members must be received by a majority vote of the body in session. The association may by a majority vote withdraw from any member found to be walking disorderly contrary to sound doctrine as believed by us. ARTICLE 3. OFFICERS

The officers of this association are as follows, Moderator, Assistant Moderator, Clerk, Treasurer, Executive Board and any other officers that we may elect to transact the business of this body. The association may elect or appoint as many boards or committees as may be necessary. The duties of the officers small be explained in an appendage to this constitution. ARTICLE 4. INDEPENDANCE OF THE LOCAL CHURCH

This association recognize the independence of the local church and their right to administer their internal affairs. They have the right to discipline their members according to the Word of God, and such discipline ought to be binding on all of our churches. No member should be received into any of our churches who is out of fellowship with another. This body assumes no higher authority over the local church than that of an advisory capacity, and has no claims over local church proerty except that which may be acquired by legal title.

### ARTICLE 5. LICENSING AND ORDAINING MINISTERS

This work shall be primarily the responsibility of the local church. After a church has licensed a man to preach and he is called to pastor a church or if his home church considers him eligible, the church may call a presbetery of at least( $\tau$ ) three pastors of the Association to lay hands on him and ordain him according to the Word of God. He must be of sound moral character and doctrine and meet all scriptural qualifications in order to be ordeined. If he shall fail to live up to these qualifications, his home church or the church that had him ordained may vote to withdraw ordination from him and he is under soloan obligation to deliver his ordination certificate to the church. No man shall be considered for license or ordination who has been married twice if his first wife is living. No woman shall be considered for license or ordination. No ordination shall be recognized as valid that is not done according to the Word of God. (The Holy Bible) ARTICLE 6. DISCIPLINE OF MINISTERS

In order to maintain and encourage sound doctrine and moral character, this body recognizes it's responsibility to discipline it's members according to the Word of God. Any charges made against a church or a minister must be presented in writing to the accused at least two weeks before a hearing is held on the matter. The charges must be signed by at least two reliable witnesses. A copy of these charges must be presented to the Executive Board of the Association who shall investigate them and bring the proper recommendations to the body in session. The association may vote to suspend or to withdraw fellowship from any member found to be disorderly by a majority vote. ARTICLE 7. <u>MESTINGS OF THE ASSOCIATION</u>

The Association shall meet quarterly and annually for worship and business. The quarterly meetings shall be held on the second Saturdays in February, August, and November. The annual meetings shall be held on the second Saturday in May, or if a two day meeting be desired the meeting shall begin on the first Friday, before the second Saturday in May. All Deacons and Ministers shall be counted as standing delegates and visitors may be granted all the privileges of the body except that of voting. ARTICLE 8. FINANCIAL SUPPORT

Each church is requested to send at least 1% of their income for the support of the association, and each minister is requested to bring a one dollar offering to each meeting. Offerings may be received at the discretion of the moderator.

### ARTICLE 9. AMENDMENTS

This constitution may be amended or suspended by a two thirds majority vote at any annual session, providing a quorum of at least nine members is present. The motion to amend must be made at the first session of the annual and must lay on the table until the final session.

# APPENDAGE. DUTIES OF OFFICERS

- I. <u>MODERATOR</u>. The moderator shall have the general oversight of the association and shall preside at all business sessions. He shall see that the chair is filled at all times and that proper order is maintained. He shall have the same speaking rights as other members providing the chair is filled. In case of a tie vote, he shall be empowered to break the tie. He shall serve as chairman of the executive board. In his absence or at his request the assistant may assume his duties.
- 2. CLERK. The clerk shall take the minutes of all business meetings of the body and shall keep a permanent record of them. The clerk shall be responsible for having the minutes printed and shall serve as corresponding secretary of the association. In the absence of the clerk or at the clerk's request the assistant clerk may assume these duties.

3. <u>TREASURER</u>. The treasurer shall receive and disburse all money of the association at the direction of the body. He shall keep an accurate and permanent financial record, and shall give a financial report to the association at least once a year or upon request. In the absence of the treasurer, the assistant may assume these duties.

4. THE EXECUTIVE BOARD. This board shall consist of seven members, The moderator, assistant moderator, clerk, and treasurer, shall be members of the board by virtue of their office, with three additional members being elected by the body. The board shall have interim authority to act for the assoclation between sessions. They shall report their work annuaapproval of the body in session. A quorum of at least four members must be present in order for the board to conduct

5. <u>BOARD OF TRUSTERS</u>. This board shall consist of three measures who shall hold title to all property acquired by the association, and shall represent the body in all matters needing trustees They shall perform their duties at the direction of the body.

- 6. <u>HISTORIAN</u>. The historian shall keep records of all historical events of the association. The assistant shall assist the historian in these duties.
- 7. <u>KLECTION OF OFFICERS</u>. All officers of the association shall be elected for one year except the historian and board of trustees. These shall be elected for an indefinite period. A nominating committee shall be elected at the last session of the annual meeting. They shall present nominations to the body the following year for all associational offices. When they give their report, the moderator shall call for nominations from the floor.
- ASSOCIATIONAL RECORDS AND PROPERTY. All finances, records, or property held by any officer of the association shall be turned over promptly to his successor in officer upon completion of his term in office.

#### BY-LAWS AND RULES OF DECORUM

- I. All meetings shall be opened with scripture reading, prayer, and worship.
- 2. The clerk, assistant clerk, or the senior minister in years shall call the meeting to order and shall preside until the moderator assumes his place.
- 3. Any member wishing to speak must first stand and be recognized by the moderator before speaking. He must confine himself to the subject before the body and shall not speak more than twice nor more than ten minutes without special permission from the body. No person shall interrupt another who is speaking except in cases of emergency or in accord with accepted parliamentary procedure. Frivolous motions or filibustering shall not be tolerated by this body.
- 4. Christian love must be the rule in every session. No title except Brother or Sister shall be used when addressing another There shall be no conversation between members that will interrupt business while the body is in session.
- 5. No member shall absent himself from the body without the permission of the moderator. Anyone violating this rule may be adomonished by the moderator. If the violation continues, it may result in loss of voting privileges for that session at the discretion of the moderator. The moderator's decision shall be final unless overruled by a majority vote of the body. Any member may appeal the moderator's decision to the body.
- 6.Roberts Rules of order shall be used as a guide in our deliberations, and shall be the final authority as it applies to religious bodies such as ours.
- 7. These rules may be amended or suspended at any regular business session by a simple majority vote, providing that a quorum of at least nine members is present.

Open in Session: Devotion and Frayer By Rev. Randy Richardson of Dallas N.C. and welcome to the Association. Response by Rev. Larry Collins, Moderators Remarks. Rev. John Cody He encouraged all pastors to promote a greater attendence to our meetings, He also encouraged our churches to invite the district womens auxiluary to meet at their church Congregational singing led by Rev. Carl Roland. Special singing included a trio from Trinity Hill F.W.B. The message by Rev. Tom Rogers the host pastor.

### Business Session

Motion to give Rev. Lester Hughes a love offering of \$250.00 due to his being out of work from an accident for some length of time. M.S.C. to give the Offering: Rcll call of churches and ministers by clerk, Treasury Report given M.S.C. to adopt as information. Visitors recognized and welcomed with a voice in the proceedings except for voting: Home Missions Report M.S.C. to adopt as information. Motion to place \$300.00 from our Treasury into a fund for the Home Mission Board of the Foothills Association for purpose of establsishing new churches M.S.C. by the body.. Report of the F.W.B. Rest Home by Rev. J.C. Lynn M.S.C. to adopt as information.. Motion Made that all our preachers and churches take the lead in opposing all forms of pornography, abortion, secular humanism, vain language, and evil progams on television. M.S.C. Motion made that the moderator appoing a committee to look for some land that we might purchase to be used for having camp meetings and other meetings for the association M.S.C. as approved of by the association: the committee appointed as follows: Rev. Harold Holcombe. Rev. Kenneth Breedlove, Rev. Randy Richardson. Motion Made: that a work day be set up by the Home Mission Department of our association and encourage all christain men of our association to meet at a selected church for purpose of visiting in the area to promote attendence for

the particular church in that area: M.S.C. to have the Home Mission Board set up the meetings. Motion made to declare Article 9 of our constitution out of order since it would be impossible to abide by it as it is now written: M.S.C. 100% Motion that Article 5 be suspended in that some churches will not ordain a minister unless he is called to pastor a church: The association voted to suspend Article 5 in the case of Rev. Richard Ball who has been a faithful supporter of the Association over the past 4 years and motion to ordain Rev. Ball after examination by the executive board on 2nd Sat. in Cctober at the Salem F.W.B. church in Old Fort N.C. (retrospect) Rev. Ball attended the association as the representive from Mt.Bethel F.W.B. in Weaverville N.C. and was ordained after joining the Salem F.W.B. church in Cctober 1985 (Suspended Article 5 for this occasion was not necessary since Rev. Ball moved his membership to Salem F.W.B.) (The association voted in session for article 5 to be re-instated after the Ordination) The association voted to meet at W.5th Avenue F.W.B. for the November Session 1985:

The Host Church W.5th Avenue Welcomed the Association with Rev. Billy Allen leading the Congregation in song Welcome by Rev. Allen and Response given by Rev. Ray Surmey, Devotion and Prayer by Rev. Larry Heffner. Sowing the Seed" Moderators Remarks Rev. John Cody asked for suggestions from churches for growth in the local churches to be shared among each other in hopes we would all increase attendence. Roll Call of Churches was made by the clerk, Visithing churches recognized: Rcll call of Ministers with visiting ministers recognized Visitors were made welcome and were given the privilege of the body except that of voting. Congregational and special singing led by Rev. Allen with a testimony and great time of praise to the Lord enjlyed by all: Rev. Haskel Davis brought the message God's Medecine Cabinet..Rev. J.C. Lynn gave a report on the N.C. State Rest Home Work Offering received and designated to Our Foothills Association Home Mission Board.

Treasury Report given by Brother Dennis Ward M.S.C. to receive the report, Motion was made to give \$200.00 To the Rest Home and National Home Mission Department \$300.00 M.S.C. to give offerings.

Rev. Kenneth Breedlove gave a Home Mission Report M.S.C. to Receive the report. Rev. Robert Harris gave report from the promotional committee: M.S.C. to receive report. Rev. Leroy England gave a report from the committee appointed to study proposed changes in the manner of election of diffrent boards to rotation on a 3 year election basis: M.S.C. to change our present system to the rotation system, begining in May 1986 which is our annual meeting. One man will be replaced with one going off each year: After Ist year. The boards affected are Home Mission, Foreign Mission, Promotional, Finance, Youth. The Gospel Temple F.W.B. of Forest City N.C. petitored the Association for membership by letter from the church. 
## MAY 1986 Meeting In Session At. Salem F.W.B. Old Fort N.C.
