#### PREFACE

The General Conference is the "mother conference" of North Carolina Free Will Baptists. From the best sources available to us it seems to have been organized around 1748. It divided in 1886 to form two conferences. The minutes of that year read partly as follows on page 6:

"On motion, it was decided that this conference be divided into two conferences, viz; one to be called the First and the other to be called the Second conference; and was further decided that six ministers be appointed to make the line between them. The following ministers were appointed as the committee, viz: Elders R.K. Hearn, D. Davis, M. Linton, John Harrison, P.T. Lucas, and R.H. Holland.

The committee, after due deliberation, reported as follows: The Wilmington & Weldon Railroad be the dividing line, and that any church on either side have the right to be represented in either conference, and that no changes shall be made in our Book of Discipline without the concurrence of three-fourths of both Conferences."

The minutes of the "Annual Conference" for 1887 read in part as follows on pages 2 and 3:

"On motion of Elder R.K. Hearn, that the entire delegation of the Western conference are invited to take seats with us.

On motion of D. Davis, that the names of the ministers and churches that belong to the Western conference be dismissed from our minutes."

The "Annual Conference" minutes for 1891 had the following heading and motion on page 3:

"Proceedings of the Eastern Conference.

"On motion, the delegates of the Western Conference and of the SouthCarolina Conference be invited to seats in this body."

So we conclude that the two conferencesorganized were the Western and Eastern Conferences.

The General Conference divided at Black Jack Church, Pitt County, North Carolina, on Saturday, November 13, 1886 and was revived at Prospect Church, Harnett County, North Carolina, November 20 1961. Consequently this session is designated the "One Hundred-Fortieth Annual Session."

#### THE PREPARATORY MEETING AT GREENVILLE, NORTH CAROLINA

November 10, 1961

Forty-five ministers and visitors met at 10:00 A.M. on November 10, 1961 in Greenville, North Carolina at Respess's Bar-B-Que to discuss and seek a solution to the current problems facing the work of Free Will Baptists in Eastern North Carolina in particular.

Rev. Bobby Jackson presided. Bro. Gene Waddell preached on "Who Are The Original Free Will Baptists". The Scriptural text was Proverbs 29:2.

A decision was made to organize a conference on November 20, 1961 at Prospect Church, Dunn, North Carolina.

### MINUTES OF THE 1961 SESSION OF THE REVIVED GENERAL CONFERENCE OF ORIGINAL FREE WILL BAPTISTS OF NORTH CAROLINA

#### PROCEEDINGS

Ministers, delegates and visitors gathered at Prospect Free Will Baptist Church in Harnett County on November 20, 1961, for the purpose of organizing an Original Free Will Baptist Conference committed to our historic practice of congregational church government. The host pastor, Rev. Carey Watkins, called the meeting to order at 10:00 A.M. and acted as temporary chairman. Rev. Bobby Jackson led the congregation in singing "Faith of our Fathers" and Rev. Rashie Kennedy led the prayer.

Brother Watkins welcomed the group to Prospect Church and stated the purposes of the meeting. Rev. Eugene Waddell brought the message on the subject, "Who are the Original Free Will Baptists?" We sang "Amazing Grace."

The ministers and delegates from the Western Conference were called into a short session.

#### MINUTES OF THE TRUE ORIGINAL FREE WILL BAPTISTS OF THE WESTERN CONFERENCE

Correspondence was comunicated from Dan Merkh and G.C. Lee requesting membership in the proposed conference. On motion their names were added to the list of Western Conference Ministers present.

The following resolution was presented and on motion was unanimously adopted:

Whereas, the Western Conference of Original Free Will Baptists has declared its present form of church government to be connectional and

Whereas, the chief clause in the STATEMENT OF FAITH AND DISCIPLINE FOR ORIGINAL FREE WILL BAPTISTS OF NORTH CAROLINA – "the annual conference or association being the highest tribunal, shall have final disciplinary authority over the local church." – supporting this erroneous practice was taken from the Holiness corrupted Cape Fear Conference Discipline of 1899, which was repudiated by the Original Cape Fear Free Will Baptist Conference; and

Whereas, the ministerial credentials of one of our pastors were revoked for reasons other than those specified on the certificate, namely immoral character and unsound doctrine, and through the improper procedure of refusing to give the accused specific or authenticated charges and the names of his accusers; and

Whereas, the unprecedented interference of the Western Conference of Original Free Will Baptists in the internal affairs of one of our sister churches, Edgemont Chruch, by becoming a plaintiff in court proceedings designed to seize control of the property and award it to a small minority, constitutes a serious departure from the historic practices, customs and usages of our denomination; and

Whereas, the Western Conference of Original Free Will Baptists has taken action which in effect laid the groundwork for said conference to become a part of a new denomination; therefore,

Be it resolved that we, the adherents to the historic doctrines, church government, customs. practices, and usages of Original Free Will Baptists, assembled this 20 th day of November, 1961, do hereby delcare ourselves to be the true Original Free Will Baptists of the Western Conference of Original Free Will Baptists; and

Be it further resolved that we repudiate the following statement found on Page 53 of the STATEMENT OF FAITH AND DISCIPLINE FOR ORIGINAL FREE WILL BAPTISTS OF NORTH CAROLINA --"the annual conference or association being the highest tribunal, shall have final disciplinary authority over the local church", and

Be it further resolved that we unite with the churches and ministers who are true Original Free Will Baptists from the bounds or the Eastern Conference, Albemarle Conference, Cape Fear Conference and Central Conference; and

Be it further resolved that we declare that all those churches and ministers in company with us, adhering to the doctrines, customs, practices and usages of the true Original Free Will Baptists are in good standing; and

Be it further resolved that we declare our determination to maintain our affiliation with our denomination, namely the National Association of Original Free Will Baptists.

On motion the session of the true Original Free Will Baptists of the Western Conference was adjourned.

#### MINUTES OF THE TRUE ORIGINAL FREE WILL BAPTISTS OF THE CENTRAL CONFERENCE

The following resolution was presented and unanimously adopted:

Whereas, the Central Conference or Original Free Will Baptists in session November 8, 9, 1961, in Greenville, N.C. by unprecedented action of refusing to seat certain ministers for reasons not specified in the constitution of the Central Conference has departed from the democratic practices, customs, and usages of Original Free Will Baptists; and

Whereas, the Central Conference of Original Free Will Baptists in the same session endorsed the action of the Western Conference of Original Free Will Baptists in its unprecedented interference in the internal affairs of a local church whereby it becomes the plaintiff in court proceedings to seize control of the property and award it to a small minority; and

Whereas, the said conference adopted a resolution supporting the action and affirming the position of a group of men who signed an affidavit stating their belief in a connectional form of church government; and

Whereas, the chief clause in the STATEMENT OF FAITH AND DISCI-PLINE FOR ORIGINAL FREE WILL BAPTISTS OF NORTH CAROLINA supporting this practice was taken from the Holiness corrupted Cape Fear Conference Discipline of 1899 which was repudiated by the Original (Cape Fear Free Will Baptist Conference. This clause is: "That the annual conference or association being the highest tribunal, shall have final disciplinary authority over the local church," and

Whereas, the Central Conference of Original Free Will Baptists in session November 9, 1961, passed resolutions which in effect laid the groundworks for said conference to become a part of a new denomination, therefore,

Be it resolved that we, the delegates who are representing churches and ministers who are adherents to the historic doctrines, customs, practices, and usages of Original Free Will Baptists assembled this 20th day of November, 1961, do hereby declare ourselves to be the true Original Free Will Baptists of the Central Conference of Original Free Will Baptists.

Be it further resolved that we repudiate the following statement found on Page 53 in the STATEMENT OF FAITH AND DISCIPLINE FOR ORIGI-NAL FREE WILL BAPTISTS OF NORTH CAROLINA which is: "The annual conference or association being the highest tribunal, shall have final disciplinary authority over the local church."

Be it resolved that we unite with the churches and ministers who are true Original Free Will Baptists from the bounds of the Eastern, Western, Albemarle and Cape Fear Conferences.

Be it resolved that we declare our determination to maintain our affiliation with our denomination, The National Association of Original Free Will Baptists.

Be it further resolved that we declare all those churches and ministers in company with us adhering to doctrines, customs, practices and usages of the true Original Free Will Baptists to be in good standing.

On motion the session of the true Original Free Will Baptists of the Central Conference adjourned.

#### MINUTES OF THE TRUE ORIGINAL FREE WILL BAPTISTS OF THE CAPE FEAR CONFERENCE

Rev. Carey Watkins was elected temporary Moderator and Rev. Herman L. Hersey was elected temporary Secretary. The following delegates were enrolled:

The following ministers were enrolled: R. Eugene Waddell, Billy Walker, C. H. Coates, Frank Davenport, Herman L. Hersey, and Carey Watkins. Requests were received from Brothers Fred Hersey and Lonnie Cayton that they be enrolled. On motion Fred Hersey and Lonnie Cayton were enrolled as ministers. On motion Wingate Hansley was enrolled as a minister.

The following resolution was unanimously adopted:

Whereas, the Cape Fear Conference of Original Free Will Baptists was originally organized by the Discipline prior to 1899 which contains the following statement, "Independence of Churches, etc." page 36, "Each local church is a distinct and independent organization with full authority to manage its own internal affairs, elect its officers, receive, dismiss, discipline and exclude members. But this principle of the independence of each church is not held as a law of isolation: on the contrary, churches conveniently situated associate and co-operate in all things which tend to advance the common cause. Councils are, therefore, called in the organization of a church, ordination of a minister, and the settlement of serious difficulties. On the same principles, the churches meet by delegation in the Annual Conference, etc. But to these Conferences are granted no judicial or appellate powers conflicting with the independence of the local churches." THE FREEWILL BAPTIST FAITH TO WHICH IS ADDED THE PRACTICE OF CAPE FEAR FREEWILL BAPTIST CONFERENCE; by J.W. Lucas, Goldsboro, N.C., Baptist Review Job. Print, 1833; and

Whereas, the revision of the Discipline, FAITH AND PRACTICE OF THE CAPE FEAR FREEWILL BAPTIST CONFERENCE, revised 1899, corrupted the original doctrine regarding church government in that the last paragraph under, "Independence of Churches, etc." quoted above was changed to read, "The Annual Conference being the highest tribunal shall have final jurisdiction over the local churches" – page 34: and

Whereas, the revised Discipline, FAITH AND PRACTICES OF THE CAPE FEAR FREE-WILL BAPTIST CONFERENCE, 1899, also corrupted the original doctrine regarding sanctification as set forth in the Discipline prior to 1899 in that the following definition was given and added to sanctification, "it is obtained by faith and is subsequent to regeneration." - page 17; and

Whereas, the following churches on January 12, 1912, Shady Grove, Bethel, Bizzell's Grove, Robert's Grove, Lee's Chapel, Oak Grove, Dalys Chapel, St. Mary's Grove, St. Paul, Goldsboro, St. John and Prospect reconvened as the Cape Fear Conference of Original Free Will Baptists and repudiated the corrupt revised Discipline of 1899 and re-enacted and re-adopted the original faith of the founding fathers as promulgated in the first Cape Fear Freewill Baptist Conference of 1855 as set forth in the Discipline prior to 1899, and is recorded in the Discipline, THE FREE WILL BAPTIST FAITH TO WHICH IS ADDED THE PRACTICE OF CAPE FEAR FREEWILL BAPTIST CONFERENCE by J.W. Lucas. Goldsboro. N.C., Baptist Review Job Print., 1883; and

Whereas, the State Convention of Original Free Will Baptists of North Carolina in 1916, in adopting their first discipline, used the corrupt discipline of 1899 of The Cape Fear Free-Will Baptist Conference in that they copied the church government revision, "The Annual Conference being the highest tribunal shall have final jurisdiction over the local churches," page 37, CHURCH DISCIPLINE OF THE ORIGINAL FREE WILL BAPTIST, revised 1916. And subsequent revisions of the North Carolina STATEMENT OF FAITH AND DISCIPLINE FOR ORIGINAL FREE WILL BAPTIST have continued to use this statement adopted from the religious group now known as the Pentecostal Free Will Baptist Holiness movement; and

Whereas, the Cape Fear Conference of Original Free Will Baptists in session at Lee's Chapel Church November 2, 3, 1961, repudiated the faith and practice of our founding fathers of 1855 and of that re-enacted and readopted in the reconvened session on January 12, 1912 and as set forth in the Discipline prior to 1899 when, after Moderator L.R. Ennis very carefully read in his opening statement the section under "Independence of Churches etc." page 36, of THE FREEWILL BAPTIST FAITH TO WHICH IS ADDED THE PRACTICE OF CAPE FEAR FREEWILL BAPTIST CON-FERENCE, by J.W. Lucas, Goldsboro, N.C., Baptist Review Job Print, 1883, and tendered his resignation with the understanding that as the Conference voted they endorsed and declared themselves as adhering to a connectional form of government that assigned final authority and sovereignty over the local churches to the Conference; The Cape Fear Conference of Original Free Will Baptists declared themselves "Connectional Free Will Baptists" by majority vote of sixty-five to seventeen, November 2, 1961; and

Whereas, the Cape Fear Conference of Original Free Will Baptists did repudiate the faith and practices of Original Free Will Baptists prior to 1899 by adopting a resolution endorsing the usurped authority of the Western Conference relating to the application of conference authority over the local churches; and

Whereas, the Cape Fear Conference of Original Free Will Baptists did further repudiate the faith and practices of Original Free Will Baptists of the Cape Fear Conference prior to 1899 by adopting a resolution that the churches that have adopted forms of government contrary to the STATE-MENT OF FAITH AND DISCIPLINE FOR ORIGINAL FREE WILL BBAP-TISTS of North Carolina be declared out of fellowship with this conference until such time as they bring themselves back in line with said discipline; and

Whereas, the Cape Fear Conference of Original Free Will Baptists did further repudiate the faith and practices of the Cape Fear Conference of Freewill Baptists prior to 1899 by adopting a resolution that the ministers who have led their churches in these violations be silenced until time as they bring themselves back in line with the statement of and discipline for Original Free Will Baptists of North Carolina; and

Whereas, about the year 1834 Prospect Free Will Baptist Church was organized as a Free Will Baptist Church; and

Whereas, Prospect Original Free Will Baptist Church participated in the organization of the First Cape Fear Freewill Baptist Conference in the year 1855 under the doctrine as set forth in the Discipline prior to 1899 and as recorded in THE FREEWILL BAPTIST FAITH TO WHICH IS ADD-ED THE PRACTICES OF CAPE FEAR FREEWILL BAPTIST CONFER-ENCE by J.W. Lucas, Goldsboro, N.C. Baptist Review Job Print., 1883; and

Whereas, Prospect Original Free Will Baptist Church participated in the special session of the Cape Fear Free Will Baptist Conference on January 12, 1912 at Shady Grove Church in Sampson County and joined the following churches — Shady Grove, Bethel, Bizzel's Grove, Robert's Grove, Lee's Chapel, Oak Grove, Daly's Chapel. St. Mary's Grove, St. Paul, Goldsboro and St. John — in perfecting a permanent organization to the end that the original faith of our fathers, as promulgated in the first conference of 1855, might be re-enacted and re-adopted; and

Whereas, "Prospect Church in Conference January 27, 1912, Brother D. R. Ennis in chair. By motion a vote was taken to decide whether the Church wanted to adopt the old Discipline as adopted prior to 1899. The Church unanimously adopted the old Discipline." D.R. Ennis Moderator, R. M. Parker, Clerk. Page 89, PROSPECT CHURCH CONFERENCE MINUTES; and

Whereas, Prospect Original Free Will Baptist Church in Conference Septtember 30, 1961, by unanimous vote, adopted the following statement and recommendations:

#### STATEMENT

For the past few months there has been some question among Original Free Will Baptists in regards to church government.

Therefore, be it resolved that Prospect Original Free WillBaptist Church. Route 3, Dunn, Harnett County, North Carolina, officially re-affirms its position relative to church government.

That Prospect Free Will Baptist Church believes now, as it always has believed, in the independence of the local church, holding that the local church, is an independent body, so far as it relates to its own government, the transaction of its business, the choice of its officers, and the discipline of its members, and these rights cannot be denied the local church by any other organization within or without the denomination.

That Prospect Free Will Baptist Church has every right to hold and retain title to all property owned by it. That the board of trustees is invested with authority from the church to make proper and legal transactions, subject to the will and order of the majority of the church, and they shall be the custodians of such documents. That Prospect Free Will Baptist Church will not under any circumstance surrender these rights to any other organization.

That Prospect Free Will Baptist Church has the right to employ any Free Will Baptist minister as pastor, who is in good standing with the denomination regardless of his place of residence. It is understood that this right cannot properly be denied by any subsequent action of a quarterly meeting, yearly meeting, district association, national association, or any other group. It is further understood that the pastor of Prospect Free Will Baptist Church shall, upon ninety-day notice, terminate his services upon request by a majority vote of members in good standing of Prospect Free Will Baptist Church.

Prospect Free Will Baptist Church recognizes and believes in the value of coming together with other Free Will Baptist Churches for the purpose of mutual fellowship and endeavor and the establishing of proper organizations for the unifying of our purposes and accomplishing the goal of preaching the Gospel of Jesus Christ to every creature. However, Prospect Free Will Baptist Church is unalterably opposed to any organizational machinery within our denomination at any level which makes subjects of those who associate with it, invests undue authority in the hands of a few, and consequently throttles the democratic processes of church government and majority rule of the local congregation.

Be it known that to withdraw fellowship is the only formof discipline which may be brought against Prospect Free Will Baptist Church by any conference or association, district or quarterly meeting, State Convention, National Association, or any other body in any instance, situation, or practice since the final disposition of any matter within Prospect Free Will Baptist Church must be decided by majority vote of the members of Prospect Free Will Baptist Church. Therefore, Prospect Free Will Baptist Church does emphatically declare that as evidenced by its more than one-hundred year history and by inherent and scriptural rights as an autonomous, self-governing body, and that Prospect Free Will Baptist Church does steadfastly refuse and deny any and all judiciary authority of any body or group outside the bounds of the congregation of Prospect Free Will Baptist Church. That under no circumstances will Prospect Free Will Baptist Church relinquish its right to govern itself by the will and vote of the majority of its members.

Let it be understood that this statement in no way implies that it is the intention or desire of Prospect Free Will Baptist Church to sever its relations with other Original Free Will Baptists, but rather that Prospect Free Will Baptist Church intends to retain its identity as an Original Free Will Baptist Church. Neither does this statement imply that

pastor is to become in any way a dictator over Prospect Free Will Baptist Church, but rather that the pastor and the majority of the Membership are under God to lead the church in all Christian endeavor; always respecting and considering the sentiments of the minority.

#### RECOMMENDATIONS

1. It is recommended by the Board of Deacons and the Pastor that Prospect Church adopt the foregoing statement in order to spell out and define its exact position relative to its church government and in order to eliminate confusion because of various interpretations or Original Free Will Baptist government.

2. It is recommended by the Board of Deacons and the Pastor that the delegates elected to the annual Cape Fear Conference meeting be instructed to cast their vote in accordance with the principles set forth in this statement relative to the church government of Prospect Original Free Will Baptist Church and that all delegates hereafter elected to any and all conferences, associations and conventions cast their vote on the basis that Prospect Church believes in the historic practice that the final voice and work of authority is vested in the membership of the congregation at Prospect Church.

3. It is recommended that since constitutional provisions are made that Prospect Original Free Will Baptist Church maintain an affiliation with the National Association of Free Will Baptists of America and its worldwide missionary ministry.

4. That on the basis of the adoption of the above recommendations and because Carey Watkins cannot submit himself to become a member of this new religious denomination the leaders of the State Convention of North Carolina Free Will Baptists are purporting to form on the basis of a lawyer's interpretation of certain articles in the STATEMENT OF FAITH AND DISCIPLINE OF ORIGINAL FREE WILL BAPTISTS FOR NORTH CAROLINA, and because Carey Watkins is in faith, doctrine, and practice an Criginal Free Will Baptist, that Prospect Church give a vote of confidence to and retain Carey Watkins as pastor of Prospect Original Free Will Baptist Church.

Therefore, the Pastor and Congregation of Prospect Original Free Will Baptist Church, Harnett County, N.C. request and invite all ministers and churches of the Cape Fear Conference of Original Free Will Baptists who desire to maintain an affiliation with the National Association of Free Will Baptists of America and who believe in and adhere to and defend the faith and practices of Original Free Will Baptists as set forth in the Discipline prior to 1899 as recorded in THE FREE WILL BAPTIST FAITH TO WHICH IS ADDED THE PRACTICE OF CAPE FEAR FREEWILL BAPTIST CONFERENCE, by J.W. Lucas, Goldsboro, N.C., Baptist Review Job Print., 1883, to sit with us in a session of the true Original Free Will Baptists of the Cape Fear Conference of Original Free Will Baptists to the end that the original faith of our fathers, as promulgated in the first Conference of 1855, may be reenacted and re-adopted.

Therefore, resolved that we the true Original Free Will Baptists of the Cape Fear Conference, hereby endorse the above resolution and join with Prospect Church in declaring that we are the true Original Free Will Baptists of the Cape Fear Conference; and

Be it further resolved that we delcare that all those churches and iministers in company with us, adhering to the doctrines, customs, practices and usages of the true Original Free Will Baptists are in good standing; and

Be it further resolved that we, the true Original Free Will Baptists of the Cape Fear Conference, unite with the true Original Free Will Baptists of the Western, Eastern, Albemarle and Central Conferences in forming a Conference committed to our historic practice of congregational church government as practiced prior to the Discipline of 1899.

On motion the true Original Free Will Baptists of the Cape Fear Conference adjourned.

Brother J.D. Ballance dismissed the congregation with prayer for the noon recess.

#### AFTERNOON SESSION

We reconvened at 1:30 P.M. with the singing of "There's Within My Heart a Melody" and prayer by Rev. Wingate Hansley. Rev. Frank Davenport brought the devotions.

Rev. Bobby Jackson presented the following proposal which was unanimously adopted.

We, the undersigned, having a burden to maintain our historic congregational church government among Original Free Will Baptists, present this proposal to the delegates and ministers who have come to this meeting for the purpose of organizing a conference committed to our historic practice of congregational church government and desiring to maintain affiliation with our denomination — the National Association of Free Will Baptists. Therefore we respectfully propose the following:

1. That we elect a temporary chairman over this meeting today.

2. That we elect a temporary secretary.

3. That we ask permission of the body to present a series of proposed resolutions for consideration of the body. We present these with the understanding that any or all of them may be amended or rejected by the body.

WHEREAS the true Original Free Will Baptists from the Cape Fear Conference in session this the 20th day of November, 1961 adopted the following resolution: (seepages 5-14) therefore be it resolved

THAT we declare that we, the adherents to the historic doctrines, practices, customs, usages and church government of the Original Free Will Baptists, assembled together on this 20th day of November, 1961, are the true Original Free Will Baptists from the bounds of the Central, Western, Eastern, Albemarle and Cape Fear Conferences of Original Free Will Baptists; be it further resolved

THAT we endorse the above quoted resolutions adopted by the true Original Free Will Baptists from the Western, Central and Cape Fear Conferences; be it further resolved

THAT we recognize and seat the delegates who were sent by their local churches to this meeting for the purpose of organizing an Original Free Will Baptist Conference committed to our historic practice of congregational church government and desiring to maintain affiliation with our denomination — the National Association of Free Will Baptists; be it further resolved

THAT we recognize and seat all ministers requesting this privilege who have been ordained as Original Free Will Baptist Ministers, and who are committed to our historic practice of congregational church government and desire to maintain affiliation with our denomination — the National Association of Free Will Baptists.

WHEREAS the General Conference of Original Free Will Baptists was the "Mother Conference" of the present Central, Eastern, Western, and Albemarle Conferences; and

WHEREAS the true Original Free Will Baptists of the Cape Fear Conference have historically operated on the same general principles as the General Conference; and

RESOLVED that member churches of the General Conference of Original Free Will Baptists of North Carolina may adopt in addition to AN AB-STRACT OF THE FORMER ARTICLES OF FAITH CONFESSED BY THE ORIGINAL BAPTIST CHURCH, HOLDING THE DOCTRINE OF GENERAL PROVISION, WITH A PROPER CODE OF DISCIPLINE FOR THE FUT-URE GOVERNMENT OF THE CHURCH any other supplementary Discipline or Treatise not in basic conflict with this ABSTRACT OF THE FORMER ARTICLES. On motion the following resolution was unanimously adopted.

WHEREAS the National Association of Original Free Will Baptists, during its 1961 session at Norfolk, Virginia, asked the State Convention of Original Free Will Baptists of North Carolina "to repudiate any and all forms of connectional church government and reaffirm its position in our historic and established form of congregational church government"; and

WHEREAS the North Carolina State Convention of Free Will Baptists, during its 1961 session at Mt. Olive, N. C., refused to comply with the above mentioned request of the National Association; therefore be it resolved

THAT we, the General Conference of Original Free Will Baptists of North Carolina, hereby comply with the request of the National Association and hereby repudiate any and all forms of connectional church government wherever it may be found among Free Will Baptists and do hereby reaffirm our belief in congregational church government.

On motion the following resolution was unanimously adopted.

WHEREAS the STATEMENT OF FAITH AND DISCIPLINE FOR ORIGI-NAL FREE WILL BAPTISTS OF NORTH CARO. INA on page 53, 1955 revision, contains the following, "The Annual Conference or Association being the highest tribunal, shall have final disciplinary authority over the local church"; and

WHEREAS this statement with slight variation has existed in the Discipline of the North Carolina State Convention since its first Discipline in 1916 where it read, "The Annual Conference being the highest tribunal shall have final jurisdiction over the local churches"; and

WHEREAS this statement came from a corrupted holiness discipline of the Cape Fear Conference, 1899 revision, which was repudiated by the reorganized Cape Fear Conference of Original Free Will Baptists on January 12, 1912; therefore be it resolved

That we hereby repudiate the above quoted statement found on page 53 of THE STATEMENT OF FAITH AND DISCIPLINE FOR ORIGINAL FREE WILL BAPTISTS OF NORTH CAROLINA.

On motion the following resolution was unanimously adopted.

WHEREAS the Cape Fear Conference was organized in 1855 and operated under a discipline entitled THE FREEWILL BAPTIST FAITH TO WHICH IS ADDED THE PRACTICE OF THE CAPE FEAR FREEWILL BAP-TIST CONFERENCE: and

WHEREAS this discipline on page 36, 1883 printing, contains the following under "Independence of Churches" "Each local church is a distinct and independent organization with full authority to manage its own internal affairs, elect its officers, receive, dismiss, discipline and exclude members. But this principle of the independence of each church is not held as a law of isolation; on the contrary, churches conveniently situated associate and co-operate in all things which tend to advance the common cause. Councils are, therefore, called in the organization of a church, ordination of a minister, and the settlement of serious difficulties. On the same principles, the churches meet by delegation in the annual Conference, etc. But to these Conferences are granted no judicial or appellate powers conflicting with the independence of the local churchés"; and WHEREAS a revision of this discipline of 1899, corrupted with holiness doctrines, changed the last sentence to read: "The annual Conference being the highest tribunal shall have final jurisdiction over the local churches"; and

WHEREAS the original Free Will Baptists of the Cape Fear Conference in session on January 12, 1912, re-organized the Cape Fear Conference and adopted the discipline prior to the 1899 corrupted version; and

WHEREAS the Cape Fear Conference through its history, except for the holiness deflection, has operated according to the principles contained in the 1883 printing regarding "Independence of Churches"; and

WHEREAS this statement clearly states the position of congregational church government relating to the relationship of a local church to a conference; and

WHEREAS this statement is in harmony with AN ABSTRACT OF THE FORMER ARTICLES OF 1812; therefore be it resolved

THAT we adopt the paragraphs on 'Independence of Churches' quoted above from the 1883 printing and pledge that this is our official position regarding the relationship of this General Conference to all affiliated churches.

On motion the following resolution was unanimously adopted.

RESOLVED that we, the General Conference of Original Free Will Baptists of North Carolina take whatever steps necessary to maintain our affiliation with our denomination — the National Association of Free Will Baptists.

On motion the following resolution was unanimously adopted.

RESOLVED that a Secretary-Treasurer be elected to act as Promotional Secretary whose duties it will be to act as our official spokesman and to distribute educational and promotional material as funds are available; be it further resolved

THAT we elect a temporary Membership Committee consisting of the Secretary-Treasurer and four others to receive ministers and churches under the watchcare of our Conference until the next session. It is understood that this is the limit of their authority; be it further resolved

THAT we meet for fellowship and necessary business on Tuesday, January 30, 1962. It is understood that the Pastor of the host church will arrange for the sermon and will preside until a moderator is elected.

On motion it was voted that we meet with the Grace Church in Greenville. Rev. R. Eugene Waddell was elected Secretary-Treasurer, Rev. LaRue Davis, Rev. Ronald Creech, Rev. Paul Lee and Mr. Fred Parker were elected to work with the Secretary-Treasurer in the Membership Committee.

On motion we gave a rising vote of thanks to the host church and to those who prepared the program and resolutions.

An offering in the amount of \$106.99 was received.

On motion we adjourned. Rev. Carey Watkins gave the benediction.

#### PROCEEDINGS

The General Conference of Original Free Will Baptists of North Carolina met at the Garner Church, Garner, North Carolina on November 13, 14, 1962.

The morning session opened at 10:00 A.M. with Rev. Conrad Williford leading the song service using hymns "I am Resolved" and "Leaning on the Everlasting Arms." The welcome was given by Mr. Silas Williams on behalf of host pastor Waddell.

The morning devotions were given by Rev. Milton Worthington. He used John 15. He pointed out three "P's" because of our relationship as "branches" with Jesus the "Vine". (1) Pruning, (2) Persecution, and (3) Personal Service. It was an excellent devotional, pungently delivered. Many amens! We were led in prayer by Bro. Worthington.

The morning message was given by Rev. Eugene Waddell using Acts 6 and speaking on the subject "The Majority Shall Carry the Point" taken from the earliest treatise known to Original Free Will Baptists, The Former Articles of 1812.

He mentioned the battle over autonomy in the State Baptist Convention Meeting in Raleigh today. He said that Original Free Will Baptists knew only "The majority shall carry the point" idea of church government until the 1899 "reversal" (instead of revision) of the Cape Fear Conference holiness corrupted discipline brought forth "The Annual Conference being the highest Tribunal shall have final jurisdiction over the local church" idea of church government. Prior to the holiness corrupted "reversal" of 1899, he said, the treatise read "But to these Conferences are granted no judicial or appellate powers conflicting with the independence of the local churches." He pointed out that the Cape Fear Conference repudiated their "reversal" in 1912 which resulted in a split in the Conference, lawsuits over church property and the beginning of the Pentecostal Free Will Baptist movement which we know today.

He further stated that the North Carolina State Convention ADOPTED this ''reversal'' in 1916 and that there is where our trouble came from.

Bro.Waddell's message was well delivered and very well documented.

During the business session, Rev. L.R. Ennis was elected moderator for the day. He gave apt and appropriate words to the body upon his election.

The moderator recognized visiting Free Will Baptists. They included: Rev. Jimmy Aldridge, South Carolina Conference (missionary appointee to Africa)

At this time the moderator asked for the presentation of any historical documents and the acknowledgements of greetings from various individuals and other bodies. The clerk proceeded to present to the Conference historian. Bro, Waddell, the following documents:

1. A photocopy of the famous CONFESSION OF 1660 presented to King Charles II.

- 2. A photocopy of the only known copy of AN ABSTRACT OF THE FORMER ARTICLES OF FAITH CONEESSED BY THE ORIGINAL BAPTIST CHURCH HOLDING THE DOCTRINE OF GENERAL PROVISION WITH A PROPER CODE OF DISCIPLINE FOR THE FUTURE GOVERNMENT OF THE CHURCH'
- 3. Photocopies of ancient minutes of the General Conference for the years 1845. 1857 and 1886.
- 4. An original printed copy of the minutes of the Annual Conference of 1894.
- 5. Copies of the minutes of the Union Conference for the years of 1891, 1892, 1893, 1894, 1896, 1897 and 1898 given by Mrs. T.E. Beamon.

The moderator then recognized Rev. D.W. Alexander who presented to the historian an original printed copy of the minutes of the General Conference for the year 1851.

We were then led in "He Lives" by Rev. Johnny Eason. Rev. Bill Gardner sana "I'm Justified".

Rev. Frank Davenport presented the speaker, Rev. Guy Owens, who was preaching a revival in Davenport's Church.

Bro. Owens spoke on the subject "Compassion Makes a Difference" using Matthew 9:34-38. and Jude 22.

He said compassion is "sorrow or pity excited by the distress or misfortunes of another." He pointed out that compassion will make a difference in:

1. Our standard of Christian living

2. Our praying

- 3. Our giving
  - a. of ourselves
  - b. of our substance
- 4. Our preaching
- 5. Our witnessing

Bro. Owen's message demonstrated the compassion about which he spoke.

We were then led in prayer by Bro. Owens.

During lunch, we enjoyed a wonderful time of fellowship. The hospitality of the Garner church was tops. "How blessed for brethren to dwell together in unity."

#### TUESDAY AFTERNOON

Rev. LaRue Davis led us in singing "He Keeps Me Singing". Rev. Luther Burns brought a good devotion from Luke 5. Prayer by Bro. Burns. The moderator led us in singing "Trust and Obey."

The moderator recognized Bro. Wayne Smith, moderator of the State Association for greetings from that body. He brought good news especially about Home Missions and the orphanagework. He revealed that a 325 acre farm had been given the Association on which to build an orphanage.

A report was given by Bro. Eugene Waddell, editor of the WITNESS, our State paper. He asked for subscriptions also and got several.

A very helpful report was given by Bro. Sam Johnson, Promotional Secretary of the National League Board.

The roll of preachers was called.

The minutes of previous meetings were read and approved.

Bro. Frank Davenport reported on the work in Fayetteville.

Bro. Rufus Coffey gave a very interesting report on World-wide missions.

Bro. D.W. Alexander requested that Bro. Bill Gardner sing "Christ Is All" at this time and that Bro. Gardner sing and Bro. Hersey play at his funeral.

Prayer by Bro. Adam Scott.

#### TUESDAY NIGHT MISSION ARY SERVICE

Bro. Bill Gardner led us in "Send the Light" and sang himself, "My Sins are Gone". Then he brought the devotional from Isaiah 6. He prayed and then led the congregation in singing "To The Regions Beyond".

Mrs. Jimmy Aldridge, missionary appointee to Africa, gave her testimony.

Bro. Gardner sang "He Left Heaven for Me".

Rev. Jimmy Aldridge, also appointee to Africa, spoke from Exodus 4:13-15, John 8:18, and Matthew 28:19-20.

The congregation sang "I Am Not Ashamed of the Gospel" written by Bro. Herman Hersey. Bro. Rufus Coffey spoke concerning Free Will Baptists and World Missions. He said that it takes 60 churches or 5,000 Free Will Baptists to support one missionary on the field at our present rate of giving.

The offering was received. Bro. L.R. Ennis led in prayer. Bro. Gardner sang "The Breaking of the Bread".

Bro. Dan Merkh, missionary on furlough from Africa, spoke. He spoke of individual churches supporting individual missionaries. He said it takes 60% of the money a missionary raises to pay his expenses in raising the money.

He showed slides of his work as a missionary builder. Bro. Merkh then prayed.

We sang "Thank You Lord for Saving My Soul".

Bro. Coffey dismissed the service with prayer.

#### WEDNESDAY MORNING

Bro. David Paramore led us in singing "Blessed Assurance" and "Bring Them In".

Devotions by Bro. Adam Scott. He spoke from Hebrews 8:1,2.

He said our "Confessions" (Profession) centers in 3 appearings of Jesus:

1. Appearance to put away sin

2. Appearance in the presence of God

3. Appearance without sin unto salvation

He then led us in prayer.

Bro. Paramore led us in singing "Take Time To Be Holy".

Our morning message was given by Bro. Frank Davenport who spoke on "The Original Free Will Baptists — Struggle for Survival".

He asserted that there were Free Will Baptists in the state even before Paul Palmer. He dwelt on the invasion of our churches in the middle 1700s by the Particular Baptists. He touched on the split in 1853 over masonry and the split in 1912 over holiness doctrine. The present split he declared was over liberal theology and free-masonry united.

This message was well-delivered and well documented.

Bro. Galen Dunbar led us In singing "There Is A Fountain". Bro Bill Gardner sang "Amazing Grace."

The Moderator introduced the speaker for the next hour, Rev. Leroy Forlines, professor at the Free WillBaptistBible College in Nashville, Tennessee. His Mother, Mrs. Leta Forlines, was requested to stand for recognition.

He spoke on "Free Will Baptist distinctives, historically viewed and Biblically defended."

He showed the early distinctives of the 1600s, and the early distinctives in America. He pointed out that the General provision of Christ's atonement was one of those basic distinctives. He said that it would be simple for God to force people to be saved but it required wisdom to allow man to have a choice in the matter. He pointed out the distinctive of the Perseverance of the Saints but said, however, that he didn't develop any ulsers over making shipwreck of faith. He praised God that we were free, as a denomination, from liberalism.

He ended his very well documented message by saying "long live Free Will Baptists." There were many amens!

The Clerk pointed out that there were in North Carolina, either officially members of our State group or in sympathy with us in our struggle for the preservation of cangregational church government, the following:

We all enjoyed wonderful fellowship during the lunch hour.

#### WEDNESDAY AFTERNOON SESSION

We sang 'He's a Wonderful Savior'' led by Bro. Chester Phillips. Devotions were brought by Bro. Don Pegram. He spoke powerfully for a few moments on the Great Commission.

A report on the Bible College was given by Bro. Leroy Forlines.

Bro. Rufus Coffey spoke further about Foreign Missions. He reported that Free Will Baptists now have 42 missionaries in 7 countries of the world. He said that the General Director, Bro. Reford Wilson, was going on a tour of our work in South America in March, 1963.

He mentioned Bill Phipps, who is in training as a missionary pilot. He said that the Eagletons, Miss Volena Wilson, the Hannas, and the Waids would be home on furlough next year. He then presented Bro. Ken Walker, a home missionary to Washington, D.C.

On motion of Bro. Carey Watkins the following resolution was adopted unanimously.

#### RESOLUTION

- WHEREAS, there is a case now pending on appeal to the North Carolina Supreme Court, to be heard November 28th involving one of our sister churches, and
- WHEREAS, this case will have far reaching repercussions regarding our congregational form of church government in this state, and
- WHEREAS, the State Convention has retained attorney Hubert E. Phillips of Kenansville, North Carolina, and has filed a petition with the Supreme Court signed by C.L. Patrick and C.H. Overman, asking the court to allow them to appear amicus

curiae and adopt the plaintiff's brief, and

WHEREAS, the Eastern Conference has retained attorneys R.S. Langley and Robert D. Wheeler of Grifton, North Carolina, and has filed a petition with the Supreme Court signed by Carroll B. Hansley and Ralph Lightsey, asking the court to allow them to appear amicus curiae and adopt the plaintiff's brief, and

WHEREAS, the Central Conference has retained attorney Joseph Horton of Snow Hill, North Carolina, and has filed a petition with the Supreme Court signed by Walter Reynolds, and C.H. Overman, asking the court to allow them to appear amicus curiae and adopt the plaintiff's brief, and

WHEREAS, the Cape Fear Conference has retained the law firm of Johnson, Gamble, and Hollowell of Raleigh, North Carolina, and has filed a petition with the Supreme Court signed by M.E. Godwin and Mrs. Carl Dudley, asking the Court to allow them to appear amicus curiae and adopt the plaintiff's brief, and

WHEREAS, the Supreme Court may grant these petitions, and

WHEREAS, we want to be prepared in any eventuality to support the struggle for congregational church government, known from our earliest history in this state to be "the majority shall carry the point" —

THEREFORE BE IT RESOLVED:

1. That the General Conference again go on record as supporting the great principle of congregational church government and our utter disregard and repudiation of any and all forms of connectional church government.

2. That to implement this position we elect here today a committee of five to have prepared, for and on behalf of this General Conference, a petition to file a brief amicus curiae and later the brief itself in case, in their judgment, it becomes necessary.

On motion of Bro. Wayne Smith the following were elected on the committee of five:

L. R. Ennis J.C. Ennis Herman Hersey Gordan Sebastian Owen Thomas

#### HISTORIAN'S REPORT

As you have observed, we have received several valuable documents in this annual session. In the light of this I wish to make the following recommendations:

1. That we extend a rising vote of appreciation to Brother D.W. Alexander for the 1851 General Conference Minutes which he has given to the Conference Historical Collection on condition that should he or his son, Carroll, ever request it they will be returned.

2. That we extend a rising vote of appreciation and instruct our Clerk to write a letter of gratitude to Bro. Nick Powell for the gift of the 1884 edition of AN ABSTRACT OF THE FORMER ARTICLES OF FAITH confessed by the Original Baptist Church, holding the Doctrine of General Provision, with a Proper Code of Discipline for the future government of the Church.

3. That we extend  $\sigma$  rising vote of appreciation and instruct our clerk to write a letter of gratitude to Mrs. Thomas E. Beamon for several valuable minutes which she donated to us.

4. That we extend a rising vote of appreciation to Bro. Ronald Creech for his efforts in securing photographic copies of several valuable documents.

5. That this Conference award a suitable citation commemorating this Sesquicentennial celebration of the first printing of our Discipline to the following churches whose history extends into the days before the General Conference was divided in 1886:

Gum Swamp Original Free Will Baptist Church, Pitt County; Parker's Chapel Original Free Will Baptist Church, Pitt County; Antioch Original Free Will Baptist Church, Wayne County; St. Delight Original Free Will Baptist Church, Franklin County; Prospect Original Free Will Baptist Church, Harnett County.

6. That we call on all our people to give all the old minutes, treatises, disciplines, and papers which they have to our General Conference Historical Collection.

7. That we authorize the Historian to rent a suitable safe-deposit box in which to store our valuable collection. (This recommendation is made in the light of the prohibitive cost of a fire-proof filing cabinet at this time.)

8. That we extend a rising vote of appreciation to Bro. C.H. Coates for the items which he is donating to the Historical Collection.

On motion of Bro. Carey Watkins, the report of the Historian, R. Eugene Waddell, was received and adopted item by item.

On motion of Bro. J.D. Ballance the following resolution was adopted:

#### RESOLUTION

- WHEREAS, we feel it proper and good to perpetuate the memory of useful and dedicated children of God, and
- WHEREAS, one of the best ways to do so is in the Christian Education of the youth, and
- WHEREAS, our Heavenly Father, in His sovereign wisdom, has taken from among us our beloved and much esteemed Sister Leah Waddell, and
- WHEREAS, this sister before her home going was one of the most active women in our denomination in youth work, and

WHEREAS, many youths need assistance in going to college -

THEREFORE BE IT RESOLVED:

1. That we recommend to our State Association that a North Carolina Student Loan Fund'be established, known as the Leah Waddell Student Loan Fund.

2. That, in the light of our Conference being Leah Waddell's home conference, that our Conference lead the way, as much as is possible, in support of this fund.

3. That we recommend that our sister conferences in the State also vigorously support this fund.

The Moderator recognized the pastors and delegates from our oldest churches mentioned in the report of the Historian and pictures were taken of them.
