The session opened with singing "In the Old Time Way" and "He Included Me" led by Rev. Fred Hall. Rev. Charles Keith had the devotion using John 14:14. Prayer by Bro. Keith.

Rev. Wayne Smith, host pastor, welcomed us to Unity Church. Rev. Eugene Waddell was elected moderator for this session. He gave a brief address to the conference after which Bro. D. W. Alexander led in prayer.

Minutes of the August Union Meeting were read and approved.

Mr. John Ennis was appointed to serve as proxy for Mr. Fred Parker and Mr. David Ange as proxy for Mr. L. B. Coley on the Membership Committee.

Rev. Frank Davenport gave a report on the Hospital Insurance for ministers and Christian workers. He urged the churches to pay their ministers hospital insurance.

The worship service was opened by singing "Christ for the World" and "The Banner of the Cross". Bro. David Ange led in prayer.

The offering was received in the amount of \$36.69.

Rev. Fred Hall rendered the special music by singing "Here Am I, Send Me." Rev. John Moehlman, Missionary to Ecuador, brought the morning message us-

He challenged our hearts with the fact that the plan of God in missions is for all the world to hear the Gospel "and ye are witnesses of these things". He further challenged us with the fact that we are God's ambassadors to the world.

AFTERNOON SESSION

The afternoon session was opened by singing "Heavenly Sunshine" and "We've a Story to Tell" led by Bro. Fred Hall.

Miss Eulla Mae Martin, Missionary to Brazil, brought the devotion using Matt. 28:18-20, after which she led in prayer. Bro. Wayne Smith led in prayer before the afternoon business session.

A partial report of the resolution committee was given. Bro Frank Davenport moved that resolution #1 be adopted.

Bro. Frank Davenport moved that number X of resolution #1 be amended to read as follows:

X. That copies of this resolution be sent to the members of the Executive Committee and to the members of the Commission on Theological Liberalism of the National Association of Free Will Baptists, and that a letter be sent to the chairman of the Commission on Theological Liberalism requesting a reply as to their intention of action by December 31, 1964.

Carried.

Resolution as amended was carried as follows:

RESOLUTION #1

- Whereas, the Lord Jesus Christ has, by His marvelous Grace, saved our souls and called us together as a conference and given us a strategic position in our state, and
- Whereas, the infallible Word of God from Genesis chapter 1 to Revelation chapter 22 makes emphatically clear that God's people are to be separated from the world:
 - I John 2:15-17, "Love not the world, neither the things that are in the world. If any man love the world, the love of the Father is not in him. For all that is in the world, the lust of the flesh, and the lust of the eyes, and the pride of life, is not of the Father, but is of the world.
 - And the world passeth away, and the lust thereof; but he that doeth the will of God abideth for ever."
 - II Corinthians 6:14-17, "Be ye not unequally yoked together with unbelievers; for what fellowship hath righteousness with unrighteousness? and what communion hath light with darkness?

And what concord hath Christ with Belial? or what part hath he that believeth with an infidel?

And what agreement hath the temple of God with idols? for ye are the temple of the living God; as God hath said, I will dwell in them, and walk in them; and I will be their God, and they shall be my people.

Wherefore come out from among them, and be ye separate, saith the Lord, and touch not the unclean thing; and I will receive you,"

- Ephesians 5:11, "And have no fellowship with the unfruitful works of darkness, but rather reprove them."
- **Psalms 1:1,** "Blessed is the man that walketh not in the counsel of the ungodly, nor standeth in the way of sinners, nor sitteth in the seat of the scornful."
- **Exodus 23.2,** "Thou shall not follow a multitude to do evil; neither shall thou speak in a cause to decline after many to wrest judgment."
- Jude 3, "Beloved, when I gave all diligence to write unto you of the common salvation, it was needful for me to write unto you, and exhort you that ye should earnestly contend for the faith which was once delivered unto the saints.", and

Whereas, after our separation from the world, we are strictly forbidden to befriend the enemies of our Lord Jesus Christ.

> II John 9-11, "Whosoever transgresseth, and abideth not in the doctrine of Christ, hath not God. He that abideth in the doctrine of Christ, he hath both the Father and the Son.

If there come any unto you, and bring not this doctrine, receive him not into your house, neither bid him God speed:

For he that biddeth him God speed is partaker of his evil deeds."

II Chronicles 19:2, "And Jehu the son of Hanani the seer went out to meet him, and said to king Jehoshaphat, Shouldest thou help the ungodly, and love them that hate the Lord? therefore is wrath upon thee from before the Lord." John 18:25-27, "And Simon Peter stood and warmed himself. They said therefore unto him. Art not thou also one of his disciples? He denied it, and said. I am not.

One of the servants of the high priest, being his kinsmen whose ear Peter cut off, saith, Did not I see thee in the garden with him?

Peter then denied again; and immediately the cock crew.", and

- Whereas, history is replete with noble examples of heroes of the faith who have courageously stood for God from time immemorial, and
- Whereas, in the year 1727 a spiritual meteor named Paul Palmer streaked across the Old North State giving birth to that noble denomination known as Free Will Baptists, and
- Whereas, they were despised by the leaders of Hyper-Calvinism, were laughed at, were persecuted, were misused — but yet who stood firmly for God, the Bible and right notwithstanding, and
- Whereas, these great forefathers of ours gave us the heritage we enjoy today and because of this tremendous trust we are in a place of immense responsibility to perpetuate this heritage to the born and unborn generations of our posterity, and
- Whereas, this same Old North State has been for the last four (4) years the battleground for the insidious and diabolical attempt to wrest from us our personal and congregational freedom and also a terrible attempt to plunge us into a pool of worldliness, liberalism, modernism, neo-orthodoxy, new-evangelicalism, and the like, and
- Whereas, God in His indifinite mercy and goodness has protected and delivered us, and
- Whereas, the trend of this age is away from historic, fundamental, Christianity and our denomination is not immune from danger, and
- Whereas, the position of our beloved denomination from its inception has been the position of historic, fundamental, basic Christianity, and
- Whereas, it becomes necessary oftentimes for the people of God to remind themselves and others of their position, therefore be it resolved:
 - I. That this General Conference of Original Free Will Baptists of North Carolina reaffirm our position on the vital matter of God's Holy Word because of the unparalleled assaults upon it today:
 - A. This General Conference has, does now, and by God's Grace always will believe that the Bible is the absolute, infallible, inerrant Word of God.
 - B. We believe in the virgin birth, sinless life, and substitutionary death of the Lord Jesus Christ.
 - C. We believe in the total depravity of man and in his absolute need of salvation.
 - D. We believe in the salvation of the soul by grace through faith alone.
 - E. We believe in the eternal blessedness of the saved in heaven and the eternal punishment of the lost in hell.
 - F. We believe while living in this world in this atheistic age, that we are to be separate from the world as taught in II Cor. 6:14 and that we are absolutely forbidden to befriend the religious enemies of the Lord Jesus Christ, and that rather we are expressly commanded by God to reprove them.
 - G. We do not intend to imply that this simple, short, concise statement is in any way an exhaustive expression of our doctrinal position.
 - II. That this General Conference go on record as being unalterably opposed to the trend of this age of Bible believers and outstanding, outspoken modernists yoking up together and working together in the light of God's plain question, "How can two walk together except they be agreed?" Amos 3:3.

- III. That this Conference go on record as being strongly opposed to the part some protestants are playing in being friendly with the Catholics, even preaching in their schools and churches and allowing Catholics to hold places of leadership in their evangelistic campaigns and other special meetings.
- IV. That this Conference go on record as believing that the Roman Catholic Church is just as dangerous as it always has been and that we are strictly opposed to the so-called ecumenical movement that the Catholics are promoting designed to destroy the protestant church.
- V. That this Conference go on record expressing our extremely shocking alarm at the dangerous, cross-roads position our beloved denomination now occupies because of the recent and present associations of the moderator of our National Association with the Billy Graham Association with all of its far reaching implications.
- VI. That this Conference go on record as strongly requesting the Commission on Theological Liberalism of the National Association of Free Will Baptists to immediately inform our denomination, through whatever channels available to them, of the subtle dangers, to us as a distinct group, of modernism, liberalism, neo-orthodoxy, the ecumenical movement and, now, the most insidious of all new-evangelicalism.
- VII. That this Conference go on record expressing great confidence in our entire denomination generally and our great concern that our Bible College in Nashville, Tennessee forever remain a stalwart, stronghold against these false doctrines.
- VIII. That this Conference go on record asking God in mercy to keep us unspotted from the world and free from the pitfalls of the devil until Jesus raptures us out of this world of sin and sorrow.
- IX. That this Conference renew its vow and determination to win all the souls we can in the shortest time we can for our dear and precious Lord Jesus.
- X. That copies of this resolution be sent to the members of the Executive Committee and to the members of the Commission on Theological Liberalism of the National Association of Free Will Baptists, and that a letter be sent to the chairman of the Commission on Thelogical Liberalism requesting a reply as to their intention of action by December 31, 1964.

On motion by Bro. Fred Hall Resolution #2 was tabled until tomorrows session. We were adjourned with prayer by Mr. Walter Edmundson until 10:00 a.m. Friday morning.

FRIDAY MORNING — NOVEMBER 6, 1964

Rev. Eugene Hales led the Conference in singing "More About Jesus" and "Victory In Jesus." Rev. Wayne Phillips brought the devotion using Esther 4:11-14 after which he led in prayer.

The following personalities were visiting with us for this day's session: Rev. John Moehlman, Missionary to Ecuador; Rev. and Mrs. Jim Combs, Missionaries to Brazil; Miss Molly Barker, Missionary to Uruguay; Miss Eula Mae Martin, Missionary to Brazil.

On motion by Wayne Smith resolution #2 was taken from the table for discussion. Resolution #2 was carried as follows:

Whereas, Our state boards are in need of a better system of giving and receiving information, and

Whereas, The giving of information is important to the solicitation of funds necessary to carry on the work of our Lord, and

Whereas, It is not practical because of the expense, for each board to set up and equip a separate office, and

Whereas, One office could serve all the boards of our State Association adequately, and

Whereas, A Bible bookstore in our state would be profitable to our state program, therefore be it

Resolved that the Conference go on record encouraging our state boards in their efforts to set up such an office and bookstore.

Mr. J. D. Ballance gave a report of the Leah Waddell Scholarship Fund and urged our churches to contribute to this fund that some needy and worthy student in the Free Will Baptist Bible College could receive some scholarship aid.

The worship service was begun by singing "Follow Me" led by Bro. Hales. Bro. Tom Hamilton, evangelist from Georgia, ask the Lord's blessing on the offering which was received in the amount of \$31.61. This was to be divided between our four missionary speakers in this session.

Bro. Jim Combs, Missionary to Brazil, brought the morning message using Genesis 24. He used the servant of Abraham, who was sent out to seek a bride for Isaac, as a type of the Holy Spirit, who is seeking out a bride for Christ. He used the bride as a type of the Christian who leaves all to follow the Holy Spirit to meet the bridegroom — Christ one day. He emphasized the following things about this bride:

1. As she followed the servant went with her.

- 2. She was provided comfort and protection by the servant.
- 3. She was taught along the way about the bridegroom by the servant.
- 4. She grew in love for this husband as she journeyed to meet him.

5. She became the medium through which all nations shall be blessed.

We sang "I Surrender All" after which we were dismissed for lunch, which had been prepared for us by the host church.
