THURSDAY MORNING SESSION

The session was opened by singing the hymn "He Lives" led by Brother Ron Christ. Prayer was rendered by Brother L. R. Ennis. A Devotional thought was given by Brother Don R. Pegram concerning "The Preaching of the Cross". He also led in prayer.

A welcome to this annual session of the General Conference from the host Church was given by Mrs. Russell Lamm. Brother Wayne Smith, pastor of the Unity Free Will Baptist Church in Smithfield was elected as moderator for this two day annual session.

The minutes of the August 28, 1965 Quarterly Meeting while convening at the Hope Free Will Baptist Church in Scotland Neck were read and approved.

The roll call of ministers revealed the following twenty-nine ordained ministers present:

There were no license ministers present.

The roll call of churches revealed the following twenty-nine churches out of thirty-eight representing by letter:

A motion was made and passed that the moderator appoint a Digest and Finance Committee. Appointed on the Digest Committee were Brother Billy Morris, Chairman, Brother L. R. Ennis and Brother Chester Phillips. Appointed on the Finance Committee were Brother Lonnie Graves, Chairman, Brother Nathan Eason and Brother J. D. Balance.

Brother Bill Robinson and Brother Edwin Hill were elected to serve the unexpired terms of Brother Adam Scott and Brother Milton Worthington on the Membership Committee.

Brothers Ronald Creech, Bobby Carden and Billy B. Walker were elected to serve on the Resolutions Committee.

The Business was suspended and a five minute intermission granted before the morning preaching service was opened by singing the hymns "My Saviour's Love" and "Trust and Obey" led by Brother Ron Christ. An offering of \$25.65 was received.

Brother Bill Fulcher, our Missionary to Uraguay, South America and the speaker for the morning service was introduced by the moderator, Brother Wayne Smith. His scripture text was taken from II Corinthians 1:11 and his subject was "What God Did For Me". The scriptural phrase "Ye also helping together by prayer for us" was used to relate experiences of how the prayers of God's people helped to realize God's direction and blessings; God's leadership in getting to the field of service and the salvation of souls.

Brother L. F. West led in prayer in adjourning for Lunch.

THURSDAY AFTERNOON SESSION

The afternoon session was opened by singing the hymns "Count Your Blessings" and "Jesus Saves" led by Brother Ron Christ. A short message was given by Brother Bill Robinson using Romans 1:1-7 as his text. He noted the following three things which Paul was: (a) A servant of Jesus Christ. (b) Called to be an apostle. (c) Separated unto the gospel of God. He also emphasized the fact that a person must become a servant of Christ before the other things can follow.

The following partial report of the Membership Committee was given and adopted:

- (1) Recommended that Brother Eddie Dollar be received into the fellowship of the General Conference as an ordained Minister.
- (2) Recommended that the First Free Will Baptist Church of Cary, North Carolina and the First Free Will Baptist Church of Greensboro, North Carolina be received into the fellowship of the General Conference and that their delegates be seated.

The right hand of Christian Fellowship was extended by the moderator, Brother Wayne Smith to Brother Eddie Dollar and the delegation from the First Church of Cary and the First Church of Greensboro.

The report of the Finance Committee was given and then by motion was placed upon the table.

FRIDAY AFTERNOON SESSION

The afternoon session was opened by singing two hymns led by Brother Nathan Eason. Devotional thoughts were given by Brother Eddie Dollar from Hebrews 11:1,6 and Judges chapter 6. His subject was "Gideons' Faith' and he pointed out four things which are needful if God uses a man or if this man ever becomes great:

- 1. Realization of a great need.
- 2. Sacrificing for a great cause.
- 3. Daring to do the unusual.

4. Putting God to the test.

The Membership Committe's report was given and produced the following action:

(1) A motion was made and passed that Preachers outside of the State of North Carolina but actively engaged in full-time Christian service receive an official communication from the clerk and duly signed expressing our concern and prayers for them.

(2) A motion was made and passed that we send letters of recommendation for Brothers Adam Scott and Albert Rollins to the Coastal Association of Free Will Baptists of North Carolina and Brother R. Eugene Waddell to the Cumberland Association of Free Will Baptists of Tennessee.

(3) A motion was made and passed that we receive Brothers J. W. Long, Jr. and Roger Russell upon official reception of letter of request for membership from their local church.

(4) A motion was made and passed that we receive the Immanual Free Will Baptist Church of Durham County, North Carolina into the General Conference upon reception by our clerk of an official letter of request for membership of said church.

Brother Frank Davenport, the Promotional Secretary of the North Carolina State Association gave a very favorable report of the State Program and other phases of our State work.

REV. D. R. (DOC.) ENNIS March 14, 1871 — January 17, 1939

The 1965 session of our General Conference authorized the placing of an historical sketch of Rev. D. R. Ennis in our printed minutes. His sons, Rev. L. R. Ennis and Mr. John C. Ennis, supplied the information to the historian for this sketch.

This stalwart soldier of the cross was born March 14, 1871 in Johnston County, N. C. His father was Levi and his mother was Clarkie Biggs Ennis. Also born to this union were five sisters and four brothers. Rev. Ennis was converted in 1891 at the age of 20, in Pine Forest Baptist Church and was baptized and united with that church immediately. After working for Christ for 14 years as a layman, he was called to the Gospel ministry and in the year 1905 was licensed to preach by Spring Hill Baptist Church. He was ordained four years later in 1909 by the ordaining council of the Cape Fear Conference at the home of Lundy Lee. Members of the council were Rev. J. F. Hill, Bob Strickland and Lundy Lee.

Bro. "Doc." Ennis was married January 4, 1893 to the former Miss Alice M. Byrd at Dunn, N. C. Born to this union were seven children—four boys and three girls.

He pastored Savana Hill Free Will Baptist Church (1909-1910), Lee's Chapel Free Will Baptist Church (1910-1924), Roberts Grove, Oak Grove and Corinth Free Will Baptist Churches in Sampson County, Prospect Free Will Baptist Church and other Free Will Baptist Churches in Harnett, Johnston and Wake Counties.

For a number of years he served as a member of the ordaining council and was a strong promoter of the Orphanage, Press, Ayden Seminary and Eureka College.

Rev. W. G. Ennis, a Free Will Baptist preacher, was his nephew. Rev. J. L. Ennis, a Baptist minister, was his brother.

Bro. Ennis retired about 1930 and went to be with the Lord on January 17, 1939. His body was buried in the Prospect Church Cemetery, Harnett County, N. C.

Thank God for giving to the church this pastor (Eph. 4:11).
