THURSDAY MORNING SESSION

The session was opened with lively singing led by Brother Ron Christ. For Devotional thoughts Brother Chester Phillips, pastor of Grace Church in Greenville read from I Timothy 1:12 and then prayed God's blessings upon us and the Lord's leadership during this two day session.

Welcome to this session and to the Tippetts Chapel Church was offered by Brother Kenneth Lee of the Host Church.

Brother Herman Hersey, pastor of Garner Church in Garner was elected Moderator for the two day session. He appointed Bobby Jackson, full-time Evangelist as assistant to the Moderator for the first day.

The minutes of the One-Hundred-Forty-Third Annual Session of November 4th and 5th, 1965 while convening at the White Oak Hill church of Bailey, N. C. were read and approved.

The following Digest Committee was appointed by the Moderator: Raymond Gaskins, Ralph Barnes and Ronald Creech.

A motion was made and passed that an attempt be made to get a communication from the Union Grove Church of Durham. If no response is received or they wish to be dropped from our roll of churches this church is to be dropped from our roll of churches.

The following Resolutions Committee was appointed by the Moderator: Chester Phillips, L. F. West and Gordon Sebastian.

Business was dispensed with in order to have the morning preaching service.

Brother Ron Christ opened the service by leading us in the hymn "Count Your Blessings" while Brother Bobby Jackson presided over the service. Brother Wayne Smith led in prayer. Brother Jackson led us in a responsive reading called "Missions". An offering was received in the amount of \$32.03.

Before Brother Jackson sang a solo entitled "Don't Take Your Eyes Off the Saviour" he introduced Brother Bobby Aycock, Missionary to Brazil, South America as the speaker for the preaching service.

Brother Aycock gave greetings from Brazil and expressed his happiness in being in this session of the General Conference . . . For the message he took his text from Matthew 16:24-27 and preached a very stirring and Spirit filled message on "The Cost of Discipleship".

He discussed the cost of Discipleship:

- I. As Relates to Dedication and Consecration.
- II. As Relates to Soul-Winning.
- III. As Relates to Making Disciples.

In closing the service and adjourning for lunch Brother Ron Christ led us in the hymn "There Is Power In The Blood".

THURSDAY AFTERNOON SESSION

The afternoon session was opened by singing the hymn "At The Cross" led by Brother Ron Christ. Brother Raymond Gaskins gave devotional thoughts from I Cor. 1:17, 29 and I Cor. 2:4,5 on the subject of "The Simplicity of the Gospel". Brother Gaskins closed his thoughts by prayer.

Brother Rufus Coffee, Director of Conference Ministeries gave greetings from the Missionaries and our total mission work. He emphasized our support of the total program as well as the missionaries' needs and "Project 5,000".

Brother Fred Hersey, Missionary to Japan and on his second furlough gave greetings from Japan and appreciation for prayers and support.

The following Partial Report was given by the Membership Committee:

- (1) We recommend accepting the action of the clerk in granting a letter of good standing for Brother Bobby Carden to the West Central Quarterly of the Illinois State Association and Ronald Niebruegge to the Cumberland Association of Tennessee.
- (2) We recommend for membership the Victory Free Will Baptist Church of Goldsboro, North Carolina.
- (3) We recommend for membership the Reverend Bobby Aycock to the roll of preachers.

- (4) We recommend that a letter of recommendation be issued to Rev. J. V. Johnson from the General Conference to the Coastal Association.
- (5) We recommend that a letter of recommendation be issued to Rev. Johnny Vernelson from the General Conference to the Northeastern Union Meeting of the Coastal Association.

This report was adopted with the exception of the part referring to the Victory Free Will Baptist Church.

The Moderator extended the right hand of fellowship on behalf of the General Conference to the Reverend Bobby Aycock.

Brother Frank Davenport, a member of the National Home Mission Board, gave a report of the Home Missions Work and emphasized our support of project "Operation Layman" in which laymen will go with a preacher to start new churches in North America.

Brother Frank Davenport made a motion which was passed that during the Friday session we consider the dissolving of the General Conference to form conferences of the Union meetings. At the suggestion of Brother L. R. Ennis, preliminary steps, adoption of the National Treaties and a constitution and by-laws was included in this motion for consideration. Among many, many other things, he mentioned that the Holy Spirit must go to work, we must stay sweet, and we must keep liberty. He closed with a thought of "whatever we do, lets do it with all our might." God's blessings were real as the Holy Spirit spoke to our hearts.

FREE WILL BAPTIST BIBLE COLLEGE

Report To

ORIGINAL FREE WILL BAPTIST OF THE GENERAL CONFERENCE OF NORTH CAROLINA

North Carolina continues to lead all states in giving to both the general fund and the building fund of our Bible College. Paul Ketteman, Director of Public Relations in charge of raising the general fund monies, reports that during the period of June 1 and September 30 a total of \$6,459.72 has been given by the various churches of North Carolina. This represents 34% of your quota of \$19,500 which is on schedule since just 1/3 of the fiscal year has transpired.

Jack Paramore, Campaign Director for the Development Program, reports that a total of \$18,052.07 has been given to the building fund through September 30 with an additional \$17,685 having been committed. For this excellent support the college family expresses deep gratitude to the faithful friends of this state. Eight (8) individuals have given \$1000 gifts so far and several are committed to do so within a few months. In addition four churches have made gifts of at least \$1000.

Enrollment for the 1966-67 school year is at an all time high with 339 enrolled in regular day classes, a 24% increase over a year ago. Of this number 47 are from North Carolina exceeded only by Tennessee which registers 51. Thirty states and three countries are represented, Evening schools add 30 to the total, summer school 28 for an aggregate total of 397. More than 225 of these live on campus again taxing our dormitory facilities and pointing up the critical need for the current Development Program.

As the churches and individuals of the General Conference have done in the past they are urged to get behind our Bible College in this all out effort to raise sufficient funds for expansion.

Present plans are to continue the promotion of the One Thousand Laymen Campaign, a concerted effort to find 1,000 individuals to give at least \$1,000 to the Development Program. However in January of next year, 1967, the One Thousand Church Campaign will be launched. As the Laymen Campaign seeks to enlist support from individuals, the Church Campaign will appeal to churches to raise at least \$1,000 within a 12 month period. Dr. L. C. Johnson, Dr. Robert E. Picirilli, and Dean Charles Thigpen along with Campaign Director Jack Paramore will be available for local church services whenever the Pastor feels their services would mean success for his local church drive which otherwise could not succeed. Though they will not be able to visit every church in the denomination, they will hold services in hundreds during the campaign.

Local churches are urged to begin now to make plans for a special drive early in the coming year to insure the success of this overwhelming project.
