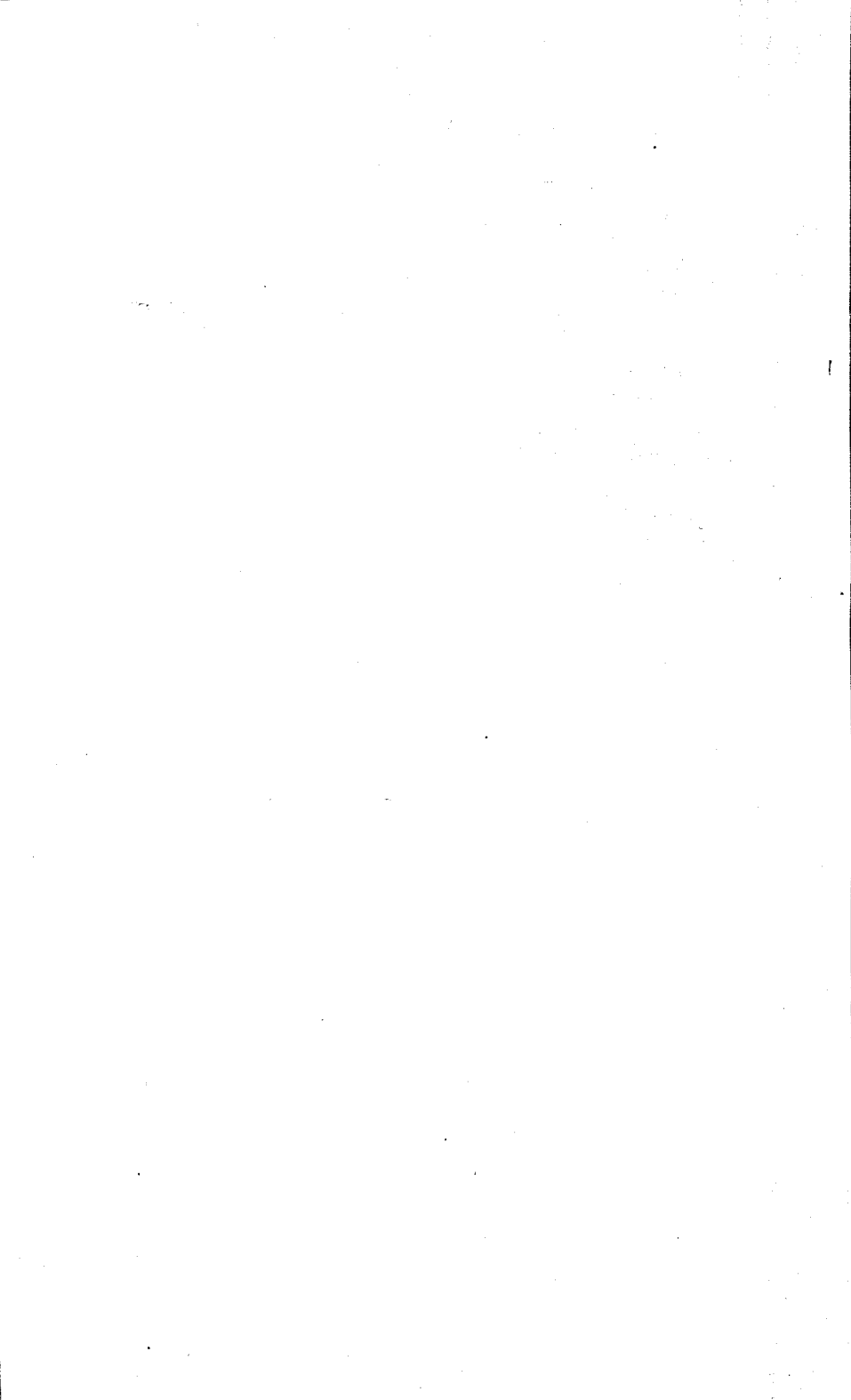

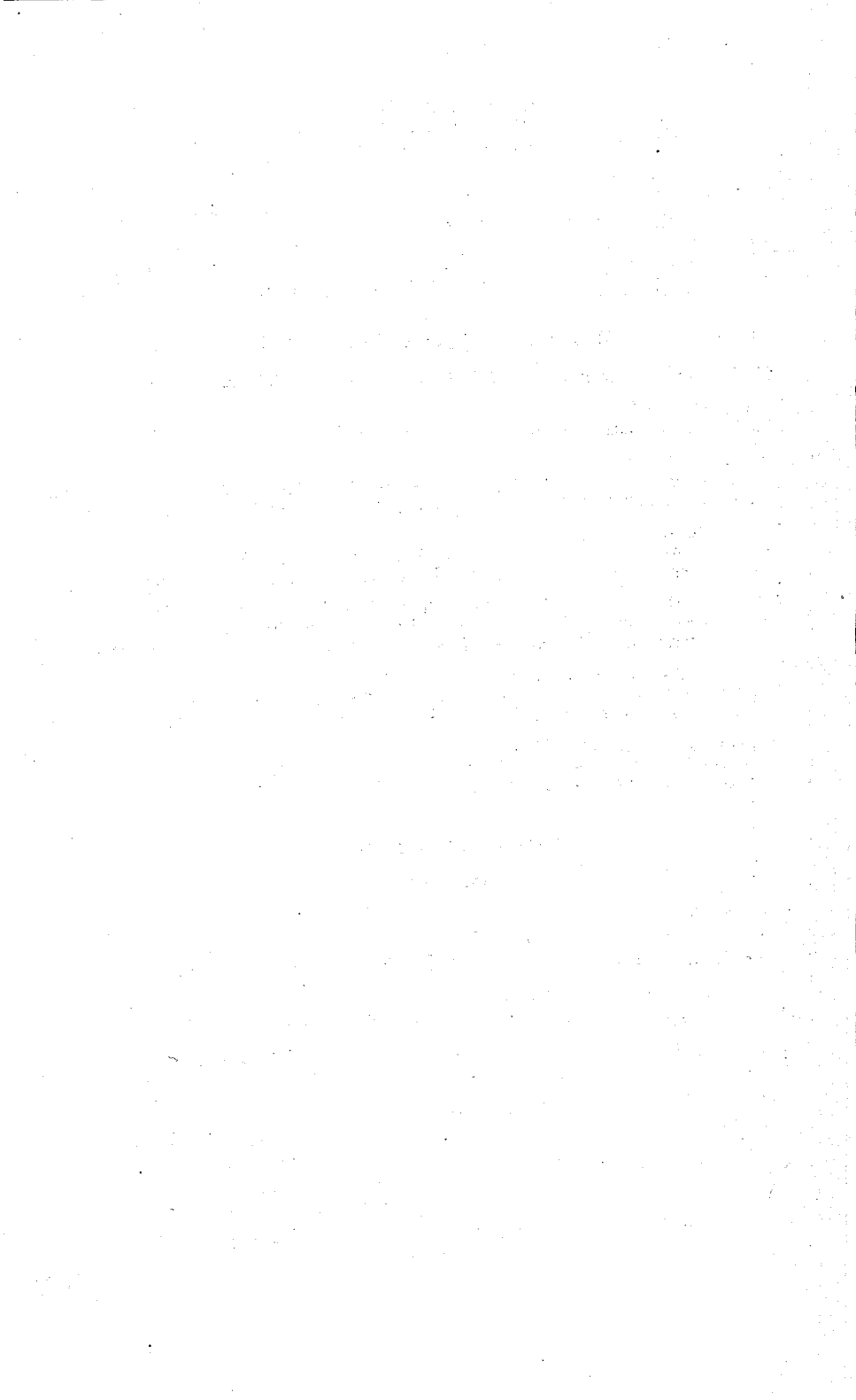

THURSDAY MORNING SESSION

The session was opened with lively singing led by Brother Fred Hall. Brother Ronald Creech prayed the opening prayer of this session. For Devotional thoughts Brother Tom Lilly, pastor of the West Calvary Church in Smithfield read from Matt. 9:27-31 and spoke on the subject of "Faith". He ended his remarks with prayer.

Welcome to this session and to the Shady Grove Church was offered by Brother Elbert Clayton, a deacon in the Host Church.

Brother Billy B. Walker, pastor of the First Church in Raleigh was elected Moderator for the two day session.

The minutes of the Friday session of The-One-Hundred-Forty-Fourth Annual Session of November 3, 4, 1966 while convening at the Tippetts Chapel Church, Clayton, N. C. were read and approved as read.

The Moderator appointed Brother Wayne Smith, pastor of the Brookwood Church, Fayetteville, N. C. as Assistant Moderator.

The roll call of Preachers showed 24 out of 63 present which were the following:

The following Finance Committee was appointed by the Moderator: Nathan Eason, J. W. Long, Jr., and L. D. Creech.

The following Digest Committee was appointed by the Moderator: Al Davis, A. C. Morgan, James Denton.

The roll call of the churches on this first day showed 22 out of 36 representing by letter. They were as follows:

Antioch, Pikeville; Bethel, Kinston; Brookwood, Fayetteville; Calvary, Durham; Community Chapel, Buies Creek; Corinth, Dunn; Faith, Goldsboro; Fellowship, Durham; Fellowship, Micro; First, Greensboro; First, Raleigh; Grifton, Grifton; Hope, Scotland Neck; Joy, Tarboro; Liberty, Durham; Prospect, Dunn; Saint's Delight, Louisburg; Shady Grove, Durham; Trinity, La-Grange; Unity, Smithfield; West Calvary, Smithfield; White Oak Hill, Bailey; Oak Grove, Durham and Tippetts Chapel, Clayton represented by delegate only. Their church letter will follow.

A motion was made and passed that all of these preachers and delegates be seated during this session.

The following Resolution Committee was appointed by the Moderator: Lonnie Graves, Lloyd Williford, L. R. Ennis.

The following Partial Report was given by the Membership Committee:
We recommend:

- (1) That the following six (6) Ordained Preachers be received into full fellowship in this Conference: Brothers Robert J. Durham, James R. Cooley, L. B. Coley, Joseph G. Ange, Fred Hall, and Dean Dobbs.
- (2) That the following two (2) Ordained Preachers be received into full fellowship in this Conference upon official receipt of a letter requesting such by the local church of which they are a member. Rev. Joe Dan Underwood, Rev. Tom Lilly.
- (3) That the following four (4) churches be received into full fellowship in this conference: St. John Church at Goldsboro, Hilltop Church at Fuquay, First Church at Roxboro and Grace Church at Rocky Mount.
- (4) That the body act on the following past recommendation from the minutes of November 3 and 4, 1966:

"A motion was made and passed that since the Victory Free Will Baptist Church of Goldsboro, N. C. wishes to unite with our fellowship but has no delegation at this session, be put under watchcare for one year and during this time the Faith Free Will Baptist Church in Goldsboro and this Victory Free Will Baptist Church work out their differences."

Each item was considered separately. A motion was made and passed that item No. 1 be adopted. The right hand of fellowship was extended by the Moderator.

A motion was made and passed that item No. 2 be adopted. The right hand of fellowship was extended by the Moderator.

A motion was made and passed that item No. 3 be adopted. The right hand of fellowship was extended by the Moderator.

The Moderator declared that we dispense with the business in order to have the preaching service and that item No. 4 of the membership committee's report be considered immediately after lunch.

With Brother Billy Walker presiding Brother Fred Hall led the congregation in singing the hymn "Stand Up For Jesus". An offering of \$45.93 was received. The special music was rendered by a trio consisting of Brothers Fred Hall, Dean Dobbs and Ronnie Peele. The title of the song was "Hallelujah What A Saviour".

The Moderator introduced the speaker for the morning message which was Brother Joseph G. Ange, pastor of the Liberty Free Will Baptist Church of Durham, N. C. He preached on the subject of "How To Have An Evangelistic Church" as recorded in the second chapter of the "The Book Of The Acts".

He said that there were three essentials of a church service: The Speaker, The Sermon and The Sequel. The speaker was Peter—Saved from sin, Sold out to Jesus and Filled with the Spirit. The Sermon was about Jesus and in an Evangelistic Church it must always be in order to get the right Sequel or Results: Conviction, Contrition, Conversion and Continuation. Brother Joe closed this tremendous message by prayer. The session was dismissed for lunch.

THURSDAY AFTERNOON SESSION

The afternoon session was opened by singing the hymn "Rise Up Oh Men of God" led by Brother Fred Hall. Brother Al Davis led in prayer.

Brother Lonnie F. West pastor, Community Chapel Free Will Baptist Church, Buies Creek, N. C. brought Devotional thoughts concerning "The Sacrifice of the Apostle Paul" from Romans 12:1.

The following visitors were recognized: Brother Carey Watkins, pastor from the Blue Ridge Association and Brother Ray Turnage, Field Director for the Free Will Baptist Children's Home, Greenville, Tennessee.

A motion was made and passed that item No. 4 of the Partial Report of the membership committee be adopted.

After a brief discussion Brother L. R. Ennis made a motion which was duly seconded and passed that the Victory Free Will Baptist Church of Goldsboro, North Carolina be and is this date received as a full fledged member of the General Conference.

Brother Ronnie Peele, Pastor of the Victory church gave a report of the blessings and progress of this new church. Four of the male delegates from this church Brothers Archie Rose, Donald Walker, Amos Edwards and Macellus Harrison gave their personal testimony of salvation.

The right hand of fellowship was extended to the Victory church and its delegates by the Moderator.

A motion was made and passed to recind the following statement from the minutes of the Friday afternoon session November 4, 1966 while convening with the Tippetts Chapel Church near Clayton: Item No. 2 of the report of the membership committee from "and that during this time the Faith Free Will Baptist church in Goldsboro and this Victory Free Will Baptist Church work out their differences."

Brother Ray Turnage, the Field Director from the Free Will Baptist Children's Home, Greenville, Tennessee spoke in behalf of the home. He expressed the importance, worthiness and need of prayer and financial support. The following facts were given concerning the home.

At the present time the home supports children from six (6) states and eight (8) counties of Tennessee. There are 71 children ranging in ages from 5 to 19 years. One of these is from Jacksonville, North Carolina. The home began in 1938 but officially opened in May of 1939 The home consists of 400 acres including 200 acres of farming, eleven buildings and a grade "A" dairy. The cost per child is \$1300. per year. This compared with \$2300. cost in other

homes. Mr. Turnage stated that training is their greatest task. We were urged to come to see the home, the workers and the children.

Questions were asked concerning such things as new buildings, source of support, admission and intergration.

The session was adjourned until Friday morning.

FRIDAY MORNING SESSION

The session was opened by singing the hymn "Onward Christian Soldiers" led by Brother Ronnie Peele. Prayer was offered by Brother Wayne Smith. For devotional thoughts Brother Edwin Hill, pastor of the Grifton Free Will Baptist Church, Grifton, North Carolina read I John 4:5 and expressed the need for more love for God and one another.

There were no new ministers, churches or visitors representing during the Friday morning session.

A motion was made and passed that the moderator appoint a committee to look into steps which need to be made for the betterment of this General Conference and that they report during this session.

Appointed were Brothers Joe Ange, Ed Hill, Ronnie Peele, Charles Keith and Wayne Phillips.

A motion was made and passed that 300 copies of the minutes be printed.

According to motion the delegates to the North Carolina State Association which convenes May 7th and 8th, 1968 at Parker's Chapel Free Will Baptist Church, Greenville, North Carolina are to be appointed by the moderator.

A motion was made and passed that late letters and reports be included in the printed minutes.

A motion was made and passed that the election of officers be presented by the previously appointed committee on the betterment of the General Conference and that the present moderator and assistant moderator also serve on this committee.

Business was dispensed with in order to have the preaching service.

Brother Ronnie Peele led in singing "'Tis so Sweet To Trust in Jesus." Prayer before the offering was led by Brother L. D. Creech, Jr. The offering amounted to \$12.43. The next song "We'll Work Till Jesus Comes" was also led by Brother Peele. Special music was rendered by Brother Fred Hall entitled "The Name of Jesus".

Brother Billy Walker introduced the speaker who was Brother Wayne Smith, pastor of Brockwood Free Will Baptist Church, Fayetteville, North Carolina. He chose Genesis 30:25-27 as his text and "Some Things I Have Learned By Experience" as his subject. He emphasized the following things.

- I. The Deceitfulness of Sin.
- II. The Vanity of This World
- III. The Goodness of God
- IV. That Tribulation worketh Patience
- V. The Grace of God In Suffering
- VI. That We Have a Mighty Saviour

FRIDAY AFTERNOON SESSION

After a song by the congregation Brother Billy Walker, the moderator presented devotional thoughts in preparation for the afternoon session.

A motion was made and passed that the following final report of the membership committee be adopted.

(1) Whereas, it is the policy of this conference to receive into its membership only those preachers who are members of churches in our conference, and to retain on its roll of preachers the same, and

Whereas, the following preachers are pastoring out of the state of North Carolina and are not members of a church in the General Conference:

J. A. Branch, Luther Burns, Sigbee Dilda, B. M. Duke, James Duke, Owen Ganey, Mack Humbles, Paul Lee, Bill McClintock, Guy Owens, Bobby Abrams, Ashley Garris, Maylon Brooks Phleps, H. C. Price.

Therefore, be it resolved that these ordained and licensed preachers be dropped from our roll of preachers.

(2) Resolved that Conny Parker of Prospect Free Will Baptist Church be received as a licensed preacher pending a letter from the church requesting the same.

(3) Resolved that the clerk's action in granting letters of transfer to the following preachers be approved: Thurman Hall, Wingate Hansley, Roger Russell, Carey Watkins and Jack Paramore.

The following report and recommendations from the special committee on betterment of the General Conference were presented item by item.

We make the following recommendations:

1. We recommend that the conference retain this committee through the next year and that this committee be called a study committee, to study rules of fellowship, regulations, constitution and by-laws, and conference policy, and make recommendations at our next annual meeting.

2. We recommend that the next annual conference meet on Friday morning, November 8, 1968, beginning at 9:00 A. M. and concluding with an evening service on Friday night.

3. We recommend that the conference elect a moderator at this session for the next session and that his service terminate at end of next session.

4. We recommend that the moderator, clerk and host pastor make up the program committee for next year's program.

5. We recommend that the conference go to the Victory F.W.B. Church next session.

6. We place before the conference the following resolution.

Whereas, the attendance in recent years has decreased and, Whereas, it has been hard to arouse the interest of our preachers and tence. Be it resolved that the conference elect 3 persons who will serve tence. Be it resolved tha tthe conference elect 3 persons who will serve as Publicity Committee, to arouse interest in and promote attendance at the next session.

A. Whereas, the trends of our time are having their effect upon our young people and leading them into unwholesome moral standards and carnal philosophy of life, and

Whereas, the entertainment world has been most instrumental in this area, and

Whereas, the entertainment world under the guise of "Christian" is using carnal and fleshy devices such as hippie and beatnik type dress and appearance, rebellious gestures against nature, nation and God, entertainment for sexual arousalment and music and tempo with the definite African beat and others to lure our young people into active participation, and

Whereas, among all places the right example of Bible Christianity with the highest of moral standards, modest dress and Christ-like philosophy should be on the National level,

BE IT RESOLVED:

- (1) That the General Conference of Free Will Baptists go on record as having voiced its disapproval as to the questionable type entertainment provided the young people at the National Association in Jacksonville, Florida, 1967.
- (2) That we request the National Church Training Service (CTS) Board and its Department leaders to hereafter provide wholesome entertainment and entertainers with a higher philosophy of life, dress and Christian standard.

B. Whereas, the Jehovah's Witnesses, Seven Day Adventists and other cults are increasing their efforts to lead our people away into their organizations,

Be It Resolved, that we warn our people against them as a cult and encourage our people to be alert to their work. Furthermore,

Be It Resolved, that we encourage our people not to allow them to enter their homes to discuss and spread their doctrines.

C. That by a rising vote of thanks we show our appreciation to the Shady Grove Free Will Baptist Church of Durham and the Immanuel Free Will Baptist Church of Durham for their fine hospitality during this 1967 session of the General Conference.
