PROCEEDINGS

The eleventh annual session of the Mt. Mitchell Free Will Baptist Association convened with the Terrys Fork Church, Route 2, Mars Hill, North Carolina, Thursday, August 25, 1966, at 10:30 a.m. Service began with the choir singing "Where Milk and Honey Flows" and "I Have Somebody With Me". Sister Cathy Austin sang "I Need the Prayers of Those I Love". Opening remarks by pastor of church, Brother Cassie Thomas. An altar prayer was led by Sister Frances Radford. Brother Charlie Miller read I. Corinthians 6:17, using for his text, "Our Union With God". The message was wonderful with great manifestation of the Spirit of God. While the congregation sang "Heaven's Jubilee" there was a Christian handshake with much fellowship. Good testimonies by Brothers Roosevelt Briggs, Roscoe Briggs, Sam Moore, T. E. Woody; Sisters Frances Hughes, Josephine Blevins, Sylvia Anderson. Closing remarks by Sister Frances Radford, dismissing us for lunch.

THURSDAY AFTERNOON SESSION

Reconvened at 1:30 p.m. for business. Service began with the choir singing "Just a Little Talk With Jesus". Devotional conducted by Brother Roy Whitson, reading I. Peter 2:21-25. Prayer led by Brother Charlie Miller.

The Moderator, Brother T. E. Woody, welcomed to our Association Brother and Sister Harold Stevens and daughter, our missionaries to Zululand, South Africa.

Proceeded with business. Appointed Sister Frances Radford and Brother Joe Woody as reading clerks. Moved to retain the committees appointed in last year's Association as follows:

Service given to Brother and Sister Stevens. Introductory remarks given by Brother Harold. Little Rebecca sang and made a speech in the Zulu language. Josephine explained many parts of the mission work. Her talk was so interesting and stirring.

Appointed Sister Vinita Deyton to preach at the Friday morning service.

An altar prayer for the many objects presented was led by Sister Josephine Blevins. We were dismissed to meet at the 7:30 p.m. worship service.

THURSDAY NIGHT SERVICE

The 7:30 p.m. worship service began with the choir singing "Alone in the Garden" and "Because of Him". Brother Rothy Ogle sang "Glorified Body" and "Happy Reunion". Opening remarks by Sister Frances Radford. Prayer was led by Brother Charlie Miller.

Brother Harold Stevens showed the slides of their work in Zululand, South Africa. He then read Romans 10:8-13 and

Matthew 28:19, 20. The message of his experiences and the need of the world was soul-stirring and challenging. An offering amounting to \$42.00 was received for Brother and Sister Stevens. We were dismissed by Brother Cassie Thomas to meet at 10:00 a.m. Friday.

FRIDAY MORNING SESSION

Service convened at 10:00 a.m. The choir sang "We'll Soon Be Done With Troubles and Trials" and "I'll Be a Friend to Jesus". Devotional conducted by Brother William Dale Robinson, reading St. John 4:1-14. Prayer was led by Brother Cassie Thomas.

Business session called to order by Moderator. Minutes of vesterday's session read and adopted.

Sister Josephine Blevins, present Treasurer of the Aged and Disabled Ministers' Fund, presented her request that another Treasurer be elected due to her being handicapped in carrying on the work of this office. Brother Cassie Thomas was elected by vote of the body to be Treasurer of the Aged and Disabled Ministers' Fund

Called for unfinished business. None presented.

Called for visiting ministers. None present.

Report of Committee on Missions called for. Read by Sister Frances Radford. Discussed by Sisters Radford, Vinita Deyton, Josephine Blevins, Opal Blankenship; Brother T. E. Woody, Cassie Thomas.

It was moved by Sister Radford that the churches of the Association raise the amount of \$300.00 to build a dormitory building at the Mission School in Mexico and to call the building the "Dad Woody Building". It was voted by the Association to raise the money by the end of this year. The amount of \$50.00 was pledged by Sister Opal Blankenship for the Prices Creek Church.

Discussion closed for the worship service. Later received and adopted.

WORSHIP SERVICE 11:00 A.M.

Worship service began with the choir singing "Glory to His Name". Sister Vinita Deyton read I. Thessalonians 5:23, using for her text "Satan's Target: The Christian's Body, Soul, and Spirit". While the congregation sang "Amazing Grace" there was a Christian handshake with much rejoicing in the Spirit. We were dismissed by Brother T. E. Woody for lunch.

FRIDAY AFTERNOON SESSION

Reconvened at 1:30 p.m. for business. Devotional conducted by Sister Frances Radford, reading Hebrews 6:1-12. Prayer was led by Brother Roscoe Briggs.

Business called to order. Report of Committee on Education called for. Read by Sister Josephine Blevins. Discussed by Sisters Blevins, Vinita Deyton, Opal Blankenship, Frances Radford and Brother Cassie Thomas. Received and adopted.

Report of Committee on Sabbath Schools called for. Read by Brother Roy Whitson. Discussed by Brothers Whitson, Levi Deyton. The poem written by Sister Loyce Deyton for her class was read by Sister Frances Radford. Moved to print poem in minutes. Received and adopted.

Report of Committee on Churches and Pastors called for. Report retained from last year. Report read by Brother Cassie Thomas. Discussed by Brothers Thomas, Roscoe Briggs. Received and adopted.

Appointed Brother Roscoe Briggs to preach at the 7:30 p.m. service, Brother Arnold Briggs at the 11:00 a.m. Saturday service. Dismissed by Sister Frances Radford to meet at 7:30 p.m.

FRIDAY NIGHT SERVICE

The 7:30 p.m. worship service began with the choir singing "I Want My Lord to be Satisfied With Me". The Phil Anderson Family sang "At Calvery" and "Because of Him". Opening remarks by Brother Cassie Thomas. An altar prayer was led by Sister Josephine Blevins. She afterwards sang "There's Room For Me". Brother Roscoe Briggs read Romans 10:9-11; 11:1, preaching on the subject "The Power of Living the Bible". His message was full of great truth and very needful. There was a Christian handshake while the congregation sang. After several good testimonies we were dismissed by Brother Charlie Miller to meet at 9:30 Saturday morning for business.

SATURDAY MORNING SERVICE

Service convened at 9:30 a.m. The choir sang "What a Day That Will Be". Opening remarks by Moderator. Prayerled by Sister Frances Radford.

Proceeded with business. Called for visiting ministers. Brother Charles Webb was welcomed by vote to a seat in our body.

Minutes of yesterday's session read and adopted.

Report of Committee on Aged and Disabled Ministers' Fund called for. Report retained from last year. Read, received, and adopted.

Report of Committee on Temperance called for. Read by Sister Lucy Deyton. Received and adopted.

Report of Committee on Deeper Devotion called for. Read by Sister Opal Blankenship. Discussed by Sisters Blankenship, Josephine Blevins, and Brother Cassie Thomas. Received and adopted.

Report of Committee on Investigation called for. No report was given.

Report of Committee on Care for Aged and Children called for. Read by Sister Bonnie Brinkley. Discussed by Sisters Brinkley, Josephine Blevins, Brother Joe Woody. Received and adopted.

Report of Committee on Sessions called for. It was voted by the body that the clerk be authorized to make a list of Association sessions apart from the Conference sessions to be printed in the Minutes.

Report of Committee on Lord's Acre Work called for. Read by Sister Vinita Deyton in the absence of the chairman of the committee. Discussed by Sister Frances Radford, Brother T. E. Woody. Received and adopted.

It was moved that each church receive an offering to help Sister Josephine Blevins pay the expenses of Brother Blevins' funeral.

Fervent thanks were expressed to the Terrys Fork Church for the wonderful care of the Association. The care the church gave was outstanding.

Adjourned with prayer until we meet with the Green Mountain Church on Thursday before the Fourth Sunday in August of 1967; Sister Edith Pauley to preach the introductory message; Brother William Dale Robinson to be the alternate speaker.

We were given a recess before preaching at 11:00 o'clock by Brother Arnold Briggs.

WORSHIP SERVICE 11:00 A.M.

Assembled at 11:00 a.m. for worship. The choir sang "What A Day That Will Be". Brother Arnold Briggs read St. Luke 14:16-24, after which he led us in prayer. On the subject, "An Excuse", he brought a wonderful, truth-filled message. There was a great outpouring of the Spirit. There was much spirit of fellowship as the congregation shook hands. We were dismissed for lunch by Brother Charlie Miller.

COMMITTEE REPORTS

MISSIONS

We, your Committee on Missions respectfully submit the following Scriptures for prayerful consideration by our body:

St. John 3:16 and 14:21-24 St. Mark 16:14-16 Romans 10:9-15

We believe that these Scriptures--only a few of dozens on the same theme--represent the very heart-throb of our Heavenly Father, and that we cannot be true Christians if we do not support with all our hearts world-wide mission outreach.

We praise the Lord for the vision He has awakened among our people, but we feel we need to be more deeply stirred to reach earth's unreached billions who have never once heard the Gospel (approximately two-thirds of the world's population). To this end, we recommend:

(1) That our pastors seek to stir our people to greater interest, labor, and prayers, and lead their people in regular financial support of our missionaries. We believe each church should have a definite plan-either by individual pledges, monthly special offerings, or tithing of all church offerings, whichever is the leading of the Lord in each church.

PASTORS & CHURCHES

We, your Committee on Churches and Pastors prayerfully and humbly submit the following observations and recommendations:

First, to the churches: Be prayerful and careful in the selection of a pastor, for not every good preacher is a good pastor ... See I Cor. 14:18, 28 and Ephesians 4:11-13. Pastors should never be chosen on the basis of "I like Bro. So and So. Let's get him for pastor next year..." The church is not at liberty to choose the man of God like going to the store and picking out a shirt or dress from the many displayed in the window... The Holy Spirit must be allowed to place the members in the body as "it hath pleased Him" if the church is to prosper, and if the church, with its leaders, will pray and submit to the Lord's will, He will direct, and there will be unity in the selection of a pastor. We recommend that our churches prayerfully agree upon their pastor each year not later than the last of July, so that both church and pastor will have ample time to consider the will of the Lord before the beginning of a new Associational year....We further recommend that our churches recognize their responsibility for the support of their pastor and His family on an equality with--neither above nor below--the average living standard of the families of the church. We applaud the willingness of our pastors, like Paul, to labor with their hands that they may make the Gospel of Christ without charge, but we do not believe that this is God's perfect

will, for I Corinthians 9:14 tells us that—"God hath ordained that they which preach the Gospel shall live of the Gospel", and we believe the church which by-passes God's ordained plan will suffer. If only ten families in a church tithe, then the pastor will be supported on a level with the rest of the church. If all families tithe, not only will the pastor be supported, but all the phases of the work of the church can be carried on without stint.

Second, to the ministry: A pastor is a servant, and an example to the flock; not a lord over God's heritage. We believe he should recognize this truth, and lead, not drive, the church. We believe he should devote Himself to the care of the souls of the flock, giving as much time as possible to prayer, Bible study, visitation, and such like. (We do not believe that the church should leave all the visitation for the pastor, however; for seeing to the material needs of the flock was the original purpose of the ordination of deacons.)

To both pastors and other preachers, we urge an application of Proverbs 24:27: 'Prepare thy work without, and make it fit for thyself in the field; and afterwards build thy house." Jesus said, "The field is the world..." Our older ministers, filled with holy zeal, saw the need of churches being established where no church was. They conducted revivals in homes, old store buildings, brush arbors, or wherever else they could. God blessed, souls were saved, and afterwards "they built their house"... If some of our older ministers had not sacrificed to grub the spiritual new-grounds of our religion, to "work the field," we would not have the organized churches and established groups that we have. Brethren, we must grow or die! We therefore urge strongly that all our Brother ministers not actively serving as full time pastor seek the Lord to find out where He would have them labor "in the field," and that the churches and pastors rally to the help of any who are led of God to clear a new-ground and establish a church.

CONSTITUTION OF MOUNT MITCHELL FREE WILL BAPTIST ASSOCIATION

ARTICLE 1

This Association shall be known as the Mount Mitchell Association of the Original Free Will Baptists of North Carolina.

ARTICLE 2

The objects of this Association shall be; to proclaim a full salvation and lift up a standard of holy living in accordance with the teaching of the Bible; to promote unity, fraternity, fellowship and cooperation within the bounds of our own churches, and Christian charity toward all Christians; to encourage and engage in larger Christian enterprises than can be carried on by one church; to combine and direct the energies of the Free Will Baptists within its bounds in one sacred effort to encourage and promote the general spread of the Gospel, and all of its benevolent enterprises.

ARTICLE 3

- 1. This Association shall be composed of all licensed and ordained ministers, and of delegates chosen and sent by each church within its bounds, said delegates being duly recommended by letter from the church to which they belong.
- 2. Each church, irrespective of size, shall be entitled to five (5) delegates, with an additional delegate for every ten (10) members or fraction thereof above fifty (50). Each church is expected to defray the expenses of the Association and the causes which it fosters.
- 3. The Association disclaims the right to exercise lordship over the churches, or to have any power which entitles it to infringe upon internal affairs or rights of any of the churches composing it. Each church shall consider its internal affairs to be its own business, but it shall not disrespect the Association and those placed in authority by the proper processes.

ARTICLE 4

The Association may withdraw from any church that becomes

disorderly or refuses to be represented by letter or delegation, providing, however, that any church accused of disorderly walk or unscriptural doctrine shall have the same rights as an individual in the church to have specific charges presented in writing, together with convincing evidence; a fair opportunity for defense and to be considered innocent until proven guilty.

ARTICLE 5

This Association shall make use of the Treatise of the Faith and Practices of Free Will Baptists adopted by the National Association November 7, 1935 at Nashville, Tennessee; recognizing however, the truth stated therein; that the Scriptures of the Old and New Testaments were given by inspiration of God, and are our only infallible rule of faith and practice.

ARTICLE 6

Churches coming from another denomination will be carefully examined and approved as to doctrine and practice before being received as members.

ARTICLE 7

- 1. The officers of this Association shall be Moderator and Assistant Moderator, Clerk, Treasurer and Historian, all of whom shall be elected for a term of two years, except the Moderator and Assistant Moderator, who shall be elected annually. They shall enter upon the duties of their offices at the close of the current season.
- 2. It shall be the duty of the Moderator to preside over all the meetings of the Association.
- 3. It shall be the duty of the Assistant Moderator to preside in the absence of the Moderator.
- 4. It shall be the duty of the Clerk to keep a faithful record of the proceedings of the Association in a business-like manner, to superintend printing and distribution of the minutes, and to give over all properties belonging to his or her office to his or her duly elected successor.

- 5. The Clerk shall be paid a fee to be determined by the Association. Minutes of the Association shall be sent to all visiting Free Will Baptist Ministers.
- 6. It shall be the duty of the Treasurer to receive all funds belonging to the Association, and to disburse same as directed by the Association. The Treasurer shall be bonded for an amount sufficient to cover all the funds for which he is responsible.
- 7. It shall be the duty of the Historian to keep a record of such items of interest as may be useful in the future, especially a file of all the minutes, and to preserve the same in a book. He or she shall also be required to give over all properties of the office to the successor to the office.

ARTICLE 8

The Association shall appoint annually such committees as it shall deem necessary to expedite its business. These committees may be called upon to serve in either a temporary or standing capacity. Temporary committees complete their work and make a report of it during the same session in which they are appointed. Standing committees are appointed to assist in such matters as may require service both during and between sessions. The Moderator is empowered to choose the Chairman of each Committee, and the delegates may assist in choosing other members of said committees from among their own ranks.

ARTICLE 9

The Executive Board of this Association shall consist of the Moderator, Assistant Moderator, Clerk, Treasurer, Historian and three (3) members elected from the floor. It shall be the duty of the Executive Board to have the supervision of the work of the Association between sessions. The Moderator and Clerk, by virtue of their respective offices, shall be Chairman and Secretary, respectively, of the Executive Board.

ARTICLE 10

It shall be the duty of this Association to encourage a sound ministry, such as present Christ as an all-sufficient Saviour, having made salvation possible to every human being on the terms of the Gospel, which is freely offered to all.

ARTICLE 11

A Church may become a member of this Association by making request by delegation, which delegation shall present a letter showing vital statistics of said church, providing however, that such church shall be examined as to doctrine, practice and willingness to abide by the Constitution and Bylaws of this Association.

ARTICLE 12

The Bylaws of this Constitution shall be read annually immediately after the body is organized.

ARTICLE 13

This Association advises all its churchs to commemorate the death and sufferings of our Lord at least twice a year, with the service of feet-washing to follow the communion.

ARTICLE 14

The Association shall meet annually on Thursday before the fourth Sunday in September for the purpose of worship and the transaction of business. There shall be no less than two (2) worship services daily while the Association is in session.

ARTICLE 15

This Association's printed Minutes shall consist of a record of all business transacted and all worship services during the annual meeting, the proceedings of the quarterly sessions of Conference, the Constitution and Bylaws of the Association and the Constitution and Bylaws of the Ministers' Conference, the Church Covenant, and such tables of statistics and blank forms as may be necessary.

ARTICLE 16

This Constitution may be amended by a two-thirds majority vote at any annual meeting of the Association.

BYLAWS OF THE MOUNT MITCHELL ASSOCIATION OF THE ORIGINAL FREE WILL BAPTIST OF NORTH CAROLINA

ARTICLE 1

A session of this Association shall meet annually.

ARTICLE 2

This Association shall be opened with Bible reading and prayer.

ARTICLE 3

There shall be no conversation with members, one with another, so as to interrupt business, while in session.

ARTICLE 4

Every person wishing to speak shall first arise to his feet, address the moderator and receive recognition.

ARTICLE 5

No member shall interrupt another who is speaking.

ARTICLE 6

Every member shall attend to the subject under consideration.

ARTICLE 7

No member shall speak more than three (3) times on any one subject.

ARTICLE 8

Every motion made and seconded shall be acted upon after suitable discussion unless withdrawn by those who made it.

ARTICLE 9

A motion before the house must be acted upon before another motion can be made.

ARTICLE 10

On all motions, when a vote of the body is taken, a majority shall prevail.

ARTICLE 11

The Moderator shall have the same privilege to speak as any other member, provided the chair is filled.

ARTICLE 12

We will admit of no other title but that of Brother or Sister while in session.

ARTICLE 13

No member shall absent himself from the body while in session without permission of the Moderator.

ARTICLE 14

Any person transgressing these Bylaws shall be admonished by the Moderator.

ARTICLE 15

No less than seven (7) members shall constitute a quorum.

ARTICLE 16

These Bylaws may be amended at any regular annual meeting by two-thirds vote.

CONSTITUTION OF THE MINISTERS' CONFERENCE OF MT. MITCHELL ASSOCIATION OF THE ORIGINAL FREE WILL BAPTISTS OF NORTH CAROLINA

ARTICLE 1

This body shall be known as the Ministers' Conference of the Mount Mitchell Association of the Original Free Will Baptists of North Carolina.

ARTICLE 2

This body is formed under and by the authority of the Mt. Mitchell Association, and shall be composed of its licensed and ordained ministers, with such delegates as provided by Article 8.

ARTICLE 3

This body shall have entire jurisdiction over the ministry in said Association, issuing license, prescribing qualifications

for the ministry, conducting examinations and ordaining ministers, and at all times working for the most harmonious and effective ministry. Each licensed minister shall work under a license for a period of not less than one year; then being eligible for ordination, providing he can meet all other requirements set forth by the Ordaining Council.

ARTICLE 4

We deem it necessary for the protection of the Gospel not to receive anyone as a minister who has two living wives.

ARTICLE 5

Suitable women may be ordained to the Christian ministry, provided there are no objections to such endorsement other than the matter of sex. (NOTE: This is a word for word copy of a ruling passed in the General Conference of the Free Will Baptist Church in 1886.)

ARTICLE 6

We believe the Bible teaches that Christian women should wear modest apparel, having long hair, and avoid adorning their persons with useless jewelry. This body shall require its female members to be guided by these principles.

ARTICLE 7

The officers of this Conference shall be Moderator, Assistant Moderator, and Clerk-Treasurer, who shall be elected annually and shall perform the duties usually performed by such officers.

ARTICLE 8

Each church shall be advised by its pastor to send two delegates to each session of this Conference, with a letter of authorization from the church, which delegation shall enjoy equal privileges with the ministry, both in deliverations and voting.

ARTICLE 9

Each year, upon being organized, this body shall elect an Ordaining Council. This Council shall consist of three (3) ordained ministers. One member of this Council shall be retained

from the preceding year's Council, the other two (2) to be elected at the discretion of the Conference.

ARTICLE 10

The Ordaining Council, when properly organized, shall have charge of all examinations and ordinations of candidates for the ministry, who have been ordered before it by the Conference. It shall also conduct due investigation into the social life of any candidate for ordination.

ARTICLE 11

This Conference may receive any Christian minister as a visiting member, and when thus received he may enjoy all rights and privileges of regular members except voting privileges.

ARTICLE 12

This Conference shall meet on Friday before each fifth Sunday, with some church in the Association previously agreed upon, or at the call of the Moderator, provided that more than one session may not be held with any church during the same Conference year; and providing also that there be no session held at the fifth Sunday in April immediately following the adoption of this Constitution.

ARTICLE 13

The Moderator is empowered, and it is his duty, to call an extra session of the Conference, upon receiving a properly signed petition from five (5) members, at least (3) three of whom shall be ordained ministers.

ARTICLE 14

Each applicant for either license or ordination shall present a letter of recommendation from his church, properly signed by both pastor and clerk. He must of necessity be a member of a church within the bounds of this Conference. Any minister coming from another denomination shall first unite with one of our churches, then present a letter of recommendation from the church, just as any applicant for license or ordination.

ARTICLE 15

Any minister who does not represent either in person or by letter for two (2) successive sessions of Conference shall be charged with delinquency and shall be deprived of his vote on any question until his disability is removed by vote of the Conference. However, if the delinquent brother offers a satisfactory reason for his absence, a majority vote of the Conference may remove his disability.

ARTICLE 16

The Conference may withdraw fellowship from any member who becomes disorderly, provided however, all Scriptural and Christian means have first been used to help him.

ARTICLE 17

The Moderator is empowered to appoint any Committee the Conference deems necessary to expedite its business.

ARTICLE 18

Any article of this Constitution or its Bylaws may be suspended or amended by a two-thirds vote of the Conference.

ARTICLE 19

A session of Conference shall be held in connection with the yearly Association.

ARTICLE 20

Five (5) members shall constitute a quorum, provided at least three (3) of them shall be ordained ministers.

ARTICLE 21

(Added as an amendment to ARTICLE 15)

Every minister granted license or ordination by this body shall be required to pledge that he will faithfully attend and support the Conference--sickness or death being the only acceptable reason for non-attendance.

BYLAWS OF THE MOUNT MITCHELL FREE WILL BAPTIST MINISTERS' CONFERENCE

No licentiate shall succeed to ordination unless he can furnish sufficient evidence that he has obeyed the Scriptural

admonition to "Study to show thyself approved unto God, a workman that needeth not to be ashamed, rightly dividing the word of Truth." The Ordaining Council must be satisfied that he or she is divinely called, and the fruit of life and work during the period served under license must be satisfactory to the Ordaining Council. If it deems such a course advisable, the Ordaining Council may require a licentiate to renew his license, for as often as may be necessary, before ordination.

ARTICLE 2

Necessary expenses of this organization shall be met by voluntary contributions or by assessment of its members.

ARTICLE 3

No member shall serve as pastor of a church which does not enforce discipline, care for its pastor according to its ability, and strive to go forward in spiritual progress and the advancement of the Cause of Christ.

ARTICLE 4

Any member who meddles with the work of another, or injures another's reputation for usefulness shall be subject to a charge of disorderly conduct, and shall be dealt with according to Article 16 of the Constitution.

ARTICLE 5

Each member, not excused by age or infirmity, is expected to do some work to advance the Cause of Christ and make a full report at each annual meeting.

ARTICLE 6

Membership in this body shall be proof of good standing in the ministry.

ARTICLE 7

All ministers seeking license to preach must be kept under the watchcare of the Conference for the period of three months.

* * * * * *

FAITH

Saving faith is an assent to the mind to the fundamental truths of revelation; an acceptance of the Gospel, through the influence of the Holy Spirit; and a firm confidence and trust in Christ. The fruit of faith is obedience to the Gospel. The power to believe is the gift of God; but believing is an act of the creature, which is required as a condition of pardon, and without which the sinner cannot obtain salvation. All men are required to believe in Christ; and those who yield obedience to this requirement become the children of God by faith.

Scripture references to Faith: II Cor. 7:10; Prov. 28:13; Ezek. 18:30; Acts 17:30; Luke 13:5; Heb. 11:6; Rom. 10:9-10; Acts 16:31; James 2:17; Phil. 1:29; Gal. 3:26.

CHURCH COVENANT

Having given ourselves to God by faith in Christ, and adopted the Word of God as our rule of faith, and practice, we now give ourselves to one another by the will of God in this solemn Covenant.

We promise by His grace to love and obey Him in all things, to avoid all appearance of evil, to abstain from all sinful amusements and unholy conformity to the world, from all sanction of the use and sale of intoxicating beverages, and to "provide things honest in the sight of all men." We agree faithfully to discharge our obligations in reference to the study of the Scriptures, secret prayer, family devotions and social worship; and by self denial, faith and good works endeavor to "grow in grace and the knowledge of our Lord and Savior Jesus Christ." We will not forget the assembling of ourselves together for Church Conferences; public worship, and the observance of the ordinances of the Gospel, nor fail to pay according to our ability for the support of the church, of its poor, and all its benevolent work.

We agree to accept Christian admonition and reproof with meekness, and to watch over one another in love, endeavoring to "keep the unity of the Spirit" in the bonds of peace, to be careful of one another's happiness and reputation, and seek to strengthen the weak, encourage the afflicted, admonish the erring, and as

far as we are able promote the success of the church and the Gospel. We will everywhere hold Christian principle sacred and Christian obligations and enterprises supreme; counting it our chief business in life to extend the influence of Christ in society; constantly praying and toiling that the Kingdom of God may come, and His will be done on earth as it is in Heaven.

To this end we agree to labor for the promotion of educational and denominational enterprises, the support of Missions, the success of Sunday Schools, and evangelistic efforts for the salvation of the world. And may the God of peace sanctify us wholly, and preserve us blameless unto the coming of our Lord, Jesus Christ.
