EDUCATION

We, your Committee on Education submit the following: Two preachers of old, Zechariah and Malachi, spoke of the "burden of the Word of the Lord." O, for that burden among preachers and teachers today! It is not enough for your young people to be reared Free Will Baptists. Young and old alike need to be acquainted with the Word of God. In facing a scoffing world we need some things to believe in. And we need to know why we believe those things. The education offered in public schools is good for this life only. But human beings are eternal souls. And the amount of Biblical education or lack of it may determine salvation or damnation for our young and old alike. The first two things we need are these:

- 1. A wholesome respect for the Word of the Lord. We regard this Book too lightly.
- 2. An acquaintance with the Book. It is amazing how unfamiliar a book the Bible really is to most of us. In a congregation, how many can answer the question: "How many books are in the Bible?" Have a Bible Drill--among young or old. Ask quickly that they find Habakkuk 2:1 or Haggai 1:2 or Jude 3. Too many times you will hear "Is that in the Bible?" or, "New or Old Testament?" It is first to our shame that we don't know more about the Bible.

Secondly, it is to our shame that we don't know more of what is in the Bible. Jesus said "Search the Scriptures," (John 5:39). Luke said of the Bereans that they "searched the scriptures daily," (Acts 17:11). Our children need to know Moses and Abraham, Peter and Paul better than they know George Washington or Abraham Lincoln. But do they? How much do we search Genesis and Judges . . . besides the other thirty-five books of the Old Testament, though God has told us those things were written for our examples? How much do we search Zechariah and Daniel, though we would know our own day better if we did? How much do we search the New Testament epistles, many of them written from a prison cell or mission fields afar from home, though they offer us hope for eternity?

But to search, tools are needed. Few lay members are going to search. The Holy Ghost challenges us who preach or teach--and that challenge is "Study to show thyself approved." Love the Book, search the Book, and that Word will become alive to you. Knowledge of the Bible is the only really worthwhile thing you can give to others. These are some tools you must have with which to search:

- 1. A readiness of mind Acts 17:11
- An awareness of your inability . . . "If any of you lack wisdom"
- 3. A knowledge of how to remedy the inability . . . 'let him ask of God' (Tames 1:5).

Besides the Bible, these two books are necessary for study:

- 1. A concordance
- 2. A dictionary

Use any means to advance your knowledge of the Bible. Pray for a way to interest your listeners in the Word. Let us let that Book have its rightful place!

MISSIONS

We, your Committee on Missions submit the following:

We believe that it is impossible for one to fully believe and obey the Word of God without believing in and practicing missions. Our Lord's last command to his disciples before his ascension was, "Go ye therefore, and teach all nations, baptizing them in the name of the Father, and of the Son, and of the Holy Ghost: teaching them to observe all things whatsoever I have commanded you: and lo, I am with you always, even unto the end of the world. Amen." (Matthew 28:19, 20). Jesus, Himself, was the first Gospel foreign missionary. In his parables of the kingdom, He tells us, "The field is the world." (Matthew 13:38) He did not say a certain

portion of the world, but "the world" meaning all the inhabited earth. He also said, "As my Father hath sent me, so send I you." John 20:21

We further believe that Jesus gave his own pattern for missionary labor when he said, "But ye shall receive power after that the Holy Ghost is come upon you; and ye shall be witnesses unto me both in Jerusalem, and in all Judea, and in Samaria, and unto the uttermost part of the earth." (Acts 1:8)

The Divine order is:

- 1. Empowerment by the Holy Ghost.
- 2. Witnessing begins at home.
- 3. Spreads to the uttermost parts of the earth.

We further submit that the early Church was strongly missionary-minded in its faith and practice. See the entire book of the Acts of the Apostles, especially Chapter 15:1-4. Our recommendation is, therefore, that all our Churches realize the responsibility laid upon us by our Lord himself, and that both as individuals and as a body - we take Him at His word and obey His command.

We believe that when God calls one of our members to foreign mission service, we should deem it one of the greatest honors He could bestow upon us and pledge ourselves to support such, both in school while preparing to support such, both in school while preparing and after he or she is on the field. REPORT OF "CROSS BEAMS"

"I will bless the Lord at all times: His praise shall continually be in my mouth. My soul shall make her boast in the Lord: the humble shall hear thereof, and be glad. O magnify the Lord with me, and let us exalt His name together!" (Psalm 34:1-3)

Truly, Friends, as I consider what the Lord has done for Cross Beams--and through this ministry, for the multitudes--I feel that I must have help to "magnify the Lord, and exalt His name . . . " The financial report gives no inkling of the thousands of

people who have heard the Gospel, or the multitudes saved and blessed. That report is on Heaven's record. But since the members of the Mt. Mitchell Association are so largely used in the financial support of the work, I feel you are entitled to such report as I am able to give.

Cross Beams is presently being heard on 42 stations scattered through 15 states. Total costs for air time alone from September 1, 1969 through September 1, 1970, amount to \$12,329.65, which averages out to more than \$1,000.00 per month for air time alone. Add to this tapes and office supplies in the amount of more than \$250.00, plus postage uncounted but estimated to average at least \$20.00 per month, plus regular mission support, and I think it is safe to say that Cross Beams total expense had not been less than \$15,685.65. This averages out to more than \$1300.00 per month. I am continually amazed at how the Lord meets this need just in time. Sometimes I go to the bank to make a deposit, and there is more in the purse than I counted just before leaving home! I don't know how: I only know that "God is able to do exceeding abundantly above all that we ask or think, according to the power that worketh in us," and I ask you to "let us exalt His name together."

Mission support is sent regularly to care for the needs of native workers in Mexico, Venezuela, and Zululand, South Africa: \$70.00 monthly to Mexico, \$50.00 monthly to Venezuela, and \$50.00 monthly to Zululand. Our mission funds are administered by American missionaries on the field, who are so much better able to judge the need and worthiness of the native worker than I, (or any mission board based here). Money is not even taken out of the gifts for postage, so that every penny given reaches the field. From September 1, 1969, through September 1, 1970, the Lord has enabled Cross Beams to contribute \$2,866.00 to the cause of world missions through Cross Beams tithes and designated gifts. We praise Him, Who alone is "sufficient for all these things . . . "

The amounts shown on the statistical table as having been contributed by the various churches have for the most part been gifts

from individuals and families within the churches. Prices Creek Church leads the list, with a total of \$1,883.00. This is a Union Church, (Free Will Baptist and Missionary Baptist), and members of both have helped to make this report possible. Several families in this community support a station or contribute regularly to mission support, and I have also included in this total the personal support which many of my good neighbors have contributed to me. Patterson Branch and Terrys Fork also have either families or individuals who support stations, and some of the people from the other churches make regular contributions. I would like to give recognition to each of these, but forebear for lack of space and the fear I might leave someone out. The total contribution from the seven churches of the Mt. Mitchell Association, if I have correctly counted, is \$3, 115.81. Friends, I have no words to thank you, but I praise God for you, and I know that He will reward you abundantly . . . Not long ago, Darryl and Karen Deyton, who support the Morganfield, W.Va. station, had some extra expense that I happened to know about, and when they came to pay their station support, I said something like this: "Children, if you want to let that go until you're more able, it's all right." One of them quickly answered, "No, the more we give the better we get along!" And I thought, "They have learned early a lesson many people never learn; that putting God first pays great dividends, not only in the world to come, but even here . . . "

May I ask that each of you <u>pray daily</u> for this ministry in the coming year? Your prayers are needed as much--even more--than your money; and I thank you from my heart for both prayers and gifts in His Holy Name, Whose I am and Whom I serve . . .

CONSTITUTION OF MOUNT MITCHELL FREE WILL BAPTIST ASSOCIATION

ARTICLE 1

This Association shall be known as the Mount Mitchell Association of the Original Free Will Baptists of North Carolina.

ARTICLE 2

The objects of this Association shall be: to proclaim a full salvation and lift up a standard of holy living in accordance with the teaching of the Bible; to promote unity, fraternity, fellowship and cooperation within the bounds of our own churches, and Christian charity toward all Christians; to encourage and engage in larger Christian enterprises than can be carried on by one church; to combine and direct the energies of the Free Will Baptists within its bounds in one sacred effort to encourage and promote the general spread of the Gospel, and all of its benevolent enterprises.

ARTICLE 3

- 1. This Association shall be composed of all licensed and ordained ministers, and of delegates chosen and sent by each church within its bounds, said delegates being duly recommended by letter from the church to which they belong.
- 2. Each church, irrespective of size, shall be entitled to five (5) delegates, with an additional delegate for every ten (10) members or fraction thereof above fifty (50). Each church is expected to defray the expenses of the Association and the causes which it fosters.
- 3. The Association disclaims the right to exercise lordship over the churches, or to have any power which entitles it to infringe upon internal affairs or rights of any of the churches composing it. Each church shall consider its internal affairs to be its own business, but it shall not disrespect the Association and those placed in authority by the proper processes.

ARTICLE 4

The Association may withdraw from any church that becomes

disorderly or refuses to be represented by letter or delegation, providing, however, that any church accused of disorderly walk or unscriptural doctrine shall have the same rights as an individual in the church to have specific charges presented in writing, together with convincing evidence; a fair opportunity for defense and to be considered innocent until proven guilty.

ARTICLE 5

This Association shall make use of the Treatise of the Faith and Practices of Free Will Baptists adopted by the National Association November 7, 1935 at Nashville, Tennessee; recognizing however, the truth stated therein; that the Scriptures of the Old and New Testaments were given by inspiration of God, and are our only infallible rule of faith and practice.

ARTICLE 6

Churches coming from another denomination will be carefully examined and approved as to doctrine and practice before being received as members.

ARTICLE 7

- 1. The officers of this Association shall be Moderator and Assistant Moderator, Clerk, Treasurer and Historian, all of whom shall be elected for a term of two years, except the Moderator and Assistant Moderator, who shall be elected annually. They shall enter upon the duties of their offices at the close of the current season.
- 2. It shall be the duty of the Moderator to preside over all the meetings of the Association.
- 3. It shall be the duty of the Assistant Moderator to preside in the absence of the Moderator.
- 4. It shall be the duty of the Clerk to keep a faithful record of the proceedings of the Association in a business-like manner, to superintend printing and distribution of the minutes, and to give over all properties belonging to his or her office to his or her duly elected successor.

- 5. The Clerk shall be paid a fee to be determined by the Association. Minutes of the Association shall be sent to all visiting Free Will Baptist Ministers.
- 6. It shall be the duty of the Treasurer to receive all funds belonging to the Association, and to disburse same as directed by the Association. The Treasurer shall be bonded for an amount sufficient to cover all the funds for which he is responsible.
- 7. It shall be the duty of the Historian to keep a record of such items of interest as may be useful in the future, especially a file of all the minutes, and to preserve the same in a book. He or she shall also be required to give over all properties of the office to the successor to the office.

ARTICLE 8

The Association shall appoint annually such committees as it shall deem necessary to expedite its business. These committees may be called upon to serve in either a temporary or standing capacity. Temporary committees complete their work and make a report of it during the same session in which they are appointed. Standing committees are appointed to assist in such matters as may require service both during and between sessions. The Moderator is empowered to choose the Chairman of each Committee, and the delegates may assist in choosing other members of said committees from among their own ranks.

ARTICLE 9

The Executive Board of this Association shall consist of the Moderator, Assistant Moderator, Clerk, Treasurer, Historian and three (3) members elected from the floor. It shall be the duty of the Executive Board to have the supervision of the work of the Association between sessions. The Moderator and Clerk, by virtue of their respective offices, shall be Chairman and Secretary, respectively, of the Executive Board.

ARTICLE 10

It shall be the duty of this Association to encourage a sound ministry, such as present Christ as an all-sufficient Saviour, having made salvation possible to every human being on the terms of the Gospel, which is freely offered to all.

ARTICLE 11

A Church may become a member of this Association by making request by delegation, which delegation shall present a letter showing vital statistics of said church, providing however, that such church shall be examined as to doctrine, practice and willingness to abide by the Constitution and Bylaws of this Association.

ARTICLE 12

The Bylaws of this Constitution shall be read annually immediately after the body is organized.

ARTICLE 13

This Association advises all its churchs to commemorate the death and sufferings of our Lord at least twice a year, with the service of feet-washing to follow the communion.

ARTICLE 14

The Association shall meet annually on Thursday before the fourth Sunday in September for the purpose of worship and the transaction of business. There shall be no less than two (2) worship services daily while the Association is in session.

ARTICLE 15

This Association's printed Minutes shall consist of a record of all business transacted and all worship services during the annual meeting, the proceedings of the quarterly sessions of Conference, the Constitution and Bylaws of the Association and the Constitution and Bylaws of the Ministers' Conference, the Church Covenant, and such tables of statistics and blank forms as may be necessary.

ARTICLE 16

This Constitution may be amended by a two-thirds majority vote at any annual meeting of the Association.

BYLAWS OF THE MOUNT MITCHELL ASSOCIATION OF THE ORIGINAL FREE WILL BAPTIST OF NORTH CAROLINA

ARTICLE I

A session of this Association shall meet annually.

ARTICLE 2

This Association shall be opened with Bible reading and prayer.

ARTICLE 3

There shall be no conversation with members, one with another so as to interrupt business, while in session.

ARTICLE 4

Every person wishing to speak shall first arise to his feet, address the moderator and receive recognition.

ARTICLE 5

No member shall interrupt another who is speaking.

ARTICLE 6

Every member shall attend to the subject under consideration.

ARTICLE 7

No member shall speak more than three (3) times on any one subject.

ARTICLE 8

Every motion made and seconded shall be acted upon after suitable discussion unless withdrawn by those who made it.

ARTICLE 9

A motion before the house must be acted upon before another motion can be made.

ARTICLE 10

On all motions, when a vote of the body is taken, a majority shall prevail.

ARTICLE 11

The Moderator shall have the same privilege to speak as any other member, provided the chair is filled.

ARTICLE 12

We will admit of no other title but that of Brother or Sister while in session.

ARTICLE 13

No member shall absent himself from the body while in session without permission of the Moderator.

ARTICLE 14

Any person transgressing these Bylaws shall be admonished by the Moderator.

ARTICLE-15

No less than seven (7) members shall constitute a quorum.

ARTICLE 16

These Bylaws may be amended at any regular annual meeting by two-thirds vote.

CONSTITUTION OF THE MINISTERS' CONFERENCE OF MT. MITCHELL ASSOCIATION OF THE ORIGINAL FREE WILL BAPTISTS OF NORTH CAROLINA

ARTICLE 1

This body shall be known as the Ministers' Conference of the Mount Mitchell Association of the Original Free Will Baptists of North Carolina.

ARTICLE 2

This body is formed under and by the authority of the Mt. Mitchell Association, and shall be composed of its licensed and ordained ministers, with such delegates as provided by Article 8.

ARTICLE 3

This body shall have entire jurisdiction over the ministry in said Association, issuing license, prescribing qualifications

for the ministry, conducting examinations and ordaining ministers, and at all times working for the most harmonious and effective ministry. Each licensed minister shall work under a license for a period of not less than one year; then being eligible for ordination, providing he can meet all other requirements set forth by the Ordaining Council.

ARTICLE 4

We deem it necessary for the protection of the Gospel not to receive anyone as a minister who has two living wives.

ARTICLE 5

Suitable women may be ordained to the Christian ministry, provided there are no objections to such endorsement other than the matter of sex. (NOTE: This is a word for word copy of a ruling passed in the General Conference of the Free Will Baptist Church in 1886.)

ARTICLE 6

We believe the Bible teaches that Christian women should wear modest apparel, having long hair, and avoid adorning their persons with useless jewelry. This body shall require its female members to be guided by these principles.

ARTICLE 7

The officers of this Conference shall be Moderator, Assistant Moderator, and Clerk-Treasurer, who shall be elected annually and shall perform the duties usually performed by such officers.

ARTICLE 8

Each church shall be advised by its pastor to send two delegates to each session of this Conference, with a letter of authorization from the church, which delegation shall enjoy equal privileges with the ministry, both in deliberations and voting.

ARTICLE 9

Each year, upon being organized, this body shall elect an Ordaining Council. This Council shall consist of three (3) ordained ministers. One member of this Council shall be retained

from the preceding year's Council, the other two (2) to be elected at the discretion of the Conference.

ARTICLE 10

The Ordaining Council, when properly organized, shall have charge of all examinations and ordinations of candidates for the ministry, who have been ordered before it by the Conference. It shall also conduct due investigation into the social life of any candidate for ordination.

ARTICLE 11

This Conference may receive any Christian minister as a visiting member, and when thus received he may enjoy all rights and privileges of regular members except voting privileges.

ARTICLE 12

This Conference shall meet on Friday before each fifth Sunday, with some church in the Association previously agreed upon, or at the call of the Moderator, provided that more than one session may not be held with any church during the same Conference. year; and providing also that there be no session held at the fifth Sunday in April immediately following the adoption of this Constitution.

ARTICLE 13

The Moderator is empowered, and it is his duty, to call an extra session of the Conference, upon receiving a properly signed petition from five (5) members, at least (3) three of whom shall be ordained ministers.

ARTICLE 14

Each applicant for either license or ordination shall present a letter of recommendation from his church, properly signed by both pastor and clerk.

ARTICLE 15

Any minister who does not represent either in person or by letter for two (2) successive sessions of Conference shall be charged with delinquency and shall be deprived of his vote on any question until his disability is removed by vote of the Conference. However, if the delinquent brother offers a satisfactory reason for his absence, a majority vote of the Conference may remove his disability.

ARTICLE 16

The Conference may withdraw fellowship from any member who becomes disorderly, provided however, all Scriptural and Christian means have first been used to help him.

ARTICLE 17

The Moderator is empowered to appoint any Committee the Conference deems necessary to expedite its business.

ARTICLE 18

Any article of this Constitution or its Bylaws may be suspended or amended by a two-thirds vote of the Conference.

ARTICLE 19

A session of Conference shall be held in connection with the yearly Association.

ARTICLE 20

Five (5) members shall constitute a quorum, provided at least three (3) of them shall be ordained ministers.

ARTICLE 21

(Added as an amendment to ARTICLE 15)
Every minister granted license or ordination by this body shall be required to pledge that he will faithfully attend and support the Conference.

ARTICLE 22

(Added as an amendment to ARTICLE 14)

Every minister coming from another Conference to seek membership in our body must bring with him a letter of recommendation from the Conference he is leaving.

BYLAWS OF THE MOUNT MITCHELL FREE WILL BAPTIST MINISTERS' CONFERENCE

No licentiate shall succeed to ordination unless he can furnish sufficient evidence that he has obeyed the Scriptural admonition to "Study to show thyself approved unto God, a workman that needeth not to be ashamed, rightly dividing the word of Truth." The Ordaining Council must be satisfied that he or she is divinely called, and the fruit of life and work during the period served under license must be satisfactory to the Ordaining Council. If it deems such a course advisable, the Ordaining Council may require a licentiate to renew his license, for as often as may be necessary, before ordination.

ARTICLE 2

Necessary expenses of this organization shall be met by voluntary contributions or by assessment of its members.

ARTICLE 3

No member shall serve as pastor of a church which does not enforce discipline, care for its pastor according to its ability, and strive to go forward in spiritual progress and the advancement of the Cause of Christ.

ARTICLE 4

Any member who meddles with the work of another, or injures another's reputation for usefulness shall be subject to a charge of disorderly conduct, and shall be dealt with according to Article 16 of the Constitution.

ARTICLE 5

Membership in this body shall be proof of good standing in the ministry.

ARTICLE 6

All ministers seeking license to preach must be kept under the watchcare of the Conference for the period of three months.

FAITH

Saving faith is an assent to the mind to the fundamental truths of revelation; an acceptance of the Gospel, through the influence of the Holy Spirit; and a firm confidence and trust in Christ. The fruit of faith is obedience to the Gospel. The power to believe is the gift of God; but believing is an act of the creature, which is required as a condition of pardon, and without which the sinner cannot obtain salvation. All men are required to believe in Christ; and those who yield obedience to this requirement become the children of God by faith.

Scripture references to Faith: II Cor. 7:10; Prov. 28:13; Ezek. 18:30; Acts 17:30; Luke 13:5; Heb. 11:6; Rom. 10:9-10; Acts 16:31; James 2:17; Phil. 1:29; Gal. 3:26.

CHURCH COVENANT

Having given ourselves to God by faith in Christ, and adopted the Word of God as our rule of faith, and practice, we now give ourselves to one another by the will of God in this solemn Covenant.

We promise by His grace to love and obey Him in all things, to avoid all appearance of evil, to abstain from all sinful amusements and unholy conformity to the world, from all sanction of the use and sale of intoxicating beverages, and to "provide things honest in the sight of men." We agree faithfully to discharge our obligations in reference to the study of the Scriptures, secret prayer, family devotions and social worship; and by self denial, faith and good works endeavor to "grow in grace and the knowledge of our Lord and

Saviour Jesus Christ." We will not forget the assembling of ourselves together for Church Conferences; public worship, and the observance of the ordinances of the Gospel, nor fail to pay according to our ability for the support of the church, of its poor, and all its benevolent work.

We agree to accept Christian admonition and reproof with meekness, and to watch over one another in love, endeavoring to "keep the unity of the Spirit" in the bonds of peace, to be careful of one another's happiness and reputation, and seek to strengthen the weak, encourage the afflicted, admonish the erring, and as far as we are able promote the success of the church and the Gospel. We will everywhere hold Christian principle sacred and Christian obligations and enterprises supreme; counting it our chief business in life to extend the influence of Christ in society; constantly praying and toiling that the Kingdom of God may come, and His will be done on earth as it is in Heaven.

To this end we agree to labor for the promotion of educational and denominational enterprises, the support of Missions, the success of Sunday Schools, and evangelistic efforts for the salvation of the world. And may the God of peace sanctify us wholly, and preserve us blameless unto the coming of our Lord, Jesus Christ.
