# PROCEEDINGS

The Nineteenth Annual Session of the State Convention of the Original Free Will Baptist of North Carolina, convened with the church at Oak Grove, Sampson County, on Tuesday September 15, 1931 at 11 o'clock A. M.

The Convention opened by song service and prayer. The president of the Convention, called Rev. J. W. Alford, pastor of Oak Grove Church to the stand, and in a very brief way he introduced Eld. J. H. Worley to the audience as Eld. Worley was to preach the introductory sermon.

Bro. Worley in his old fashioned and simple way responded and preached a noble soul stirring sermon, stressing the point of maintaining the sure foundation. Text Psa. 11:3. "If the foundations be destroyed, what can the righteous do?" After the sermon, the president announced that the convention would take a recess till 1:30 for dinner.

#### TUESDAY AFTERNOON

The Convention assembled at the appointed hour, and was opened with song service and prayer.

A letter was read from Eld. E. T. Phillips, Secretary of the Convention stating his inability to attend this session owing to his ill health.

The chair declared that nominations were in order for secretary protem.. The name of W. A. Jackson was placed before the convention, and he was elected by acclamation as the secretary for this convention only.

The following resolution by S. H. Styron and J. C. Griffin was offered and after being read was, by a vote of the Convention, unanimously adopted:

#### REPORT OF EXECUTIVE BOARD

In the absence of the Secretary, the Board was not prepared to give :a full written report; therefore, a verbal report was called for from the members of the Board who were present.

The Board reported as follows: The Board has held only one meeting since the last State Convention.

The resignation of R. E. Tripp as Vice President was received and accepted and Eld. J. C. Griffin was elected to fill the vacancy.

The resignation of Bro. Wiley Lamm of the Western Conference as a member of the Orphanage Board was received and accepted, and Bro. D. W. Parker of the Cape Fear Conference was elected in his stead.

A program committee was appointed to arrange a program for the next convention. The above report was adopted and ordered placed in the minutes.

At the urgent request of the Convention, Eld. J. C. Griffin, who was to speak to night at 8 o'clock on the Mission of the State Convention, consented to deliver his message at this hour. Bro. Griffin in a very creditable manner spoke of the outstanding purpose of the organization of the State Convention, it being that of unification of the ministers, various conferences and associations.

The president called the congregation to urgently bow in prayer in behalf of Rev. E. T. Phillips, who has sent a request to the convention for prayer. The prayer was led by R. V. Self and closed by S. H. Styron.

After the prayer referred to above, Bro. Self gave a very interesting message on prayer, and specially on prayer for the healing of the sick. He gave several incidents where the sick were instantly healed following prayer in their behalf.

Eld. L. H. Wetherington spoke earnestly in the interest of the Free Will Baptist paper.

Petition was received from the newly organized Buncombe County Association for admission into this body. The association, by the unanimous vote of the convention, was admitted and the hand of welcome extended to the following delegates from that body: W. L. Moretz, Cecil Ballard, Mr. and Mrs. A. M. Hickle, Mrs. L. E. Ballard.

TO THE N. C. STATE CONVENTION OF FREE WILL BAPTIST:

The Orphanage Board submits to you a summary of its activities during the year, which we hope will meet with your approval.

During the year we have held seven meetings, and transacted the various items of business incident to the work of the Home. Six of these were held at the Home, the other being held at Goldsboro, when all the Boards were in joint session.

It is noticeable that during the year, we have had fewer applications to consider than heretofore, and fewer children have been admitted. There is a small number of children whose applications have been approved who are waiting to be admitted, but the conditions generally do not warrant an increase in the number to be cared for, by the Home.

Several children have been returned to their mothers or other relatives during the year. Some of these had reached the age of eighteen, the others who went to their mothers, were sent because of the fact that the mothers had remarried, and were in position to take care of them. We feel safe in assuring you that this policy will continue to be observed by the Board, since we feel that the Home should be maintained for the children who have no one at all to provide for them. In sending these back to their relatives, we have decreased the number of inmates, so that today the total in the Home is 80.

The Supt. and his helpers in the Home are due credit and the thanks of the brotherhood for taking a voluntary cut in salaries amounting to \$5.00 each per month, and this they did for the love of the cause. How many of our brethren are contributing an amount equal to this? The depression has been very keenly felt, and certainly there will not be one in all our number that will not commend and bless these faithful workers for their sacrifice.

The health conditions of the Home are good, though we have had a number of tonsil operations. Each operation has been successful, and no unfavorable reactions have occurred. The throat specialist, Dr. Blackshear

Woodard of Wilson has been in charge of these, and his interest in thesechildren has been and is a matter that gives us cause for deep gratitude. The report of the Supt. will doubtless give you the inside information concerning the financial standing and outlook of the Home; but I cannot refrain from reminding us that we must rally more earnestly to its needs and obligations, or else a situation will develop that will cause great privation and hardship on the children. Brethren these are your wards, and the privilege of helping to care for them should be one of the inspiring opportunities of your life. Let each minister in our connection see to it that his church is a regular contributor. Insist on the brethren visiting the Home for we would like for them to become better acquainted with it. It is yours brethren, and we will make of it, and operate it on the level that you make possible.
