REPORT OF EXECUTIVE COMMITTEE

The Executive Committee of the State Convention met in Ayden, N. C., October 5, 1951. Prayer was offered by Rev. C. H. Coates. The definition of the

The purpose of the meeting, as stated by the President, was to consider all matters referred to the Executive Committee by the Convention in session.

The president appointed M. L. Johnson and R. N. Hinnant to study the Constitution and By-Laws of the convention and recommend to the Executive Committee, at any called meeting, any changes necessary to bring them up to date.

The President called the representatives of the various boards together and proceeded to organize the Commission for studying the setting up of headquarters, as requested by the Convention. The organization was as follows: J. A. Evans, Chm., M. L. Johnson, Vice-Chm., R. N. Hinnant, Sec., H. M. Mallard, D. W. Alexander, D. W. Hansley, Bruce Barrow were appointed as members. (Motion the matter of a state wide uniform questionnaire for the ordination of

ministers be deferred until a later date.

Motion the Treasurer be paid twenty five dollars (\$25.00) per year for his services, retroactive as of the past year.

Motion the contract of the Promotional Secretary be renewed for one year at a salary of one hundred dollars (\$100,00) per month.

Motion that the Promotional Department be allocated twenty seven hundred (\$2700.00) dollars for the year of 1951-1952.

Motion that all boards pay their expenses in promoting their respective enterprises, with the exception of the secretary's work, through the Promotional Department.

Motion that two hundred dollars (\$200.00) be appropriated for the expense of the Commission appointed to set up headquarters.

The President, Vice-President and Secretary were appointed as a committee to arrange a program for the 1952 session of the Convention.

L. B. Manning, R. N. Hinnant and M. L. Johnson were named as a committee to purchase the necessary equipment for the office of the Promotional Secretary.

Motion that the secretary express to the auxiliaries the appreciation of the Executive Committee relative to their desire to place a woman on the Orphanage Board but the Charter will only allow nine members.

Note: Some of the Ladies' Auxiliaries were anxious to add a woman to the Board, at large, to represent the interest of those auxiliaries.

Motion the report of the committee appointed in the May 27th meeting be adopted.

Motion that the contract of the Promotional Director be renewed for the year of 1952-1953.

Your Committee on the Establishment of a State Headquarters for Free Will Baptists in Wilson, North Carolina, has held two consultation meetings, investigated available rental property, and restudied the advantages and disadvantages of maintaining a central administrative and promotional headquarters in the city of Wilson for Free Will Baptists of North Carolina.

We submit the following statements of opinion and recommendations:

1. It is the opinion of this Committee that adequate funds for the maintenance of a creditable state headquarters in Wilson, North Carolina, cannot be made available at this time without disserving the enterprises and institutions of the State Convention and the National Association.

2. It is the opinion of this Committee that your Executive Board should authorize the preparation of appropriate resolutions prescribing the integration of all administrative and promotional services engaged in by

integration of all administrative and promotional services engaged in by departmental boards, institutions, and subordinate general organizations of the North Carolina State Convention of Free Will Baptists; and that said resolutions, thus approved by the Executive Board, be submitted to off the 1952-session of the Convention for adoption.

3. This Committee recommends that the action passed by the Executive Board in the previous session, held May 27, 1952, which authorized the establishment of a state headquarters for Free Will Baptists in Wilson, North Carolina; be rescinded as of this date. 4. This Committee recommends, subject to the approval of the Executive Board and the State Convention, the negotiation of an agreement with the Free Will Baptist Press for the indefinite use of adequate offices for the accommodation of the general administrative and promotional services of the Free Will Baptist State Convention of North Carolina and all its agencies.

During the past year I have made at least one visit into the sections covered by each of the Conferences or Associations. I have attended seven (7) annual Conferences or Associations and have attended ministers meetings and Executive Committee meetings in three (3) other Associations. I have attended all other public meetings of the various bodies of our denomination that it was possible to attend. In all of these meetings I have presented the United Program and have found a growing interest in our state wide program.

During the year I have served as treasurer for three of our boards; namely: Church Finance Association, Inc., Board of Superannuation and the Board of Christian Education. I have also been the receiving agent for funds for Cragmont Assembly. In addition to the above I have received some funds for each of the other Boards and have forwarded said funds to the proper boards.

During the year I have helped each of the boards with their promotional work. I have mailed letters for each of the boards for the special drives during the months designated for them. I have attended at least one meeting of each board and in some cases more than one meeting.

During the year I have done a great deal of writing and speaking in the interest of our denominational work in this state. 1951-1952-Receipts from all other sources, by Mr. Fountain Taylor: Promotional Department, M. L. Johnson-\$2,240.27; Treasurer, Mr. Taylor-\$1,399.65; Total Receipts-\$3,639.92; Expenses-\$3,605.53; Balance-\$34.39.

Extra Information: Payment on Mortgage, \$1,000.00; Bus Payments, \$2,400.00.

The Board of Christian Education for The North Carolina State Convention of Original Free Will Baptists, wishes to make the following report to The North Carolina State Convention of Original Free Will Baptists, to be held September 17th, and 18th, 1952, with Goshen Original Free Will Baptist Church, Belmont, North Carolina.

1-The Board of Christian Education has held four regular meetings this year. The purpose of the meetings was to carry out the recommendations that were recommended to the Board of Christian Education during the sitting of The North Carolina State Convention for the year 1951 and recorded in the Minutes of the same year.

2-The Board of Christian Education has met with the Trustees of Cragmont Assembly, Inc., and an agreeable contract was entered into between the two boards, whereby the proposed Junior College at Cragmont Assembly can be established. (See Contract Copy.)

3-The Board of Christian Education suggested that the college be known as Mount Allen Junior College and it is chartered by that name.

4—A Charter for the incorporation and operation of a Junior College has been granted to The North Carolina State Convention of Original Free Will Baptists, by the State of North Carolina. The Charter is on file in the Court House of Buncombe County, Asheville, North Carolina. (See Copy of Charter.)

5-A Catalogue for Mount Allen Junior College has been printed. The Catalogue in many details was not complete at the time of printing, but due to the limited time it was the best we could do under prevailing circumstances. (See Copy of Catalogue.)

6-We have been fortunate to secure the services of the following persons to teach in the College: Rev. Lloyd Vernon, Mount Olive, North Carolina, Teacher, President; Rev. W. L. Moretz, Swannanoa, North Carolina, Dean of Boys, Teacher; Rev. A. B. Chandler, Ahoskie, North Carolina, Business Education, Teacher. Other teachers and personnel will be added as the need arises.

7-The suggested time for the College to open is Monday September 22nd, 1952, 10 o'clock a. m.

8-We have received 10 applications from students who wish to attend the College.

9-The suggested courses of study, up to this time, for this school year, are as follows: High School Subjects, Business Education, Religious Education, Bible Institute and Music. The courses of study will be regulated as the need arises and according to the individual needs of the students who apply for admittance to the College.

10-The financial income from our people has not been as much as we would prefer it to be, but we are grateful to those that have given for this great purpose. Hoping for an increased interest on the part of all our people to this great and worthy cause. (See Treasurer's Report by Promotional Secretary.) (See Copy of Proposed Budget.)

11-There are many other things that have been done that are of a detailed nature. All that has been done, great or small, by the Board of Christian Education, has been done with God and our people at heart and the youth of our church in mind. We are asking each person to pray with us and help us with your means and time to make this great cause of our church and state, a success, in the name of Christ who gave Himself in death, "that we might have life and it more abundantly."

3-PENSION CHECKS

There are now 22 ministers receiving monthly checks from this Board. There are also 22 widows receiving quarterly checks. If there are other ministers or widows who should be receiving these checks their application should be filed with this board not later than Dec. 1, 1952.

4–PROTECTIVE INSURANCE

The amount of Retirement Insurance available through the National Board of Superannuation is still \$2,000.00 for each minister who can qualify. Application Blanks can be had by asking this board for them.

5-GEORGE P. BEST MEMORIAL FUND

The amount of the George P. Best Memorial Fund is still \$6,459.55. This fund is invested and earned \$194.09 this year in interest. This interest has been transferred to the Reserve Fund.

6-RESERVE FUND

The Reserve Fund is that amount of interest earned by the George P. Best Memorial Fund. The total of this fund is now \$1,499.84.

RECOMMENDATIONS

7-BUDGET

We recommend that our total budget for the next year be \$10,000.00 and that we ask our people to try to raise this amount by raising at least 25c per member.

8-AMENDMENT TO OUR CONSTITUTION AND BY-LAWS

We recommend favorable action upon the proposed amendment to the By-Laws of this Convention, that would establish the number of members of this board at five members.

9-MINISTERIAL RETIREMENT SYSTEM

We are submitting, for the approval of this Convention, a plan for a Ministerial Retirement System whereby the churches and pastors may work together in building up a fund from which the ministers may draw their pension upon their retirement. (See copy of plan attached.)

MINISTERIAL RETIREMENT SYSTEM

In order to help the ministers and other Christian workers of our great denomination to provide for their retirement or disability, the Board of Superannuation offers the following plan:

1-Membership: Those ministers or Christian workers of our denomination who are regularly employed by churches or other organizations of the denomination of our state may become members of this system by meeting the following requirements: A – There shall be an agreement between the employee and employer that they both enter this system by paying into the funds of this system equal amounts.

B - The above agreement shall be the payment into the funds of this system a designated percentage of the employee's salary received as compensation for service rendered and a like amount paid into the funds of this system by the employer. This payment shall be made not less than monthly.

2-Investment of Funds: The funds of this system shall be faithfully invested in an effort to increase the benefits for those belonging to the system. All earnings of the fund shall become a part of this fund except the amount that shall be used for the actual expense of the administration of this system. Gifts may also be made directly to this fund by those desiring to help provide greater benefits for our retired and disabled ministers. True and faithful records shall be kept of the payments into the fund by the member employers and employees and there shall be declared an annual dividend for each member based upon the earnings of the fund and the amount paid into the fund by the members.

3-Withdrawal from the System: Any employee member of this system may withdraw from the system at any time, but shall not be allowed to receive in refund more than the actual amount he or she has paid into the fund. In such case the employer member shall be permitted to determine the disposition of the actual amount paid by them. The accumulated profits for such member shall revert back to the funds of the system.

4-Benefits: At the time of retirement or permanent disability the minister or Christian worker shall begin receiving the payments of a pension based on the following schedule:

In cases where a member has paid varying percentages the monthly pension shall be based upon an average percentage for the time payments have been made.

These payments shall continue so long as the amount paid in by the member and his employer plus the accumulated earnings of the member shall last.

In case of the death of the member before all the benefits have been received, the remaining balance shall continue to be paid in like amounts to the widow or widower of the member. In the case of the death of both parties and in the event of the absence of provisions contained in a last will and testament the remaining balance shall revert back into the funds of this system.

5-Retirement and Disability: The age of retirement under this system shall be sixty-five (65). Permanent disability before the age of sixty-five (65) shall be established by a statement from the Moderator and Clerk of the conference or association to which the member belongs and from the member's family physician stating that it is their opinion that the member is permanently disabled to continue his employment.

6-Administration of the Ministerial Retirement System: The Board of Super-

annuation shall be charged with the responsibility of administering this system. Upon the adoption of this plan by the Convention the Board of Superannuation shall proceed to have suitable contracts and blanks prepared and offer this system to our ministers and Christian workers. The Board of Superannuation shall secure competent legal advice in preparing said contracts and blanks.

Greetings:

When we look at the facts given to us by the Promotional Secretary of the State Convention, of the number of leagues and league members in North Carolina, they should stop us and we should ask ourselves: what is the reason for this? One hundred and five leagues out of three hundred and fifty-three churches and three thousand and nine hundred and ninety-nine league members out of a membership of forty-six thousand and one hundred and fifty-six Free Will Baptists in North Carolina.

Seemingly we have forgotten or neglected the Great Commission of Our Lord and Savior Jesus Christ. He said, "Go ye therefore into all the world and teach them to observe all things whatsoever I have commanded you, and lo I am with you always even until the end of the world." Jesus is talking to us as a church. Dr. Evans in *Great Doctrines of the Bible*, says that one of the vocations of the church is to develop the personality of the individual believer. The League stated its purpose as being the training unit of our church. Let us see the league then as something that is for the whole church membership and not just for the young person. To the Delegates, Ministers, and Visitors of the 1952 session of the State Convention of Free Will Baptists of North Carolina Greetings:

On behalf of our North Carolina Free Will Baptist Sunday School Convention-Institute, it is my pleasure to bring you our report of our organization.

Sponsored by your state convention, our Sunday schools were organized into a state convention thirteen years ago at Little Rock Church, in Wilson County. Since that time our state Sunday school convention has grown steadily, until now we have an executive board that is rendering full time service to our schools throughout the state.

A brief statistical report of our last annual convention, which convened April .24 and 25 at our Orphanage, Middlesex, N. C., is as follows:

The attendance records for 90 schools were carefully estimated because they did not use six point records. All schools using these records have the best system of records, and they report in every instance that their use encourages students to become better Bible students, and to be more regular in attendance, studying the Bible, etc.

Our 1952 session authorized the executive board to hire a *Field Secretary* at the earliest possible date. Raymond T. Sasser has been hired as a part time Field Secretary and he is at work in the field, holding county wide Sunday School Rallies. Thus far rallies have been held at Kinston, Goldsboro and Greenville. Rallies scheduled to be held are as follows: New Bern, St. Mary's Church, Sept. 21;

Smithfield, N. C., Sept. 28; Aleo Church, East Rockingham, N. C., Oct. 5; and Edgemont Church, Durham, N. C., Oct. 12. Other rallies are being planned, and announcement will be made about them at a later date.

These rallies are for the purpose of encouraging our Sunday school leaders, the officers and teachers in each county, or otherwise geographically located district, to become more closely united in their activities, that they may learn to work together as a unit, all striving to make theirs a better group of Sunday schools. As soon as a full time secretary can be employed he will then begin to hold county wide training schools for officers and teachers, and other work of a Sunday school missionary and promotional nature. This work is scheduled to cover the state as fast as conditions will permit.

All schools are urged to support the State United Sunday School Program, which was authorized by the 1951 session of our convention. Each school supports this program by sending 10 per cent of its offerings each month to our state treasurer, Mr. Milton Wiggs, Smithfield, N. C. These funds are for three purposes: 1. To support Cragmont property expansion and Sunday School Institute work. 2. To support State Sunday School Field Secretary work. 3. To support the State Sunday School Convention program in general.

As a result of the practical usefulness of this plan for Cragmont, the executive board at its last meeting appropriated \$500.00 to help retire the debt on Cragmont, thus fulfilling the requirements of our constitution, by having the support of schools throughout the state who have regularly supported the United Program.

The support of this program has been gratifying, however there are some schools who have not yet begun to support it, and it is felt that the county rallies will better inform them of this program that they may see the need and rally to its support. The sconer more schools support it regularly, the sconer a full time secretary can be put on the field.

The 1952 session also took another broad step forward. For thirteen years our organization has seen the need of a Sunday School officers and teachers manual, a Free Will Baptist Manual. Since none was available, about six years ago the convention authorized its president to prepare this manual for publication. After six years of study and work on this project, holding several institute study courses with the manuscript he was ready at our 1952 session to offer it for publication. The convention immediately gave its spontaneous endorsement, and the manual is now being offered for sale to officers and teachers and prospective officers and teachers. The net proceeds from the sale of the manual are being contributed to the United Program by our president for use in Field Secretary work.

We urge each Sunday school in the state to order a dozen or two copies of this manual, its study by individuals and groups will make them better prepared officers and teachers.

To the 1952 session of our state convention of churches, the Sunday schools of our state extend hearty greetings and prayers for a most successful convention.

CONSTITUTION and BY-LAWS Of the North Carolina State Convention Of Original Free Will Baptists

PREAMBLE

We, the Original Free Will Baptists of North Carolina, assembled in order to advance, promote, and increase the cause of Jesus Christ, do establish and ordain this Constitution and these By-Laws.

Constitution

ARTICLE I

SECTION 1: This assembly shall be known as the North Carolina State Convention of Original Free Will Baptists.

SECTION 2: This Convention shall hold an annual session commencing on Wednesday after the second Sunday in September of each year. The place of such meetings to be determined by the Convention or the Executive Committee. Special sessions may be called by the Executive Committee in the event of the existence of needs of sufficient urgency.

ARTICLE II

SECTION 1: The officers of this Convention shall be a President, Vice-President, Recording Secretary, Assistant Recording Secretary, Promotional Director, and Treasurer.

SECTION 2: The Convention shall be composed of the general officers, members of standing boards, committees or commissions, and all ordained ministers who belong to churches that are affiliated with the convention; one delegate from each church in good standing; one delegate from each Union Meeting, Conference or Association in good standing for every one thousand members or a fraction thereof.

By-Laws

ARTICLE I

SECTION I: The work of this Convention shall be departmentalized, with a board of control over each department. Each board shall be governed by rules set forth by the Convention. It shall be the duty of the Convention to solicit the cooperation of the Conferences and Associations in promoting the work of these departments.

SECTION 2: All members of the Convention shall have a right of voice and vote on any issue before the body, providing they have been properly recognized by the Presiding Officer. They shall serve the Convention in any capacity when called upon by the proper authority. Before membership in the Convention is established, all ministers and delegates must be properly registered.

ARTICLE II

Officers, Boards, Committees and the manner of their election

SECTION 1: President: The President shall be elected for a term of two (2) years. He shall not be elected to succeed himself.

SECTION 2: Vice-President: The Vice-President shall be elected for a term of two (2) years.

SECTION 3: Recording Secretary: The Recording Secretary shall be elected for a term of two (2) years.

SECTION 4: Assistant Recording Secretary: The Assistant Recording Secretary shall be elected for a term of two (2) years.

SECTION 5: *Promotional Director*: The Promotional Director shall be elected for a term of one (1) year under such contract as may be agreed upon by himself and the Convention or its Executive Committee. In case of a vacancy in this office between sessions of the Convention the Executive Committee shall fill the vacancy until the next session.

SECTION 6: Treasurer: The Treasurer shall be elected for a term of two (2) years.

SECTION 7: Orphanage Board: The Board of Trustees of the Free Will Baptist Orphanage, Middlesex, shall be composed of nine (9) members with the terms of three members expiring each year, the vacancies to be filled by the Convention.

SECTION 8: Board of Superannuation: The Board of Superannuation shall be composed of five members with the term of one member expiring each year; the vacancy to be filled by the Convention.

SECTION 9: Board of Missions: The Board of Missions shall be composed of five (5) members with the term of one member expiring each year; the vacancy to be filled by the Convention.

SECTION 10: Board of Christian Education: The Board of Christian Education shall be composed of five (5) members with the term of one member expiring each year; the vacancy to be filled by the Convention.

SECTION 11: Board of Trustees: The Board of Trustees shall be composed of three (3) members with the term of one member expiring each year; the vacancy to be filled by the Convention.

SECTION 12: Representatives of Cragmont Assembly Stock: The Stock held by this Convention in Cragmont Assembly, Inc., shall be represented by three members with the term of one member expiring each year; the vacancy to be filled by the Convention.

SECTION 13: Representative of Free Will Baptist Press Stock: The stock held

by this Convention in the Free Will Baptist Press shall be represented by one member elected annually by the Convention.

SECTION 14: Representative of Church Finance Association Stock: The stock held by this Convention in the Church Finance Association, Inc., shall be represented by one member elected annually by the Convention.

SECTION 15: *Historical Commission:* The Historical Commission shall be composed of three members with the term of one member expiring each year; the vacancy to be filled by the Convention.

SECTION 16: *Executive Committee*: The Executive Committee shall be composed of the President, Vice-President, Recording Secretary, Treasurer and three members elected by the Convention for a term of two years.

ARTICLE III

Duties and Responsibilities

SECTION 1: *President:* It shall be the duty of the President to preside over each session, preserve order, govern the body according to established parliamentary usage and appoint all temporary committees. He shall have power to declare any office of the Convention vacant, temporarily, subject to the approval of the Convention or the Executive Committee. He shall have authority to call meetings of the Executive Committee, when such is needful, and preside over said meetings.

The President shall be ex-officio member of all boards, standing committees and commissions of the Convention.

SECTION 2: Vice-President: The duties of the Vice-President shall be the duties of the President when that officer is not present.

SECTION 3: Recording Secretary: The Recording Secretary shall keep an accurate record of the transactions of the Convention and preserve the same, keep all valuable documents and surrender the same to his successor in office.

SECTION 4: Assistant Recording Secretary: The duties of the Assistant Recording Secretary shall be the duties of the Recording Secretary when that officer is not present and to assist the Recording Secretary when called upon.

SECTION 5: Promotional Director: The Promotional Director shall maintain an office for the purpose of centralizing the work of the Convention. He shall prepare statistical tables necessary to keep the Convention informed as to the growth and progress of the denomination. He shall work with the Convention, the Executive Committee, all boards, committees and commissions of the Convention in placing the work of the denomination before the various bodies of the state for their information and support; also perform any other promotional duties as directed by the Convention or the Executive Committee.

When designated by a board, committee or commission the Promotional Director shall receive and (or) pay out any money controlled by said board, committee or commission as directed by them.

The Promotional Director shall be ex-officio member of all boards, standing committees and commissions of the Convention, there is a standard stand SECTION 6: Treasurer: The Treasurer shall hold all money belonging to the Convention. He shall pay all bills ordered by the Convention or the Executive Committee; other bills paid must be approved by the President and Recording Secretary. He shall give an annual report to the Convention; also make reports to the Executive Committee when called for,

SECTION 7: Orphanage Board: The Orphanage Board shall be responsible for the management and control of the Free Will Baptist Orphanage at Middlesex. It shall give an annual report to the Convention setting forth its progress, needs and achievements.

SECTION 8: Board of Superannuation: It shall be the purpose of this Board to organize and unify all superannuation work throughout this State Convention. They shall seek to provide for our aged, retired and infirm ministers in some form of a superannuation program; also seek to offer to our active ministers some program whereby they may help to provide for their future security and retirement.

SECTION 9: Board of Missions: The Board of Missions shall regulate and supervise all mission work under the control of this Convention. It shall co-operate with the Mission program of the National Association. It shall endeavor to raise money for missions and build sentiment favorable to missions.

SECTION 10: Board of Christian Education: The Board of Christian Education shall keep our people informed as to our educational needs; endeavor to promote the cause of, receive funds for and stimulate interest among our people in the cause of Christian Education. It shall be their duty to co-operate with the educational institutions of our denomination and use all funds for the best interest of Christian Education as directed by this Convention and the donors of funds for education.

SECTION 11: Board of Trustees: The Board of Trustees shall hold title to all property belonging to this Convention. It shall have power to convey such property when authorized by the Convention.

SECTION 12: Representatives of Cragmont Assembly Stock: The Representatives of the stock held by this Convention, in Cragmont Assembly, Inc. shall work jointly with representatives of other auxiliaries holding stock in said institution.

SECTION 13: Representative of Free Will Baptist Press Stock: The Representative of the stock held by this Convention in the Free Will Baptist Press shall meet annually, or as often as called upon, with the stockholders of the Press at Ayden, N. C., to transact any business that may come before them.

SECTION 14: Representative of Church Finance Association Stock: The Representative of the Membership Stock held by this Convention in the Church Finance Association, Inc., shall meet annually, or as often as called upon, with the stockholders of the corporation for the purpose of transacting any business that may come before them.

SECTION 15: *Historical Commission:* The Historical Commission shall make research, compile same and record historical events of the denomination to date; these documents become the property of the Convention and shall be held by the Recording Secretary.

SECTION 16: Executive Committee: The work of the Executive Committee shall

be that of the Convention when the Convention is not in session. It shall call as many sessions as necessary between the annual sessions of the Convention to transact business. It shall have the authority to suspend any officer of the Convention when such officer proves a failure in duties, proves non-Christian or detrimental to the cause of Christ and appoint another to fill the vacancy; also fill vacancies made by any other cause.

The Executive Committee shall supervise the work of the Promotional Department between the annual sessions of the Convention as most practicable to our state work and in keeping with the expressed will of the annual sessions of the Convention.

A report of all transactions of this Committee shall be made to the Convention in annual session.

AMENDMENTS

This Constitution and these By-Laws shall not be changed or altered except by a two-thirds vote of members present in a regular session. All amendments shall lie on the table not less than six hours prior to adoption and shall, during that time, be read not less than twice in open Convention.
