Report of Resolution Committee

- Art. 1. We, your Committee on Resolutions, recommend that the Ohio State Association of Free Will Baptists go on record as being opposed to dancing, card parties, bingo games and all places of amusement where these things are practiced or allowed.
- Art. 2. And that we refrain from visiting all places where intoxicating liquors are handled in any form, and members who fail to abide by this resolution be called to question by the Association before a committee of their peers, and on being found guilty, and fail to show true repentance, they be excluded from fellowship.
- Art. 3. We recommend that this Association appoint a Foreign Mission Board to take care of our mission work.
- Art. 4 We recommend that a program committee be appointed to prepare a program for the next State Association and when said program is complete that a copy be sent each member of the Publicity Committee.

Art. 5. That this Association appoint an Incorporation Committee.

Motion carried we retain the Credential Committee for the next Association.

Motion carried we dismiss the following committees: Business, Minute, Resolution, Finance, and Pulpit. Dismissed with prayer.

# Constitution of Ohio State Association of Free Will Baptists

- Art. 1. This Association shall be called the Ohio State Association of Free Will Baptists, and shall be composed of all regularly well organized and well disciplined Free Will Baptist Yearly Meetings as may embody themselves under this constitution.
- Art. 2. The purpose of this Association is for the promotion of the cause of Christ among our people, and to bring about a better spirit of union among our several Quarterly Meetings.
- Art. 3. The officers of this Association shall be a Clerk and Treasurer, who shall serve at the pleasure of this Association, a Moderator who shall be elected one year in advance of the year he shall serve.

- Art. 4. The members of this Association shall consist of one
  (1) delegate from each church, together with all ordained
  authority belonging to same.
- Art. 5. Any well organized and well regulated Yearly Meetings in the State, shall, by application and conforming to the usages of the Free Will Baptist denomination, be received into this Association by a majority vote of this Association.
- Art. 6. The sessions of this Association shall be held annually on the first Tuesday in June of each year; the place being in one of the various Yearly Meetings, in rotation, and placed by vote of the Association until each have had an Association, and repeated, etc.
- Art. 7. This Association shall have power to adopt any regulations and by laws that are consistent with this constitution and not repugnant to any constitution or usages of the Free Will Baptist denomination.
- Art. 8. This constitution may be altered or amended by vote of this Association at any session by a two-thirds majority vote.

### By-Laws of Ohio State Association of Free Will Baptists

- 1. The clerk shall call the conference to order, and in his absence the oldest minister present shall call the conference to order.
- 2. It shall be the duty of each body belonging to the Association to send a letter giving statistics of the body.
- 3. Each meeting shall be opened by reading of Scripture and prayer.
- 4. The Association shall sit with open doors except when it goes into a committee as a whole.
- 5. No person shall nominate more than one, if that person be elected.
- 6. The moderator shall not allow any conversation except it be in a Christian Spirit, or when he thinks it will cause discord.

- 7. Anyone desiring to speak must rise to his feet and address the moderator.
  - 8. Voting must be done by the showing of the right hand.
- 9. No member shall be allowed to speak more than twice on any subject and not more than five (5) minutes at a time.
- 10. It shall be the duty of the moderator to sit the delegates in a body in a convenient place.
- 11. These By-Laws may be altered or amended by a two-thirds vote of members present.
- 12. All ordained authority and licentiates are standing members.
