REPORT OF EXECUTIVE COMMITTEE - 1967

The Executive Committee met two times during the year.

On March 18, we met at Chillicothe Church at 10:00 A.M. with all members present.

A general discussion was the business, taking in consideration all the work of the Association.

The Editor gave his report of THE AMBASSADOR, and was willing to relinquish the job of publishing the paper.

The Committee ask that the Editor continue on in his work.

No definite action was taken in this meeting, but we talked of various ways to improve the State Association and some of its problems.

On April 7th, Friday night, 7:00 P.M., the Committee met again. All members present.

The first item of business was making up the program for the Association June 23, 24 at Akron.

The Executive Committee was aware of the situation and status of the Mission Board concerning an item which the Association adopted in 1963, concerning a member of the board who was employed by the board.

The rule says that upon acceptance of employment his membership on the board was automatically terminated.

The Committee further noticed that:

Inasmuch as Clarence Newman, a member of the board and secretary-treasurer, had taken over the work in Youngstown he had become an employee of the Association.

Due to the shortness of time until the Association and the money would involve a change, and it has taken almost two years to get it where it belongs, the Committee felt that we should wait until the Association meets and act on it.

The Association may hold us responsible for not taking any action, but we thought this best.

It was also noted by the Committee that the various areas that the Association voted to do had not proper representation on the Mission Board. (Explain) 2 - 2 - 2 - 1.

The following recommendation was to be brought to the Association:
That the Friday night session revert to the past as a regular service rather than a Missionary service. The reason for this is since we have had these services no missionary was present, ~~and the service was not held~~

The Executive Committee further recommends that we ~~should have~~ some different type of finance for the Association as we barely have enough to operate now. Our expenses increase every year.

We also noted the lack of interest of the churches in sending a free will offering to the State Association; only around 44 sent last year and we have around 110 churches. We agreed that the secretary send a letter to the pastor of our churches reminding them that the method of financing the Association is by this method.

The Executive Committee is willing to work out a plan if the Association so desires.

We discussed quite at length the placing of the Association as was voted by the Association. This takes a lot of time and careful consideration, and we don't want to act too hastily. However, the Committee is willing to still continue to come up with some workable plan to locate future sites of the Convention.

(abandoned idea for time being)

The Association last year voted that the Clerk pursue the matter further of the idea of bringing the National Association to Ohio in 1969. The Clerk informed the Committee he had done this, having spent the biggest part of a day in Cincinnati with Billy Melvin. They went over the entire plans for the Association such as hotels, motels, meals, lodging, and the convention site itself. Cincinnati was the only likely town as some of the rest of the cities did not have facilities in that month. Billy Melvin mentioned Cleveland but we feel it is too remote for the Association. Both Mr. Melvin and the Clerk feels at this time we are not in a position to invite the National Association.

REPORT OF EXECUTIVE COMMITTEE ACTING AS CREDENTIALS COMMITTEE.

On June 19th, 7:00 P.M., three members of the Executive Committee, met to check the letters, delegates, ministers from the four Yearly Conferences.

This was done because we did not know whether we would have enough present at the beginning of the Association. Bro. Harness, Bro. Williams and myself were present as we lived close by.

In checking the letters we found everything to be in order with one exception - that the letters did not have all the statistics, and our report when sent to the National will be just a partial report.

We have URGED our churches, Quarterly Conferences and Yearly Conferences to please send in their complete statistics so we can send a complete report to the National Association.

We recommend that the letters be accepted and delegates be seated in the Association. Dues were missing from Great Lakes Conference.

Read 1st.

The Executive Committee noted from the Miami Yearly Conference a recommendation to the State Association: that we have a centrally located office in the central part of the State. We discussed this quite at length and wondered about the wisdom of this item.

The Secretary called Paul Thompson, Conference Clerk, relative to this and it was the understanding that the Editor of THE AMBASSADOR was going to resign, and if so, the office should be in the central part of the State.

However, the Editor is still going to publish THE AMBASSADOR and after taking in consideration all the details, the trouble it would be, the cost and many more things too numerous to mention, we recommend that the principal office be still be located in the same place under the present set-up.

However, the Executive Committee feels that if the State Association grows and the finance comes in and we need a new location in the central part of the State then we are in favor of this.

However, our finance as of now does not meet the present needs, first of our Association, and 2nd of our Mission Work, so we could not operate a State Office as it should be.

This special recommendation was made concerning the work of "THE AMBASSADOR". We have given our Editor a complete vote of thanks and confidence and are aware of the amount of time and expense that is involved in this work.

We also feel THE AMBASSADOR has played an important part in our Association. The Association voted that our promotional work be done through THE AMBASSADOR, which has efficiently been done by the editor.

The executive committee is in charge of the paper and the editor works under them. He also reports to the committee when they meet the financial status of the paper, this has been done efficiently.

Although the committee could set the salary of the editor, we have let the Association do this. The editor at the present time received \$100.00 per month for publishing THE AMBASSADOR. The Association pays \$25.00 per month for the Assistant Editor and \$25.00 for the office, such as heat, light, telephone, etc. The Executive Committee RECOMMENDS: that the editor be given extra money for expenses as he takes this out of his salary and this involves a lot. This amount is ^{be} ~~to~~/designated by the Association. We also have to keep in mind the expense of the Association.

We feel the editor has done a very good job and we have asked him to stay on as editor.


Dear Brethern:

REPORT OF THE AMBASSADOR

Although I work under the direction of the Executive Committee, as authorized by the State Association, I feel I should give a detailed report to the body itself. The AMBASSADOR serves as the promotional arm of our association and we feel

We feel this has been another good year in publishing THE AMBASSADOR in many ways. We have the largest circulation of any State magazine of its size, over 2900. We have operated in the black again this year, and after considering our method of financing, this is amazing.

EXPLAIN METHOD OF FINANCE. Churches, Conferences, Offerings, Individuals, February - AMBASSADOR MONTH, over \$800.00 received.

Name some of the equipment

This is quite a task rather than just editing what we publish, we must have equipment to do the job, cut my own stencils, file them in Zip Code order, address all of them, bundle them, keep mailing list up to date, do bookkeeping, send out hundreds of letters each year.

Numerical Sequence

I receive \$100.00 a month salary; all my expenses are taken out of this, several trips to printer, to the post office, buying supplies, etc. I tried to give up this job but the Executive Committee asked me to stay on and gave me a complete vote of confidence.

The Assistant Editor has resigned due to her health, and Charity Sparks and Dorothy Harness agreed to be the Assistant Editors. Both are qualified and capable of this task and their willingness to help us is deeply appreciated. The mailing of the paper is more complicated than ever since the new Zip Code System has gone into effect. My wife and I used to do the mailing but now it takes three. My wife does all the tying, stapling and bundling. This takes about five hours to complete. She also helps me keep the mailing list up to date. We can no longer give THE AMBASSADOR away free of charge as it costs too much. (Go over complete mailing list.)

In June's issue I could have had 24 pages as I had enough material but I had to cut down.

Note. My salary comes out of the money sent for the ambassador and personally I don't think it should. (EXPLAIN)
