51st. Annual Session of the OHIO STATE ASSOCIATION OF FREE WILL BAPTIST THEME

"REACHING A LOST WORLD FOR CHRIST"

On June 23,1989 at 9:30 A.M. the 51st annual session of the Ohio Association of Free Will Baptist convened at Heritage Temple Free Will Baptist Church, Columbus, Ohio. The meeting was opened by congregational singing led by Richard Davis. The clerk, Mike Stokes, then called the association to order and introduced the moderator, Edwin Hayes.

Moderator Hayes introduced the pastor of Heritage Temple, David Boggs, who welcomed the association to Columbus and to Heritage Temple.

The moderator's message to the association was taken from Luke 15:1,2. The theme of his message was,"Reaching a lost world."

The clerk then informed the association that all credentials were in order and the moderator proceeded to seat all delegates in the center aisles.

The clerk was then called upon to give the general board report. Item 1) Board members present 10, absent 7. The board voted on and approved George Grice as proxy for Ron Parker from Pine Creek and Oziel Jeffries as proxy for David Trustey from North and Western.

- Item 2) The clerk read a letter of resignation from assistant moderator, Mike Mounts, who informed the board that he has accepted a pastorate in Millport, Alabama. Delmar Sparks was elected by acclamation to fill brother Mounts unexpired term.

Item 6) The Ohio Mission Board report was given by Roy Hutchinson. Brother Hutchinson informed the board that Tom Dooley missionary to Hamilton has resigned for health reasons and that missionary David McGowen will assume that work in July. The general board recommends that the report and proposed budget of the mission board be adopted. Item 7) The Board of Directors report was given by chairman Hobert Ashby. The board presented a Constitution and By-Laws designed to govern the board of directors. The general board recommends it's radification and that the report and projected budget of the Ambassador Bookstore and State Office be adopted.

Item 8) The Executive Secretary report was given by Alton Loveless.

There was a motion and second to receive the report. Then the association proceeded to vote on items 2 and 3 which were approved. Item 7 to be considered in the afternoon session.

The moderator then called for congregational singing while the right hand of fellowship was given to visitors Herman Hersey Director of the national board of retirement, A.J. Looper director of the Free Will Baptist Childrens Home in Greenville, Tennessee, Fred Warner from the National Foreign Mission Board, Bill Fulcher from Southeastern Free Will Baptist Bible College, and Melvin Worthington from the National Office.

Moderator Hayes then called for reports from various departments. Report of the national office was given by Executive Secretary, Melvin Worthington, received.

Report of the Free Will Baptist Childrens Home was given by director, A.J. Looper, received.

Report of the National Home Mission Board was given by, Willie Booth, Ohio home missionary, received.

Report of the Southeastern Free Will Baptist College was given by, Bill Fulcher, received.

Report of the OYC was given by, Manuel Lopes, received.

Report of the National Foreign Mission Board was given by, Fred Warner, received.

There was a motion and second to adjourn from business until the afternoon session. Voted on and carried.

An offering of \$117.63 was received from the congregation. Special singing by, Cindi Porter. The message from Acts 1:8 entitled, "The Power of the Witness" was delivered by, Wendell Combs, Pastor of the First Free Will Baptist Church Chillicothe, Ohio.

AFTERNOON SESSION

The afternoon session was opened by congregational singing let by, Richard Davis. A devotion from Matthew 18:11 was led by, Danny Cline.

The moderator then called the association to order and introduced the board of directors chairman Hobert Ashby, to give their report. The moderator then called for the reading of item 7 in the general board report which is a recommendation from the general board that, the proposed constitution and by-laws of the board of directors be adopted. The board of directors report and item 7 of the general board report were voted on and approved.

Alton Loveless then gave a detailed report of the State Office and Bookstore. Brother Loveless reported that Free Will Baptist in Ohio were moving forward. Report received and approved.

Report of the Womans State Auxiliary was given by Vice President, Zerina (zee) Shopbell. Sister Zee reported that Auxiliary members reporting were 384 from 28 auxiliaries. Four local auxiliaries reported who does not belong to a district. Five districts reported. Two auxiliaries were added this year. Their projected goal for 1989-90 is \$9,500.00. New officers elected this year are: President, Barbara Chaffin; Vice President, Zerina Shopbell; Field Worker, Delois Loveless; Secretary, Clara Widdig; Treasurer, Catherine Rapp; Members at Large, Barbara McArther, Betty Ashby, and Judi Dempsey, received.

Nashville Free Will Baptist Bible College report was given by, Bob Shockey, director of student support department. Brother Shockey reported that the Pass the Torch campaign ended May 31,1989, and that Ohio gave \$30,372.24. Enrolement at the college for 1988 - 1989 was 345 with 15 students from Ohio. Received.

Report of Hillsdale Free Will Baptist Bible College was given by, Richard Terry. Brother Terry reported that president Edwin Wayde has retired and that Jim Shepherd was now president of the college, received.

Report of the National Association Meeting last year in Kansas City was given by A.J. Dooley, received.

The moderator then ask for volunteers to go as delegates to the national association meeting in Tampa, Florida. Delegates appointed are: A.J. Dooley, Mary Dooley, Doris Ball, Delois Loveless, Janueta Jewell.

There was a motion and second to adjourn from business until Saturday morning. Voted on and carried.

FRIDAY PM SERVICE

Presiding, Rev. Delmar Sparks. The service was opened with prayer and congregational singing. Manuel Lopes then presented CTS activity awards to division winners who will represent Ohio in national competition. Brother Alton Loveless then presented an appreciation plaque to Herman Hersey for his 50 years of ministry in Free Will Baptist.
