6<sup>th</sup> Enquired into the expediency of sending a delegate to General Conference & appointed a committee to Nominat

7<sup>th</sup> The committee returned a nomination of Elders Lemuel Thorn which was approved by the Conference & Bro Seth Barrett as a substitute

8<sup>th</sup> Call'd a vote to dispose of the money in the treasury for the use of the delegate's expenses to the general conference which was in the affirmative

9<sup>th</sup> Given order to Bro S. Thorn Delegate to General Conference on the Treasurer of this Quarterly Meeting for money in his care
