## CONSTITUTION

## of the

## **Palmer Association of Free Will Baptists**

## ARTICLE 1. NAME AND PURPOSE.

This organization shall be known as the Palmer Association of Free Will Baptists and by this name shall it be designated in all its work, government and fraternal relations. The general purpose of the Association shall be the exaltation of Christ, the great Head of the Church, the edification of its members through the effective teaching and mutual encouragement in the use of the manifold means of grace; the unification of the methods and programs of its affiliated churches and subordinate organizations; and the coordination of persistent efforts in church extension, Christian education, benevolence and evangelism.

## **ARTICLE 2. COMPOSITION.**

This association shall be composed of churches, ordained and licensed ministers who are members of churches that are associated with the association and recommended by the membership committee and accepted by the body in session and approved by the messengers from the churches.

## **ARTICLE 3. REPRESENTATION.**

Voting privilege shall be accorded to all approved ordained ministers of the association who remain above reproach and five messengers from each church and one additional messenger for every 100 members or fraction thereof, properly seated.

## **ARTICLE 4. GENERAL OFFICERS.**

The general officers of the association shall be a moderator, an assistant moderator, a secretary-treasurer, an assistant secretary-treasurer, each of whom shall be elected for a term of two years beginning at the close of the annual session at which they are elected.

## **ARTICLE 5. COMMITTEEES.**

Section 1. The Executive Committee shall consist of the general officers of the association together with two members elected from the churches at large for a term of two years. It is understood that this committee has no authority other than that which is expressly stated in this constitution and by-laws.

Section 2. AMembership Committee of six members shall be elected for a term of three years, the tenure of two expiring each year.

Section 3. A Quarterly Fellowship Program Committee consisting of three members shall be elected for a term of two years.

Section 4. A Youth Committee consisting of three members shall be elected for a term of two years.

Section 5. A Digest Committee consisting of three members shall be appointed by the moderator at each annual session to serve only during that session.

Section 6. A Finance Committee consisting of three members shall be appointed by the moderator at each annual session to serve only during that session.

Section 7. A Committee on Committees consisting of five members shall be elected at each annual session to serve only during that session.

Section 8. Special committees may be elected or appointed at the option of the association.

## **ARTICLE 6. ORDINATION.**

The Palmer Association recognizes that the authority to ordain ministers has its source in the local church.

## **ARTICLE 7. MEETINGS.**

Section 1. The annual session of the association shall meet on the second Saturday in May at 9:30 a.m.

Section 2. The Quarterly Fellowship meetings shall meet on the second Saturday in August, November and February at 9:30 a.m.

## **ARTICLE 8.**

The Reporting Year for Associational Churches shall be April 1 through March 31.

# ARTICLE 9. AMENDMENT.

This constitution may be amended at any regular session by a two-thirds majority vote of the messengers present.

#### **BY-LAWS**

## **SECTION 1. OFFICERS.**

No person shall serve more than four (4) years successively in any one office or combination of offices.

A. The moderator shall preside according to accepted parliamentary procedure over the sessions of the association.

B. The duties of the assistant moderator shall be those of the moderator when the latter shall so direct or when he is absent.

C. The secretary-treasurer shall record the proceedings of all sessions of the association and preserve an accurate record of said proceedings in a book provided for this purpose. He shall hold in trust all money that belongs to the association and pay out same by order of the association. He shall keep an accurate account of all funds received and paid out and make an annual report accordingly to the association.

D. The duties of the assistant secretary-treasurer shall be those of the secretary-treasurer when the latter shall so direct or when he is absent.

## **SECTION 2. COMMITTEES.**

A. The Executive Committee shallplan the program for the annual session in consultation with the host pastor. They shall perform any other duties as directed by the association in session.

B. The Membership Committeeshall examine the credentials of ministers who apply for membership in the association and applications of churches that desire membership in the association and shall make recommendations according to their judgment.

C. The Quarterly Fellowship Program Committee shall plan the program for the Quarterly Fellowship meetings in consultation with the host pastor.

D. The Youth Committee shall plan, promote and direct youth ministries and activities within the association and shall present an annual report of activities and finances.

E. The Digest Committee shall receive the annual reports from the churches and compile a digest of information contained therein and report the same.

F. The Finance Committee shall compile a financial status of the association and make recommendations accordingly.

G. The Committee on Committees shall make nominations for each standing office and committee member whose term expires or is left vacated and present the same.

## **SECTION 3. MEETINGS.**

A. The Annual Meeting shall be for the purpose of fellowship, inspiration, and the transaction of business.

B. The Quarterly Meetings shall be for the purpose of fellowship, inspiration, and instruction in the work of the Lord.

## **SECTION 4. ORDINATION.**

The Palmer Association recognizes the authority of the local church to ordain men to the ministry of the gospel. It further recognizes the authority of the local church to ordain men to general Christian ministries. The following is suggested procedure in the ordination of a minister.

A. The Candidate should be licensed for at least one year.

B. The church should call together at least three ordained Free Will Baptist ministers to examine the candidate as to doctrine and general qualifications. The committee should make written recommendations to the church.

C. The ordination service generally includes a sermon, presentation of the Bible, charge to the candidate, laying on of hands and prayer of dedication.

## **SECTION 5. PROVISION FOR MEMBERSHIP.**

A. Churches. — Each church which is a member of the association is required to represent by written report and messengers from the church at each meeting. In the event this cannot be done a letter must be sent to the association stating the circumstances. Regular attendance and communication must be maintained with the association to remain in good standing.

B. Ministers. — Each ordained and licensed minister who is a member of the association is required to attend 75 percent of the regular meetings. In the event an absence becomes necessary a letter must be sent to the association stating the circumstances. When a licensed or ordained minister is attending an educational institution and is unable to attend, a letter must be sent to the association stating the same. Regular attendance and communication must be maintained with the association to remain in good standing.

## **SECTION 6. AMENDMENT.**

These by-laws may be amended at any regular session by a two-thirds majority vote of the messengers present.

## MINUTES of the Third Annual Session of the PALMER ASSOCIATION OF FREE WILL BAPTISTS

## Saturday, May 10, 1975

# Bethel Free Will Baptist Church Kinston, North Carolina

The session was opened promptly at 9:30 a.m. with congregational singing led by Billy Oliver from the host church.

David Paramore, the host pastor welcomed the session to Bethel Church. Devotions were presented by Jim Markum, pastor of Trinity Church in LaGrange. Scripture was read from Isaiah 1:7 and I Timothy 4:1 and he spoke on the subject of "Our Country Is Desolate".

The Moderator, Robert Durham, welcomed the Pastors, Messengers, and visitors to this session.

Special music was presented by a young men's quartet from the host church.

The following were appointed to the Digest Committee by the moderator: Philip Cooper, Gordon Hart and David Paramore.

The following were appointed to the Finance Committee by the moderator: L. B. Coley, Harley Bennett, and Gordon Sebastian.

The minutes of the Second Annual Session dated Saturday, May 18, 1974, convening at Gethsemane Church in Wilson were read and approved.

The session reconvened by the call of the moderator. Tommy Godley gave a report of the new mission work at Farmville. A letter from our State Evangelist, Ronald Creech, was read by the moderator. A motion was made and passed that the facts of this letter be included in the minutes. They are as follows:

"I want to thank you for the support the Palmer Association churches have given to the work of the North Carolina Association of Free Will Baptists. On behalf of all of our departments, I send sincere thanks and appreciation.

A check into the matter the other day revealed that North Carolina had given \$267,407.35 to the causes of the National Association in 1974. That is fantastic! I do want to commend our churches. I do not want to take away from that one minute nor pour any cold water on our enthusiastic rejoicing over it. But I do want to point out that the combined budgets in North Carolina are about \$55,000.00. Sometimes we have difficulty reaching our budgets.

Brethren, this ought not to be! Let's not cease doing one thing we are doing for the National Association, but at the same time, let's take care of our North Carolina causes too. Please get the North Carolina work in the budget of your church.

Thanks for all that you have done for the State Association in the past. Please increase your giving if you can."

# Report of the Study Committee on Constitution and By-Laws

The following recommended changes were proposed, considered and adopted:

1. Under Article 2, Composition, insert the following words after the word association: "And recommended by the membership committee and accepted by the body in session."

2. Under Article 3, Representation, insert the following words after the word accorded: "All approved ordained ministers of the association who remain above reproach"; strike out the words: "the pastor of each church in session"; add the words "properly seated" after the word thereof.

3. Under Article 7, Meetings, add Section 1 for Annual Meetings and add 9:30 a.m. as the time to meet. Add Section 2 for Quarterly Fellowship Meetings which shall meet on the second Saturday in August, November and February at 9:30 a.m.

4. Add Article 8, Reporting Year for the associational churches shall be April 1 through March 31.

5. All officers and committees are to be properly inserted with information as to number of members, terms of office and method of selection.

Dear Brother Pastor:

On March 11th, Sandra Dupree, wife of Harvey Dupree, pastor of Hope Free Will Baptist Church, Scotland Neck, North Carolina, shot a man who subsequently died March 15th.

The basic facts of the case are as follows:

1. Sandra's son, Mark, had been assaulted previously by juveniles and a 24 year old adult while on his paper route.

2. Sandra went out looking for Mark on March 11th and found him being assaulted by a 21 year old black man. She attempted to free Mark and the attacker turned on her.

3. After being knocked to the ground 4 times, glasses broken, clothing torn and beaten, she was able to get a pistol from her purse, carried because of fear of assault, and shot the man. After his death March 15th she was charged with first degree murder, denied bail and is now held in Halifax County Jail, Halifax, North Carolina.

4. Racial tension in the area has complicated the case demanding that Sandra have the best legal defense possible.

Defense for Sandra will cost in excess of \$20,000. She has no source except her own Christian friends throughout the Free Will Baptist Churches. We are therefore appealing to you, a North Carolina Free Will Baptist pastor, to urge your people to give to her legal defense fund. Your IMMEDIATE response is needed. The trial is now set for June 7th. We suggest that you either receive offerings or appoint a committee in your church to receive gifts for Sandra. Again, this is URGENT! Please do something now.

In addition, we are urging all of our people to pray for Sandra, her husband Harvey and her 4 children. On May 15th we are suggesting a special day of prayer and fasting. During the week of her trial, June 7-13 we are asking all of our people to pray each morning at 7 o'clock.
