CONSTITUTION

Article I. This association shall be called the Piedmont Association of (original) Free Will Baptists.

Article 2. This association shall be composed of delegates elected annually by the Free Will Baptist churches cooperating with this association and ministers who are members of this association.

Article 3. The officers of this association shall be a moderator, vice-moderator, clerk and treasurer.

Article 4. Each church shall be entitled to three delegates, and one additional delegate for every fifty members over one hundred.

Article 5. The churches cooperating with this association shall send by the hands of their delegates a full account of all work done by them during the year and all such statistics and information as will be interesting and helpful.

Article 6. This association shall meet once a year at such time and place as may be agreed upon by the preceding session or by its executive board.

Article 7. The executive board shall consist of three members elected by the association, one for one year, one for two years and one for three years. The associational officials are members ex-officio of the executive board. The executive board shall have interim authority.

Article 8. Ministers in good standing in our sister associations may be invited to a seat and take part in the deliberations and his name enrolled in our minutes.

Article 9. The association may withdraw from any church that becomes disorderly or refuses to represent by letter or delegate.

Article 10. This association shall encourage a sound ministry such as presents Christ as an all sufficient Saviour, having salvation possible to every human being on the terms of the gospel which is freely offered to all.

Article 11. This association assumes no higher authority than an advisory council.

Article 12. This constitution may be amended at any annual meeting of the association by a two-thirds vote of the delegates attending, providing that a notice of such change shall have been given during the first setting of said meeting after permanent organization.

RULES AND REGULATIONS

Associational officials are to be elected by ballot system.

The moderator, vice-moderator and treasurer are to be elected at the close of the session.

The ordination council is to be elected by the association.

The ordination council is to consist of five members and has interim authority to ordain ministers and has charge of investigations of ministers.

The ordnation council must report its work annually to the association.

The executive board is to make an annual report to the association.

The Treatise of Faith and Practice of Free Will Baptists is to be used.

The body sponsors the Ministers' Conference.

The body sponsors the Sunday School Convention.

The body sponsors the Woman's Auxiliary Convention.

The body sponsors the F. W. B. League Convention.

The Seven-Point Program of the state association approved.

The indefinite pastor call approved.

When a church calls the ordination council, it is to pay their expense.

The executive board has charge of the associational education program.

The chairman of each board or committee is treasurer of its funds.

The churches sending preachers and delegates to the association are to pay for their board; the host-church will provide all the sleeping quarters they can, and arrange for rooms that may be rented.

The minute fund changed to general fund, and all churches are requested to send 10c per member with church report.

The moderator authorized to appoint from the floor the nominating committee, consisting of five men to nominate, moderator, vice-moderator, treasurer and ordination council. The body may place nominations from the floor for each office.

ORDINATION QUALIFICATIONS

1. A Bible course satisfactory to the ordaining council.

2. If a minister cannot meet the standard but shows satisfactory fruits in his ministry, he may be ordained.

3. A minister must be a tither in order to be ordained.

No man can hold more than one associational office.

RECORD OF PROCEEDINGS

FRIDAY MORNING, AUGUST 19, 1955

The Piedmont Association of the original Free Will Baptists of North Carolina, convened in annual session with the Wayside Free Will Baptist Church of Charlotte, North Carolina, August 19, 1955.

The service was opened by the congregation singing "Standing on the Promises," led by Rev. Sherman Branch.

Rev. William T. Allen opened the devotional by reading Psalm 133, and urging that *unity* be the watchword for the day.

Rev. J. B. Starnes led in prayer.

The house was called to order by the clerk, Rev. R. J. Reynolds.

The moderator was introduced to the body by the clerk.

Rev. Roy Rikard, the moderator, made the announcements.

The welcome address was then given by the host pastor, Rev. Reynolds. The response was given by Rev. L. H. Clayton.

The moderator called for nominations for clerk. Rev. R. J. Reynolds and Rev. William T. Allen were nominated. Rev. Allen was elected by a majority vote.

Motion made and seconded that we give a rising vote of thanks to Rev. Reynolds, the former clerk, for the past year's work. Motion carried.

The following visitors were recognized: Rev. A. W. Lawter, Rev. Carl Shook, Rev. J. B. Starnes, Rev. Seldon Bullard and Rev. J. W. Alford.

Motion made and seconded that we extend to the visitors all privileges in this conference except the privilege of voting. Motion carried.

Motion made and seconded that the delegates of the churches not sending the regular minute fee not be seated unless someone guarantees that the fee will be paid before this session is over. Motion carried.

The church letters were called for and received.

Motion made and seconded that the delegates be seated at this time. Motion carried.

A letter was read by the clerk from the Hoffman Free Will Baptist Church requesting membership in this association. Motion made and seconded that this be referred to the executive board. Motion carried.

Rev. J. W. Alford, member of the state mission board, gave a report from the board. Motion made and seconded that we adopt this report as information. Motion carried.

Motion made and seconded that we change the names of our foreign and home mission boards to "mission boards" without reference to home or foreign. Motion carried.

Motion made and seconded that the executive board select a man as promotional director of our mission board and present him before this body at this session. Motion carried. Motion made and seconded that we adjourn this business session until 1:30 p. m. and go into the worship service. Motion carried.

Rev. Ralph Staten brought the morning message using the subject, "A Full Gospel Christian." He brought a wonderful message and God wonderfully blessed His people.

FRIDAY AFTERNOON SESSION

A songspiration was led by Rev. Clyde Cox, followed by him rendering a solo, "The Robe of Calvary."

Rev. Charles Broadway brought an inspirational message on "The Value of Salvation."

The house was declared open for business by the moderator.

Motion was made and seconded that we request each fellowship club to send a \$2.00 minute fee with each report. Motion carried.

Motion made and seconded that the moderator appoint a committee on committees; this committee is to act as nominating committee. Motion carried. The following men were appointed to serve: Rev. Clyde Cox, chairman, Mr. Deese Hunsucker and Rev. W. F. McQuage.

Rev. R. H. Jackson, superintendent of the state orphanage, gave us a report from the orphanage. Motion made and seconded that we accept this report as information. Motion carried.

Motion made and seconded that we take an offering for the orphanage. Motion carried. An offering was taken amounting to \$24.50.

Motion made and seconded that the moderator appoint a committee to meet with other committees of the state at Mt. Allen College for the purpose of establishing the boundary lines of the various associations and conferences of the state. Motion carried. The following men were appointed: Rev. N. B. Perkins, Rev. William Calvert and Rev. W. F. McQuage.

The report of the committee on committees was called for and adopted as follows:

Motion made and seconded to adjourn the business session until Saturday morning. Motion carried.

FRIDAY EVENING WORSHIP SERVICE

Song service was rendered by the host church choir, with special singing by a quartet from the Ben Avenue Church of Kannapolis.

The message was delivered by Rev. N. W. Holt, and his subject was, "What Is Wrong with the Free Will Baptists of the Piedmont Association." The text was read from John 3:14; a timely topic in which Brother Holt stressed our need to lift up Jesus above everything.

SATURDAY MORNING SESSION AUGUST 20, 1955

The Saturday morning session opened with congregational singing led by Rev. Reynolds.

Rev. Robert Ferrell conducted the devotion by reading John 4:4, and leading in prayer.

The house was declared open for business by the moderator after commending us for the fine Christian spirit that has prevailed during the previous sessions.

Motion made and seconded that the association pay the expenses of the committee that is to attend the boundary line committee at Mt. Allen College. Motion carried.

Motion made and seconded that we pay Brother Staten for the printing of the associational programs and give him a rising vote of thanks. Motion carried.

The moderator called for the report of the ordaining council. This report was adopted in its entirety after expunging from the records items agreed upon by the council and this body.

The report of the executive board was called for and adopted under the same conditions as that of the ordaining council.

Moved and seconded that the following announcement be inserted in the minutes: That all matters between Rev. Paul Brown and the Piedmont Association have been satisfactorily settled and Brother Brown is still in good standing with this association and is available for evangelistic and pastoral work. This announcement is to appear in the state and national paper. Motion carried.

Motion made and seconded that all committees, except the committee on committees, be changed to standing boards. Motion carried.

Motion made and seconded that the Hopewell Church be dropped from our roll at their request. Motion carried.

The following sisters were elected by acclamation as delegates to our State Convention: Mrs. Roy Rikard and Mrs. L. H. Clayton.

The woman's auxiliary report was called for and given. Motion made and seconded to adopt this report. Motion carried.

The treasurer's report was read and adopted.

The nomination committee's report was called for and adopted after calling for nominations from the floor.

Motion made and seconded that we change the date for the meeting of our association to Friday and Saturday before the first Sunday in August. Motion carried.

Motion made and seconded that midnight Thursday before the association convenes be the deadline for the closing out of the books of the ordaining council and the executive board. Motion carried. Goshen Church of North Belmont, was selected as the place of the next meeting.

The ordaining council was given charge of the meeting at this time for the purpose of ordaining and licensing ministers. The following men were ordained: Rev. H. C. Faulkner and Rev. George Bullard. The council licensed Rev. R. J. Lambert and exchanged ordination papers with Rev. W. M. Morton; Mr. Morton coming to us from the Yadkin Valley Association.

Motion made and seconded to adjourn. Motion carried.

Piedmont Ministers' Conference August 18, 1955

The Ministers' Conference of the Piedmont Association of the Original Free Will Baptists of North Carolina met in annual session at the Wayside Free Will Baptist Church of Charlotte, North Carolina, August 18, 1955, at 10 a. m.

The meeting was opened by the congregation singing "Revive Us Again" led by Rev. W. T. Allen. Rev. Ralph Staten led in prayer.

The house was declared open for business by Rev. Sherman Branch, the moderator, after a reminder to keep all business in order, prevailing in a spirit of love.

Nominations for a clerk to serve for the forthcoming year was called for and Rev. W. T. Allen was nominated and elected by acclamation.

Motion made and seconded that this conference have a program committee to select the places for the meetings of this conference and to plan a program for each meeting. The moderator and the clerk to be on this committee and that the moderator appoint three additional men. Motion carried.

The following men were appointed: Rev. William Calvert, Rev. Walter Carter and Rev. L. H. Clayton.

The election of officers for the forthcoming year was called for at this time.

The following officers were elected: Rev. John R. Newton, moderator and Rev. Billy Yawn, vice-moderator.

Motion made and seconded to adjourn for five minutes. Motion carried.

The conference met for the morning worship service with Rev. Norman Perkins bringing the message.

EDUCATIONAL BOARD

That the Piedmont Association sponsor a monthly publication to give publicity as to its activities and goals. The promotional secretary make this one of his duties with the executive board setting up a plan of finance.

That this association sponsor a youth encampment within the bounds of the association, the time, place, officials and teaching staff to be set up by an encampment committee appointed by the moderator.

That the churches subscribe to the denominational publications as "Contact" and "The Free Will Baptist."

REPORT OF THE EXECUTIVE BOARD JULY 31, 1954

Motion made and seconded that a committee be appointed to draft recommendations for dealing with representation to our national convention. Motion carried.

Motion made and seconded that the state of North Carolina protest the action of the national convention. Motion carried. Piedmont voted against it.

Motion made and seconded by the committee appointed that our complaints be taken to the national convention in 1955 through a proposal drawn out by the state convention this September. Motion carried.

AUGUST 17, 1954

The executive board met at the home of Rev. Clyde Cox in Concord, North Carolina.

Motion made and seconded to select an evangelist to fill the office of promotional director. Motion carried. Rev. Williams of the Cramerton Church, and Rev. Allen of Gastonia First Church were nominated.

Motion made and seconded to interview these brethren at the Cramerton Church on fifth Saturday night at the fellowship meeting. Motion carried.

Rev. John R. Newton was nominated and elected by acclamation to fill the vacancy on the home mission board created by the death of Rev. W. H. Calvert.

AUGUST 27, 1954

The executive board met at the home of Rev. Roy Rikard in Cramerton, North Carolina.

Rev. Allen and Rev. Williams were interviewed in regards to the work as promotional director. Motion made and seconded to postpone the action on said matter until next meeting. Motion carried.

Motion made and seconded to grant Rev. Noah Brown a letter from the Piedmont Association. Motion carried.

Motion made and seconded to inform Rev. Ballew of Lexington, North Carolina,

that it will be impossible for the board to meet with him until after September 20, 1954; also for him to select date and place to meet after this date. Motion carried.

Motion made and seconded that each church be asked to make a special donation for promotional work. Motion carried.

SEPTEMBER 19, 1954

The executive board met at Goshen Church, North Belmont, North Carolina. This was a joint meeting with the ordaining council.

The ordaining council made a report to the effect that the Wayside Church of Rockingham was being disbanded and that an investigation should be made as to the disposal of said property.

Motion made and seconded that a committee of the executive board be appointed to investigate said matter. The following brethren were appointed: Rev. Rikard, Rev. Holt and Rev. Reynolds. They are to meet in Rockingham, at 12 o'clock noon, September 20, 1954.

Motion made and seconded that this board meet with the Calvary Free Will Baptist Church in Concord, October 2, 1954, in regards to receiving the church into the association. Motion carried.

Moved and seconded that Rev. Willie Williams be appointed as promotional director until next associational meeting. Motion carried.

Motion made and seconded that each church be asked to send an offering each month for promotional work consisting of 10 cent per member for churches with less than 100 members, 15 cent per member for churches with 100 to 200 members, and 20 cent per member for all over 200 members. Motion carried.

OCTOBER, 1954

The executive board met with the Calvary Free Will Baptist Church, Concord, North Carolina, and received the church into the association.

The board met with the Westside Church in Charlotte, North Carolina, as the church had petitioned for membership into the association. The Articles of Faith were read by Rev. Reynolds, the church covenant by Rev. Reynolds and the charge was given by Rev. Staten. By vote the church was received into the association.

JANUARY 28, 1955

The executive board met at The First Church in Gastonia, North Carolina.

Rev. John R. Newton was appointed to the ordaining council to replace Rev. L. D. Gray.

APRIL 30, 1955

The executive board met at Aleo Church, Rockingham, North Carolina, on April 30.

Motion made and seconded that the expenses incurred by Rev. Clayton in his meeting with other state board representatives for the purpose of drawing up a proposal to our state convention in regards to rules governing the preachers of the state be paid. Motion carried.

Moved and seconded that a representative of the Hopewell Free Will Baptist Church, Rockingham, meet with the board at the Mt. Beulah Church in Rockingham, on May 20, 1955, in regards to obtaining a letter from this association.

AUGUST 18, 1955
