#### RULES OF DECORUM

1. The clerk, assistant clerk, or senior minister in years may call the meeting to order and shall have charge until the moderator assumes his place.

2. This association shall be opened and closed with suitable devotions providing a quorum of nine members are present.

3. This body shall decide all questions by majority of the members present.

4. There shall be no conversation by members, one with another, so as to interrupt business while in session.

5. Every person wishing to speak, shall first rise and ad-

6. No person shall interrupt another while he is speaking.

6. No person shall interrup another while he is speaking.

7. All motions made and seconded shall be open for discussion, but debate may be shut off any time by a majority of the members present.

8. No one shall speak more than twice on the same subject, without special leave from the body, and personal reflections shall be avoided.

9. No member shall be allowed to speak more than ten minutes on the same subject, unless body gives permission.10. No member shall absent himself from the body without

10. No member shall absent himself from the body without the permission of the moderator.

11. If any proposition or motion under debate contains two or more points it shall be divided at the request of any member and the vote taken separately.

12. Motions made and lost shall not be recorded in the minutes unless so ordered at the time.

13. The moderator shall have the same privilege to speak as any other member, provided the chair is filled.

14. By a two-thirds vote any decision of the moderator may be overruled.

15. Visiting brethren shall be entitled to a seat to discuss subjects, but not to vote.

16. No motion shall be discussed without a second.

17. Unlawful absence from body denies a party voting privileges.

18. Members breaking any of these rules, moderator admonishes.

19. Alterations may be made in these rules at any regular meeting of the association.

#### THE CONSTITUTION

Article 1. This association shall be called the Piedmont Association of (original) Free Will Baptist.

Article 2. This association shall be composed of delegates elected annually by the Free Will Baptist Church cooperating with this association, all active ordained deacons of said churches and all ministers who are members of this association.

Article 3. The officers of this association shall be a moderator, vice-moderator, recording clerk, reading clerk, treasurer and promotional secretary.

Article 4. Each church shall be entitled to three delegates, and one additional delegate for every fifty members over one hundred.

Article 5. The churches cooperating with this association send by the hands of their delegates, a full account of all work done by them during the year and all statistics and information as will be interesting and helpful.

Article 6. No person shall interupt another while he is speaking.

Article 7. The executive board shall consist of three members elected by the association, one for one year, one for two years, and one for three years. The associational officers are members exofficio of the executive board. The executive board shall have interim authority.

#### RULES AND REGULATIONS OF THE PIEDMONT ASSOCIATION

1. Associational officers are to be elected by the ballot system.

2. The clerk is to be elected at the beginning of the session. (both.)

3. The moderator, vice-moderator, treasurer, promotional secretary are to be elected at the close of the session.

4. Ordaining council is to be elected by the association, the number of this council is to be six members elected in two year terms rotating; two for two years; two for three year terms; and two for one year term. The council shall elect their own chairman and secretary and shall have authority to ordain, investigate ministers, subject to the approval of the association in regular session or special session. They shall keep a record of their work and their secretary shall send a record of that to the clerk of the association not later than one week before the annual association convenes. The expense of the council is to be paid from a fund of \$125.00 set aside by the association for this purpose, and each church who calls council is requested to receive a free will offering and send same to the treasurer of the association for this purpose. The council shall receive from the treasurer expenses of six (6) cents per mile, per car, plus meals.

5. The executive board shall have charge of the promotional work, and educational work of the association and shall have the authority to act for the association in its business between sessions. The board shall report its work annually to the association and its work is subject to the approval of the association. The expense of the board shall be paid in the same manner as the ordaining council.

6. The Piedmont Association is affiliated with the N. C. Association of Free Will Baptist and the National Association of Free Will Baptist. The treaties of the faith and practices of the National Association is to be used.

7. The Piedmont Association believes and practices "CON-GREGATIONAL' church government and assumes no higher authority than in that capacity. The highest authority that the association has over the churches within her fellowship is the power to withdraw fellowship from a church.

8. The association approves and urges our churches to support our denominational programs of our State and National Association.

9. The association approves and urges the indefinite pastoral call.

10. The chairman of each board and committee is treasurer of its funds (exceptions: associational treasurer is treasurer of the executive board.)

11. A member in good standing in the association may serve on as many boards and committees as he or she is elected (exceptions: no member may serve on the executive board and the ordaining council at the same time.)

12. Each church shall send thirty (30) cents per member with

their report to the annual association or have someone to stand good for this amount in order that their delegates may be seated. This money is to be used for the printing of the minutes and associational expense.

13. A nominating committee will be appointed at the beginning of each annual session of the Piedmont Association. Their duty will be to present nominations for all officers, boards and committees necessary to carry on the work of the association. The body shall have the right to nominate from the floor, when this committee gives its report.

14. Each church shall record the following information on church letters (in addition to required information.) The names and the addresses of every minister belonging to their church, and whether or not, each minister is a constant tither. The clerk of the association is to take special note of this information and to include the same in the minutes. The clerk shall make a list of the non-tithers and report the same to the ordaining council.

Motion and second to accept Rev. Paul Browns resignation from the executive board. (carried.)

The following men were elected for the finance committee: Rev. Frank Spargo, Rev. Claude Bean, Jr., Rev. Charles Maness, and Mr. Bill Jacobs.

Motion and second that all boards be changed to committees and that they be elected at the beginning of each session. (carried.

The business session was suspended until after the morning message.

The Rev. Clarence Ballew, pastor of Mt. Pleasant Free Will Baptist Church of Lexington, North Carolina, brought the morning message. The message was enjoyed by everyone. His subject was "Christians and the World."

Motion and second that the moderator appoint one man for each of the following committees: Resolutions – Rev. Herman Griffin, Christian Education – Rev. James R. Adams, Missions – Rev. Jimmy Skipper, Sunday School – Rev. Albert Bell, C. T. S.– Rev. J. W. Wooten, Master's Men – Rev. Robert Hagler. Anyone having suggestions concerning these committee may meet with these men. (carried.)

Motion and second to adjourn for lunch. (carried.)

THURSDAY EVENING - AUGUST 3, 1967

The ordaining council and all committees met this afternoon. THURSDAY NIGHT – AUGUST 3, 1967

The ordaining council had charge of the worship service this afternoon. These four men received their licenses to preach: Rev. Archie Furr, Rev. Danny Gerald, Rev. William Jacobs, and Rev. Vernon Jacobs.

FRIDAY MORNING - AUGUST 4, 1967

Rev. J. W .Wooten was elected assistant clerk.

The roll call of the churches and pastors that had not reported was made at this time.

Rev. Galen Dunbar, Moderator of our State Association gave us a report of our State work.

Rev. Gene Parrish, chairman of the State Misisons Board gave us a report concerning State Misisons.

Rev. J. R. Adams gave the report of Christian Education. Motion and second that the report be received and put in the minutes. (carried.
