### Proceedings

The Scioto Ministerial Conference of Free Will Baptists in Ohio, convened in its regular annual session at the Porter Church, September 5-6, 1946, which had extended to us the invitation for a visit at the local church at 10:00 a. m.

The Conference was called to order by the Clerk, and asked who the choice for Moderator would be, and Rev. Walter Doll, Pastor of the Porter Church was elected.

Devotional services were conducted by the Moderator.

Reading of the Scripture was the 48th Psalm.

There were 13 ministers present.

Prayer was around the altar, led by Rev. J. A. Kemper.

Assistant officers were selected as follows: Rev. Clarence Herles, Assistant Moderator; Rev. W. J. White, Assistant Clerk.

Reading of the Constitution and By-Laws was the next order of business.

Moved and sustained that we adjourn the business until 1:00 P. M.

The rest of the time was spent on the discussion of subjects which were assigned at the previous session.

1st Topic: Titled, The Plan; John 3:5, by Rev. Selven Percell. He was absent, so Rev. Kemper started the discussion, appointed by the Moderator. This verse of Scripture was freely discussed by all, and all of us had a clearer conception of this text of Scripture.

Dismissed to reconvene at 1:00 P. M.

The dinner was served in the basement of the church, by the good women of Porter Church and all the ministers enjoyed themselves.

1:00 P. M. the Conference re-assembled, with the Assistant Moderator in charge. Prayer led by Rev. E. T. Carter, Scripture reading Titus 2:1-10.

Both of these topics were discussed freely, and the differences of opinion was so trifle, that you could hardly notice it.

These various topics are very helpful, and it brings the ministers closer together in their interpretation of the Scriptures.

During the course of the conference, three new members were added: Rev. Forrest Chamberlain of Union Church, Rev. Floyd Estep of Dailyville Church, Rev. Elmer Miller of Union Church. These three men are all young men, and have a promising future, in their ministry.

Reading of to-day's minutes were read and approved.

Rev. Forest Chamberlin was appointed by the Moderator to lead the devotions for the evening service.

#### THE CONSTITUTION OF THE MINISTERIAL CONFERENCE OF THE FREE WILL BAPTISTS and the ALT STATES

Article 1.—This Conference shall be known as the Scioto Ministerial

Conference of Free Will Baptists and shall consist of all Ordained Ministers belonging to this Compact.

Article 2.—The object of this Conference shall be for the mutual benefit of its members and for the advancement of the cause of Christ among their people.

Article 3.—The officers of this Conference shall be a Moderator who is elected annually, a Clerk and a Treasurer who are standing officers.

Article 4.—This Constitution may be altered or amended by a vote of 2-3 majority of the Scioto Ministerial Conference of F. W. B. at any session, notice of such intended alteration, having been given in writing at the previous session.

#### BY-LAWS OF THE SCIOTO MINISTERIAL CONFERENCE OF FREE WILL BAPTISTS

Article 1.—All members shall report in person or by letter at each annual session.

Article 2.—All members reporting by letter must give a cause for not being present in person.

Article 3.—Any member failing to comply with Article 1, Article 2, and fails to receive a card of good standing shall be deemed in not good standing with the denomination and can not pastor any church in the Scioto Yearly Conference of Free Will Baptists and no minister be allowed to serve a church regularly by appointment that has no card from the Ministerial Conference.

Article 4.—No member shall be given a card of good standing until he has given proof of his efficiency and of doctrine and of character.

Article 5.—It shall be the duty of every member of this conference to live up to the doctrine and practice of the denomination as prescribed in the treatise of same and to require the same of their respective charges.

Article 6.—The meeting of this Conference shall be held annually in connection with the scioto Yearly Conference and shall begin on Thursday before the first Saturday in September at 10:00 A. M:

Article 7.—Any Pastor permitting any heretical doctrine to be preached in the church which he has charge may be dealt with by a grievance committee of his peers. Article 8.—There shall be an introductory sermon preached on Thurs-

day at 8 P. M. The subject pertaining to the ministry and the appointment to be made by the committee for the next session.

#### YEARLY MEETING CONSTITUTION

Article 1.—This Yearly Meeting shall be called The Scioto Free Will Baptist Yearly Meeting and shall be composed of such regularly organized and well disciplined Free Will Baptist Quarterly Meetings located, as may embody themselves under this constitution.

Article 2.—The Conference of this Yearly Meeting shall consist of delegates from the several Quarterly Meetings of which it is composed, every Quarterly Meeting being entitled to one delegate to each church of the Quarterly Meeting of which it is composed.

Article 3.—The Officers of this Yearly Meeting shall be a standing Clerk and Treasurer; and a Moderator shall be chosen at every session of the Yearly Meeting with such assistance as may be found necessary.

Article 4.—Any well organized and well regulated Free Will Baptist Quarterly Meeting composed of such churches as conform to the usages and adopt the doctrine of the Free Will Baptist Denomination, as published in the Minutes of the General Conference, and are in favor of all the benevolent enterprises of the denomination, may at any time on application by vote of this Yearly Meeting become a member thereof.

Article 5.—This Yearly Meeting shall have power to discipline the Quarterly Meetings of which it is composed, and to exclude them for disorderly walk if labor prove unsuccessful; but in no case to reverse their decision nor interfere with any of their internal regulations.

Article 6.—The session of this Yearly Meeting shall be held on the First Saturday in September of each year at which time it shall be the duty of the Quarterly Meetings of which the Yearly Meeting is composed, to represent themselves by delegate and report their standing, prospects and statistics by letter, at which time the Yearly Meeting shall act on such topics as may be referred to them by their respective Quarterly Meetings and transact such other business not repugnant to this constitution nor to the usages of the Denomination, as in their judgment may promote the cause of Christ and the interests of the churches and Quarterly Meetings within the limits of the Yearly Meeting.

Article 7.—This Yearly Meeting shall have power to adopt any regulations by laws not inconsistent with this Constitution, which be deemed essential to the further regulation of its session.

Article 8.—This Constitution may be altered or amended by a vote of the Yearly Meeting at any session, notice of such intended alteration having been given in writing and recorded at the next previous session.

#### **BY-LAWS**

I. We recognize no other treatise than of 1847.

II. That an offering be taken at each annual session for the benefit of the conference.

III. That we allow no one to have any official business who is not a member of the Free Will Baptist Organization.

IV. There shall be an introductory sermon preached on Saturday morning to be selected by the Pulpit Committee.

V. No Minister in this Yearly Meeting be allowed to Pastor any Church in this Yearly Meeting unless he has a card of good standing from the Scioto Ministerial Conference of the Free Will Baptists.

VI. That the Churches of this Yearly Meeting require their Pastors to present a card of good standing signed and dated by the Moderator and Clerk of this Yearly Meeting of Free Will Baptists.

VII. The Members of this Conference shall be all ordained Authority of the Scioto Yearly Conference, of Free Will Baptists.

The following rule was adopted September 7, 1946, at Porter Church:

I. That all Ministers belonging to the three Quarterly Conferences, which comprises this Yearly Conference to affiliate themselves with the Scioto Ministerial Conference, and if they fail to do so after reasonable warning, to demand and confiscate their Credentials, as Ministers of the Free Will Baptist Denomination.

I. This Yearly Conference has adopted all the work of the Ministerial Conference, and will cooperate with the Ministerial Conference into putting them in force.
