Our Ohio State Meeting is scheduled to be held on Friday and Saturday, June 26-27, 2009 at the Gahanna FWB Church. As you all know each conference is to send a report letter for the year 2008 along with fees of \$125.00 per church in order to seat your delegates at the state meeting. Also, if you have a nominee for your conference's General Board slot, you should include it on your letter. In order to give us time to prepare the State Letter, we would ask you to send your letter and fees the Ohio State Office by June 15th.

In addition, with your letter, we do need the names and all ordained ministers and ordained deacons with your letters. (These are all standing delegates for the Ohio State Meeting).

The fees will go up to \$150.00 per church starting in 2010.

If your conference has any additions for the Obituary Committee, it would be good to send their name, what church they were a member and possibly a picture.

We are responsible for hosting the National Association of Free Will Baptists July 19-23 in Cincinnati. Part of our responsibility is to pay the arena cost of \$30,000. Would you mind checking to see if your conference churches have paid their \$200.00? If you have some who cannot pay the \$200.00, maybe your conference or some of the churches in the conference can help?

Also, we are going to need some of our people to help greet delegates to the National, participate in projects on the Saturday before the National and for ushers during the services at the National in July. Could you mention this to your conference?

We do appreciate the role you have in recording and corresponding with the Ohio State Association. You are a vital link in our denomination. Thank you so much! Let's be praying together for a blessed Ohio State Meeting in June!

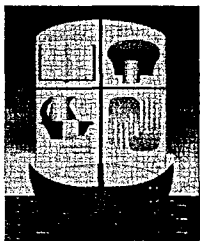
