## HISTORICAL.

The St. Annah Free Will Baptist Conference is an off-shoot of the Mount Moriah Conference. It was organized in the year 1898. And since then it has convened with the churches. This same said conference was organized in the Old St. Annah church, and since that time it has had many conferences and unions. Satan has tried to inject poisonous doctrines in the ranks, but he has ever and anon met with defeat.

The Conference still stands upon its original doctrines of justification by faith, sanctification, baptism of the Holy Spirit, divine healing, and the second coming of Jesus. Through its work the Gospel has been preached in many places, and many have received the experiences named. They are a band of happy saints, dead to the world and rejoicing in the Lord.

#### PROCEEDINGS.

First Topic. We, the full body of the St. Annah Free Will Baptist have met at Macedonia Church in Hoke County, N. C., to hold another annual session on the 17, 18, 19th of November, 1927.

Eighth Topic. By motion all the preachers will be excused from last union that were not present.

By motion we elect Bro. W. F. Oxendine for clerk.

By motion we receive the calling of all the work and enrolling business that's tabled above in full.

Ninth Topic. By motion the moderator be empowered to appoint all the committees by names. They were appointed as follows:

Devotional.—Bros. William Locklear, Collen Brooks, Jim Calder.

Temperance.-Elders H. B. Bulard, M. B. Emanuel, H. B. Tadlock.

Literature.—Elder J. A. Maynor, Rev. W. A. Chavis, Elder Jim Johnson.

These committees were all accepted in this conference to work and they did so.

Tenth Topic. By motion the devotional committee go out and bring in their report. By motion we have the reports of the committees.

The devotional committee reports that Bro. H. K. Calder will close for dinner at 12:30, and Bro. H. H. Pearce will open up at 1:30 P. M.

Eleventh Topic. By motion we receive the new church, Union Tabernacle, about six miles west of Lumberton, N. C.
