MINISTERS' MEETING.

Ministers from the various Conferences met with the Church at Woods Grove, Wayne County, December 13th, 1910.

Eld. R. F. Pittman preached the Introductory sermon—text, Isa. 52:1 "Awake, awake, put on thy strength, O Zion."

The meeting was organized by electing R. F. Pittman president and E. T. Phillips secretary.

The following ministers were enrolled:

Wilmington—E. L. Parker.

By motion, T. E. Peden of the Ohio River Yearly Meeting was invited to a seat with us in the meeting.

The following were appointed a devotional committee for the meeting: J. A. Thomas, Elijah Vinson and L. G. Taylor.

The following were appointed a query committee: Elds. T. E. Peden, P. T. Lucas and E. L. Parker.

The list of those enrolled was called and their Christian conduct inquired into.

By motion, we invite the delegates who are present to take a part in the Ministers' Meeting.

Devotional committee reports that E. L. Parker open tonight and P. T. Lucas preach at 7 o'clock.

The meeting adjourned to meet the next day at 9:30 cocks. Prayer by E. L. Parker.

Wednesday Morning.

The meeting opened with a prayer service conducted by Loyd Vernon.

Devotional committee reports that R. F. Pittman open and E. T. Phillips preach to-day.

The Query committee reported questions as follows:

1. What is our duty to the criminal classes, especially the convicted criminals? Discussed by Prof. T. E. Peden P. T. Lucas, E. T. Phillips, J. F. Hill and E. L. Parker. It was decided that we should do all that we possibly can to break the bread of life to criminals of every description, both high and low, and induce them if possible to accept Christ.

There was a recess for one hour for dinner.

- Query 2. How can we stop the tendency to Episcopacy and other forms of monarchical church government? Discussed by Peden, Phillips, Hill and others. It was decided that we should adhere to the congregational form of church government.

Query 3. How can we establish Free Will Baptist churches in the cities? Discussed by Parker, Peden, Lucas, Phillips, Hill and others. It was decided that the best thing we could do was to establish churches in all towns possible. Have a minister to serve them and that they be sustained.

Devotional committee reports that Loyd Vernon open and E. L. Parker preach and close to-night. The meeting closed until 9:30 a. m. on Thursday. Prayer by T. E. Peden, D. D.

Thursday Morning.

Meeting opened at the appointed time. Prayer by E. B. Hart.

Query 4. Why ought we attend the Ministers' Meeting and the Union Conference? Discussed by Parker, Lucas Edmondson, Hart and others. It was decided that we ought to attend the meeting that we might know more of each other, and learn more of the doctrine and how to manage our church affairs more successfully.

By motion an Executive committee of three was appointed to get up a program for the next Ministers' Meeting and

distribute the same among the ministers and churches in due time. E. T. Phillips, T. E. Peden and E. L. Parker were appointed said committee.

Query 5. What are the chief characteristics of a good pastor? Discussed by Lucas, Peden, Parker and others. It was decided that some of his traits should be as follows: He should be prompt, have no pets, should be truly converted and of great piety, industry, deep sympathy, free from all bad habits and customs. He should be very systematic in his work and mingle in the homes of his congregation. He should be deeply interested in the mission work and in Gospel work everywhere.

On motion, Ehl. P. T. Lucas preach the Introductory sermon at the next Ministers' Meeting and G. C. Vause be his alternate. The meeting closed with prayer by E. L. Parker

CONSTITUTION OF THE MINISTERS MEETING.

ARTICLE 1. A Minsters' Meeting of the Original Free Will Baptist of North Carolina shall meet at least once every year, Tuesday before the meeting of the Union Conference and hold until the opening of the same, at the appointed place for the Union Conference.

Arr. 2. An introductory sermon shall be preached at the sitting of the ministers' meeting each year.

ART. 3. The minister who preaches the intorductory shall preside over the meeting until a president is elected.

ART. 4. Each meeting shall have power to elect such officers as may be needful.

ART. 5. The meeting shall be to devise for plans for the advancement of the Gospel of Christ.

ART. 6. It shall be the duty of the meeting to keep unity between the brother ministers and to understand each other's work, so that our preaching will not conflict in preaching the Gospel.

ART. 7. All ministers of our faith in good standing in their respective conferences or association throughout the state are considered members of this meeting.

ART. 8. All members composing said meeting shall be required to attend annually, unless providentially hindered.

Art. 9. The meeting shall have power to exclude any member of said meeting for any disorderly walk.

ART. 10. This meeting shall have power to make or amend any rule or by-law they may think necessary in carrying out its benevolent purposes.

ART. 11. All members composing this meeting shall be required to vote pro or con, unless excused by the President.

Arr. 12. The President shall have supreme power to call any person to a point of order during the sitting of the meeting.

ART, 13. No person shall speak over ten minutes on the same subject without the consent of the President, and shall be allowed to speak twice if necessary.

Arr. 14. The proceedings of the Ministers' Meeting shall be published in connection with the minutes of the union conference.

A letter was read from Sister L. M. Peden, giving an account of the Triennial Conference held at Florence, Ala., and same was ordered printed.

By motion, we return thanks to Sister Peden for representing our state in the General Conference and that we ask each conference and association in the state to pay Sister Peden its *pro rata* part of her expenses in attending the Conference.

The devotional committee report that R. E. Edmonson preach and T. E. Peden follow with a lecture on the denomination.

The letters from the different churches were read (See table of Statistics).

By motion, an Executive committee be appointed to select time and place of the next Union Meeting. The committee to be E. T. Phillips, C. A. Thomas and R. A. Boyette.

By motion, Eld. E. L. Parker represent the Wilmington Conference and send donation as he may see proper.

By motion, the Clerk correspond with the various associations that have not represented in the meeting and induce them to do so if possible.

By motion, Conference close until to-morrow 9 a. m. Prayer by J. H. Worley.

Friday Morning.

Met as per adjournment. Prayer by J. A. Smith. Minutes of the previous day read and approved.

Committees Reports.

The following reports were read, discussed and adopted:
Sunday Schools—We find the report of the Sunday
School committee in some way out of our hands. We do
not know how this occurred, but the committee urged the
necessity of the Sunday School work being pushed urgently
in each and every church and the great importance of using
our own literature.—Clerk.

EDUCATION-Like the Sunday School report, we find the

report of the committee on education out of place. We regret this very much as the paper was a strong one in favor. of education. The committee favored an educated ministry as much as possible. Our Ayden school was highly recommended for our care and encouragement, and general education highly endorsed for all our people everywhere. The endowment of our Ayden institution should be fully accomplished and our people should patronize the school when it is reasonable to do so.-Clerk.

Temperance—(1) We regard the enactment of the prohibition law as the highest legislative achievement of the present century. We believe it to be the duty of every citizen to see as far as in him lies, that the law is strictly and fully enforced.

(2) Total abstinence from all that intoxicates should be taught from the pulpit, in our schools, in our homes, in our business, in our social circles and in every department of human effort.

Ayden, N. C., December 2, 1910.

To the Elders and Brethren of the North Carolina Union Conference: I attended the General Conference of the Free Will Baptist Denomination, at Florence, Alabama, October 5 to 15, 1910. I was kindly requested to represent the Union, N. C. Conference and all of its constituent bodies, which I did to the best of my ability. This, I hope, is satisfactory to your body, as there was no elected delegatepresent from N. C. and I, the only member of a church in the State. Eld. Jefferson D. Stephens of Marianna, Florida, was chosen Moderator and the business was transacted rapidly and with great unanimity. The work of our schools and benevolent societies was enthusiastically endorsed and recommended. Six new conferences were received, and general prosperity was indicated in the letters' from all parts of the Denomination. Home Mission work was continued through National Evangelist and such other ministers, as means will allow the Board to put into the field. My expenses were thirty-six dollars (\$36.00). ZETTER FROM OHIO RIVER YEARLY MEETING Zaleski, Ohio, August 15, 1910.

The Ohio Free Will Baptist State Convention, auxiliary to the Free Will Baptist General Conference, to the North Carolina Union Conference, greeting: The last year has been one of ordinary prosperity. CONSTITUTION OF THE UNION CONFERENCE.

ARTICLE 1. This body shall be known as the Original Free Will Baptist General Conference.

ART. 2. The object of this conference shall be to promote Christ's kingdom among men by means in strict conforming to the Holy Scriptures, in our co-operation together in having the doctrine of Christ preached for the salvation of souls.

ART. 3. The officers of this body shall be a moderator, treasurer, corresponding and recording secretary, who shall be elected for a term of two years, who shall hold their office until their successors are elected, which election shall take place one year previous to their entering upon the duties of their office.

ART. 4. This conference shall be composed of the ministers of the several conferences or associations of the Original Free Will Baptist of North Carolina and of delegates from the different conferences, associations or churches Every 300 members or fraction thereof being entitled to one delegate.

ART. 5. The delegate from each church shall bear to the conference a letter certifying his appointment, showing the amount of contribution raised for benevolent purposes during the year, and total number of members and nothing more.

ART. 6. This conference may, at each regular meeting, elect as many boards or standing committees as may be necessary in carrying out its benevolent purposes. These shall keep a record of their proceedings and make a report at each regular meeting of this conference.

ART. 7. The moderator may extend to visiting brethren all the privileges of the body save that of voting.

ART. 8. Each conference is a distinct and independent organization with full authority to manage its own internal affairs, elect its own officers.

ART. 9. This constitution may be amended at any regular session by a vote of two-thirds of the members present.
