PROCEEDINGS

The Thirty-Fourth Annual Session of the Western Conference of the Original Free Will Baptist of North Carolina, convened with the church at Marsh Swamp, Wilson County, Thursday, October 14, 1920.

Elder R. F. Pittman who was appointed to preach the introductory sermon attended and preached. Text: Numbers 13:30. "And Caleb stilled the people before Moses and said, Let us go up at once, and possess it; for we are well able to overcome it."

THURSDAY EVENING.

Conference assembled at 2 P. M. Prayer by Elder J. K. Ruffin. The Moderator, Elder W. M. Howell was in the chair. Elder E. T. Phillips, clerk was also present as was E. C. Morris, reading clerk.

Conference being organized praise was offered by R. F. Pittman and prayer by E. Poston.

On motion, the moderator be empowered to invite all visiting brethren present to seats in the body or any who may come at his discretion.

The following were enrolled from the different bodies:

Very encouraging remarks were made by E. Poston, A. T. Dawson, M. C. Prescott, and S. H. Styron.

On motion E. Poston be received as a member of this conference.

The list of ministers was called and their Christian conduct inquired into.

Elders B. B. Deans, J. K. Ruffin, and J. J. Wilson were appointed to write an obituary of Eld. S. D. Scalf, deceased, to appear in the minutes.

Devotional committee report that G. C. Joyner open and M. C. Prescott preach tonight.

On motion the name of W. G. Boykin be entered upon the list of ordained ministers. On motion the name of R. N. Hinnant, of Micro, be placed on the list of licensed ministers.

On motion, the name of Curtis Howell be placed on the list of retired ministers.

On motion, conference call off till Friday morning 9 A. M. Benediction by E. T. Phillips.

FRIDAY MORNING.

Conference met as per adjournment. Prayer by D. U. Oliver. Minutes of yesterday read, corrected and approved.

Mission Report.

Elder L. T. Phillips, evangelist of the conference reports that some work has been done on the house at Plain View, Franklin county, and that the work is progressing fairly well there. He reports that he has also held regular services at Fremont Chapel, and is now preaching there. Also that the church there has remunerated him. In fact, he makes no charge for his work at either place.

On motion, we accept the report of evangelist Phillips, and that the conference allow him \$50.00 for his services.

On motion, the apportionment committee turn over the funds for missions to the Mission Board and that they pay the evangelist the \$50.00 as voted by the conference.

A letter was read from sister Mitchell about her son Sam, asking that the conference help her to take Sam home with her. A letter was aloo, read from Bro. Mitchell, her husband, who is an old minister in our ranks and who is very feeble at the present time.

Letters were read from Elder E. B. Joyner and others highly commending the work of Elder A. R. Flowers in Florida, where he is located at the present. A letter was also read from Elder Flowers himself, in which he expressed himself as being in full accord with the brotherhood and wishing and praying for the success and harmony of the conference.

Letters were also read from Elders W. A. Benson and J. W. Valentine, each sending greetings and prayers for the good of the brotherhood and regretting not being able to be with us in our deliberations.

On motion, the clerk be advised to write to sister Mitchell informing her that the conference deem it advisable for her son Sam to remain in the asylum.

Devotional committee report that W. E. Anderson open and E. C. Morris preach at 11 o'clock.

On motion, the editor of the Baptist be requested to print a supply of disciplines as revised with the articles of faith to appear as formerly.

On motion we return to the old system of bringing letters to the conference all motions and resolutions conflicting with this resolution being repealed.

On motion each church be requested to send to the conference not less than \$5.00 to be applied to the retired ministers' fund.

Dr. M. Hinnant, J. W. Alford, and A. B. Utley spoke in favor of putt-

ing a man in the field to assist M. C. Prescott, the state evangelist for the proposed college of the Free Will Baptist.

Report of Financial Agent of the Proposed F. W. B. Callege.

The following resolutions were submitted through the Financial Agent:

As Financial Agent of the F. W. B. Seminary (or proposed college), I beg to submit the following outline in waging a campaign for the raising of funds to erect a college at Ayden, N. C.:

1. That we put on a campaign as early as possible for Three Hundred Thousand Dollars for the erection of an Administration Building and two dormitories.

2. That the campaign be opened up in Pitt county first with a view to raise one-third of the amount to be raised for the college.

3. That the remainder be divided between the conferences and associations according to their financial ability to be worked out by counties and individual churches, and that a general campaign be made as early as possible.

4. As Financial Agent, I pledge myself to devote my entire time to the duties of a Financial Agent in attending conventions, conferences, associations and union, preaching every Sunday to one or more churches as far as is possible to do so, and to work during the week in planning and doing local canvassing for raising funds.

5. That I'll appreciate any recommendation or suggestion from any one and I earnestly ask the co-operation of all the ministers that we may succeed, the same to be expressed by standing at this session of the convention. Also I ask the co-operation of all and especially the delegates of this convention, and it is to be expressed by standing.

M. C. PRESCOTT, Financial Agent.

The above report was adopted modified by the two following amendments; which changes the First and Third resolutions offered above.

Resolution by R. F. Pittman. That we put on a campaign for Five Hundred Thousand Dollars (\$500,000.00) and that 75 per cent go for the college, 20 per cent for the Orphanage, and 5 per cent for the Printing Company. (This changes the last resolution above).

Resolution by J. E. Sawyer. That we do not apportion the amounts to the different conferences, associations, etc., but collect as much as possible from each one. (This resolution affects the three resolutions above.)

The above resolutions as amended by the Pittman and Sawyer resolutions were adopted by the State Convention.

On motion we accept the report of the Financial Agent as presented at the State Convention as amended, and also that a man be appointed to assist him in this conference who is to be under his instructions.

On motion E. Poston be elected to assist the Financial Agent in raising funds for the proposed college and that the Executive Board of the Conference fix his salary.

Devotional Committee report that A. A. Wells open and E. Poston preach this evening; L. T. Phillips open and N. B. Wall preach tonight.

Free Will Baptist Paper.

C. K. Dunn, editor of the Free Will Baptist spoke concerning the condition of the paper. He stated that there was at the present time an emergency. That expenses were at this time exceeding the receipts, and that it was highly necessary that immediate steps be taken to relieve the present distressing situation. He advised that the property be made church property.

On motion the conference take such stock in the Printing Company as will put the office in the hands of the denomination.

The motion was amended that this conference appoint one member to confer with one member appointed by each of the other conferences to look after the special needs of the Printing Company.

W. T. Kirby was appointed from this conference to confer with the representatives of the other conferences in regard to the Printing Company.

Free Will Baptist Song Book.

R. F. Pittman as chairman of a committee that was appointed to superintend the getting out of a song book for the denomination reports that arrangements have been devised for the publishing of 4,000 books. In order to do this work the committee has seen fit to ask a loan of \$200 each from 20 individuals. He further states that \$1000 has been taken in the Western Conference from five men, and that there is but-little doubt of receiving the full amount to have the work done from the other conferences in the state. He further stated that the surplus that would be derived from the sale of the 4000 books would be a sinking fund to enable or make possible the publication of the second edition.

On motion the conference adopt the book as proposed by Elder Pittman in his report.

Meeting adjourned informally till Saturday 9 A. M.

SATURDAY MORNING.

Conference met at 9 A. M. as per adjournment. Prayer by B. B. Deans. Minutes of yesterday read and approved.

Report of Educational Committee.

The Educational Committee endorse the work of yesterday in regard to the report of the Financial Agent of the Seminary, appointing E. Poston as his assistant in this conference, etc. W. E. ANDERSON, Ch'm. Devotional Committee report that G. C. Joyner open and B. P. Jones

Report of Sunday School Committee.

We your committee on Sunday School beg leave to submit the resolutions of last conference, which are as follows:

Your committee beg to submit the following: The work of the Sunday School in the bounds of our conference in most places is doing a very commendable work. Many precious souls have been saved this yea: through the work of the Sunday Schools. Yet we regret to say that there are a few churches in the bounds of our conference that are not having any Sunday Schools at all, such a report brings us to a state of sadness.

Since the work of the Sunday School has proven to be of so much value in the teaching of the people God's Word, and in bringing them to a knowledge of their duty to their Lord and their fellow man. We therefore submit the following:

First. That the pastors be urged to more greatly impress upon their received the great need of Sunday Schools in all their churches, also the duty of the individual members in regard to the work of the Sunday school.

Second. That this conference select a local board, consisting of five whose duty it shall be to encourage the work of the Sunday school, and to gather all the information possible, and to make a report from time to time as may be necessary, and to make an annual report at each conference meeting. They are to meet together as often as possible to devise plans and ways to greatly advance the work of the Sunday school, and to raise funds sufficient to meet the demands of this great work.

The term of this board shall last for one year, and close at the end of the meeting of the next annual conference.

Third. That the pastors be asked to try to get every church to pledge a definite amount each month to meet the increasing demands of our Sunday schools in our state and conference, which amount shall go into the bands of the Conference Sunday School Board, to be distributed as they may deem best. The same to be used only in Sunday School work.

Fourth. That this conference go on record as endorsing the work of the State Free Will Baptist Sunday School Board in their efforts to do general Sunday School work throughout the state and in their efforts to put out a Field Secretary.

Fifth. That we ask our churches and Sunday Schools to raise a definite amount during the year for state Sunday School work, to the amount of 10 cents per capita, and that said money be sent direct to the chairman of the Sunday School Board, E. C. Morris, Ayden, N. C. Thus more rapidly hastening the kingdom of our Lord and Savior Jesus Christ on earth and in bringing lost souls to a throne of grace.

We your committee on Missions beg to make the following report: We feel that the cause of missions is being greatly neglected in the Western Conference, and we realize that our success depends largely upon the mission work. We recommend that we keep up our mission work that we are now carrying on. BY THE COMMITTEE.

ference comply with a request of Sister Georgia Cayton that a committee of ladies be appointed to comply with the mandates of the mission report of last year. An Executive Committee of ladies was appointed in accordance to Article 8, on page 8, of last year's minute, pertaining to the organization of societies. The following ladies were appointed for the Western Conference as said committee: Mrs. Walter Barnes and Mrs. C. G. Pope.

Report of Examining Board.

We, the Examining Board recommend that the name of E. Poston be entered on the list of ordained ministers.

We recommend that J. E. Jernigan's name be placed on the ordained ministers' list after his ordination, by a presbytery appointed by this conference.

We recommend that Bro. Z. E. Cox's name be placed on the list of licensed ministers.

We recommend that Bro. J. H. Lamm's name be placed on the list of ordained ministers. ^l BY THE EXAMINING BOARD.

The above report was adopted.

Report of Orphanage Board.

We, your Orphanage Board beg leave to report that much work has been done on the building which is now in use but it is not completed.

We recommend that this conference elect a man whose duty it shall be to arrange a campaign in this conference that will keep the needs of the Orphanage before our people to that extent that the Western Conference may properly be informed in regard to their duty in meeting the expense of our Orphanage.

We further recommend that this conference adopt the former plan recommended by the Board of Directors, that Thanksgiving be celebrated annually at the Orphan Home, and that each church hold a Thanksgiving service before Thanksgiving Day and that we celebrate this legal holiday with the orphans at the home near Middlesex.


